- Section 38(1) applications will close from the 4th December 2020 and reopen on 4 January 2021;
- The 30 days commenting period for Section 38(8) applications submitted to SAHRA from the 17th November 2020 will end in 2021. Please do not expect comments on these applications before the 15 December 2020. This is in line with section 3 of the NEMA EIA regulations with regards to Public Commenting Periods closing for the Festive Season i.e. no commenting period may include the days between 15 December and 5 January;
- Section 9 alienation applications submitted to the HOU unit will close on the 4th December 2020 and reopen on 4 January 2021
- The SAHRA offices (Cape Town and Pretoria) will be closed from the 24 December 2020 and will reopen on the 4 January 2021. Please note that staff may take leave before and after those days.
