## 1 INTRODUCTION

Paulputs Wind Energy Facility (RF) (Pty) Ltd ('PWEF'), a wholly owned subsidiary of WKN Windcurrent SA (Pty) Ltd, was granted environmental authorisation for the 300 MW (75 Turbine) Paulputs Wind Energy Facility (WEF) and its associated 132 kV grid connection on 11 December 2019 by the Department of Forestry, Fisheries and Environment (DFFE) (DFFE Reference No. 14/12/16/3/3/2/1120) (Figure 1.1). PWEF are proposing to give permission to Paulputs Wind Energy Facility North (RF) (Pty) Ltd and Paulputs Wind Energy Facility South (Pty) Ltd to **split and amend** the Environmental Authorisation (EA) into three amendment applications for EA.

The summary of each amendment application is defined below:

- Paulputs North Amendment:** Paulputs Wind Energy Facility North (RF) (Pty) Ltd ('Paulputs North') intends to construct and operate a 150MW WEF<sup>1</sup> (Paulputs North WEF) consisting of up to 40 turbines, with a hub height of up to 180m, blade length of up to 110m and a rotor diameter of up to 220m. This authorisation will also include the authorised Paulputs WEF preferred on-site substation and a proposed Battery Energy Storage Facility in the area authorised for temporary laydown. All infrastructure is to be located on the north west of the N14 Highway.
- Paulputs North Grid Connection Amendment:** PWEF give permission to Paulputs Wind Energy Facility North (RF) (Pty) Ltd ('Paulputs North' - The Applicant) to remove the authorised 132 kV Grid Connection (Option C) from its authorisation in favour of ownership by Paulputs Wind Energy Facility North (RF) (Pty) Ltd ('Paulputs North') for use at the Paulputs North WEF site. The approved grid connection will be taken over by Eskom in the future and thus requires its own Environmental Authorisation. This amendment application and report will be referred to as the 'proposed amendment'; and
- Paulputs South Amendment:** Paulputs Wind Energy Facility South ('Paulputs South') intends to construct and operate a 150MW WEF (Paulputs South WEF) consisting of up to 35 turbines, with a hub height of up to 180m, blade length of up to 110m and a rotor diameter of up to 220m.

**The focus of this public participation report is on the Paulputs North WEF 132kV Grid Connection Amendment.**

### 1.1 Paulputs North WEF 132kV Grid Connection Amendment

The proposed amendment application will be submitted to the DFFE (the Competent Authority) and is summarised below:

Arcus Consultancy Services South Africa (Ltd) Pty ('Arcus') has been appointed to act as project manager and to undertake the environmental impact assessment process for Environmental Authorisation under Chapter 4 of the National Environmental Management Act, 1998 (Act 107 of 1998 – NEMA) as amended, for the Proposed Development.

## 2 THE PUBLIC PARTICIPATION PROCESS

The sharing of information forms the basis of a Public Participation Process (PPP), with an aim to encourage the public to have meaningful input into the decision-making process from the project initiation until the final report is submitted to the Department of Forestry, Fisheries and Environment (DFFE) for a decision. The primary aims of the public participation process are:

- To inform Interested and Affected Parties (I&APs) of the proposed development;
- To identify issues, comments and concerns as raised by I&APs;
- To promote transparency and an understanding of the project and its potential consequences;
- To facilitate open dialogue and liaise with all I&APs;
- To assist in identifying potential environmental (biophysical and socio-economic) impacts associated with the proposed development; and
- To ensure that all I&AP issues and comments are accurately recorded, addressed and documented in a Comments & Response Report.

This Public Participation Report has been compiled as Appendix C to the Amendment Report that has been prepared in support of the above application for Environmental Authorisation. This report has been updated to include all comments received up until submission of the application. This Public Participation Report has been compiled as Appendix C to the Amendment Report.

A public participation plan (PP Plan) was compiled and submitted to the CA on the 26 August 2020. This plan was submitted in compliance with regulation GNR660 published on 05 June 2020 in terms of the Disaster Management Act (57/2002) and titled: Directions Regarding Measures to Address, Prevent and Combat the Spread of COVID-19 Relating to National Environmental Management Permits and Licences. In compliance with Section 5.1 and Annexure 2 of these regulations, a public participation plan must be presented to the competent authority for approval prior to implementation.

The plan was not granted written approval for the following reason:

“Please note that the Department has no mandate to approve the Public Participation Plan during alert level 2 of Covid-19. The direction that required

submission of PPP during level 3 is no longer applicable in level 2. However, you are required to ensure that the EIA Regulations 2014 as amended are strictly followed and ensure that the disaster management directions which are still applicable are considered”

Despite the above, Arcus have taken the decision to continue to follow the PP Plan that was submitted on 26 August 2020.

### 3 METHODOLOGY

The Public Participation Process (PPP) follows the requirements of Section 24 (5) and Chapter 6 (41, 42, 43, and 44) of GN R. 326 of the National Environmental Management Act, 1998 (Act 107 of 1998) (NEMA) Environmental Impact Assessment (EIA) Regulations, 2014 (as amended), as well as the Public Participation Guidelines in terms of NEMA, 1998 EIA Regulations, 2014.

#### 3.1 Initial Notification Phase

Notification during the initial notification period of the PPP has been undertaken in the following manner:

- A2 Correx board notices have been placed on the boundary of the site as well as in English and Afrikaans from 14 February 2020 (see Appendix C1).
- A4 posters have been placed at ten local public gathering places in the town of Pofadder and Kakamas in February 2020 (see Appendix C1). Posters were in both English and Afrikaans.
- Newspaper Advertisements were placed in the Advertisements were placed in the Gemsbok and Die Burger newspapers on 13 November 2020 (in English and Afrikaans) (see Appendix C2).
- Initial notification e-mails were distributed on 21 July 2021 to all pre-identified key I&APs including landowners, surrounding landowners, government organisations, NGOs, relevant municipalities, ward councillors and other organisations that might be affected. The notification informed I&APs of the intention of the applicant to apply for Environmental Authorisations for the proposed development (see Appendix C3 and C4). This included a locality map, brief proposed development plan and project description.
- The latest I&AP database of the authorised Paulputs WEF was used as the baseline for the pre-identified key I&APs (see Appendix C5). *This database will be updated throughout the duration of the amendment process and anyone with an interest in the proposed development is encouraged to register.*

The notices and notifications also afforded all pre-identified I&APs the opportunity to submit their issues/queries/concerns, and indicate the contact details of any other potential I&APs that should be contacted and registered. The contact person at Arcus, contact number, email and fax details will be clearly stated on the notifications.

#### 3.2 Submission: Draft Amendment Phase

The draft Amendment Report is subjected to a 30 day comment period from **Friday, 30 July 2021 to Monday, 30 August 2021 (both days inclusive).**

Written Notification (in English) regarding the availability of the Draft Amendment Report for Public Review and Comment has been sent to all registered I&APs via e-mail (Appendix C6). The written notification also advised I&APs of the following:

- How and where they can access the Draft Amendment Report (electronic and hardcopy);
- The safety measures to consider when accessing the hard copy of the Draft Amendment Report (due to the National COVID-19 Pandemic), such as the precautions to be taken for handling of the document (sanitizing / handwashing / wearing of gloves); and
- It afforded all I&APs the opportunity to submit their issues/queries/concerns/suggestions regarding the proposed development and content of the Draft Amendment Report; and
- Informed the I&APs the duration that the Draft Amendment Report was made available for public comment and the dates in which comments must be submitted.

Comments received during this period have been captured in the Comments and Responses table below.

### 3.3 Submission: Final Amendment Phase

Notification regarding the submission of the Final Amendment Report to DFFE for a decision will be sent to all registered I&APs in the following manner:

- Written Notification (English and / or Afrikaans) will be sent to all registered I&APs (pre-identified key I&APs, I&APs registered during the initial and draft report period, as well as affected landowners, surrounding landowners and their occupiers) via e-mail and post (registered mail);
- SMS notifications will be sent to I&APs and / or land occupiers that have supplied mobile phone numbers and who does not have a postal or email addresses; and
- If written notification cannot be sent to an I&AP, notification will be provided telephonically.
- The notification will inform all registered I&APs of the submission of Final Amendment Report to the competent authority for their decision making.

### 3.4 Decision and Appeal Phase

All registered I&APs will be provided with access to the decision and the reasons for such decision. Attention of all registered I&APs will be drawn to the fact that an appeal may be lodged against the decision in terms of the NEMA 1998 National Appeal Regulations, 2014 (as amended).

Notifications regarding the decision made by the DFFE will be provided in the following manner to all registered I&APs:

- Via e-mail, which will include an attachment of the decision, reasons for the decision, and appeal procedure;
- Via SMS, which will be sent to I&APs and / or land occupiers that have supplied mobile phone numbers and who does not have a postal or email addresses. The SMS will advise the I&AP that access to the decision, reasons for the decision, and appeal procedure must be accessed from the Arcus website: <https://arcusconsulting.co.za/projects/>;
- Via registered mail, which will include a complete hard copy of the decision, reasons for the decision and appeals procedure; and
- Courtesy telephone calls will be made to those who cannot receive access by either of the above-mentioned methods to advise them of the decision made by the DFFE and to confirm if and / or how they wish to receive access to the decision, reasons for decision, and appeal procedure.

I&APs will be provided with access to the decision, reasons for the decision by the DFFE and the process for appeals within 14 days of date of receipt of the decision.

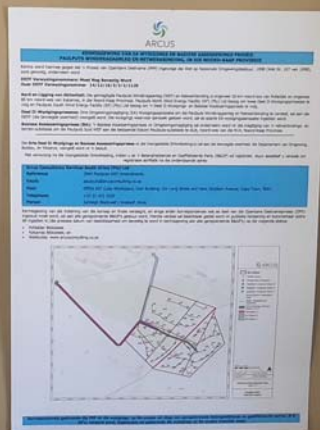
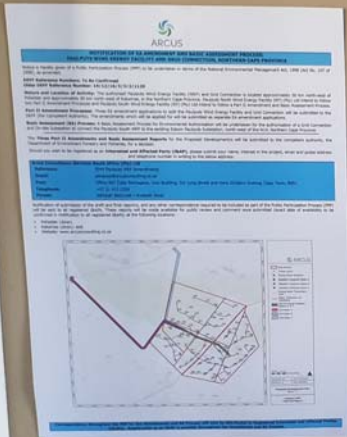

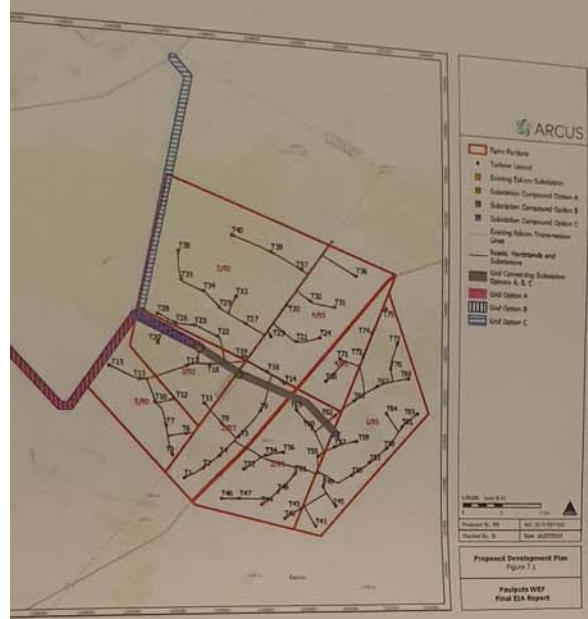

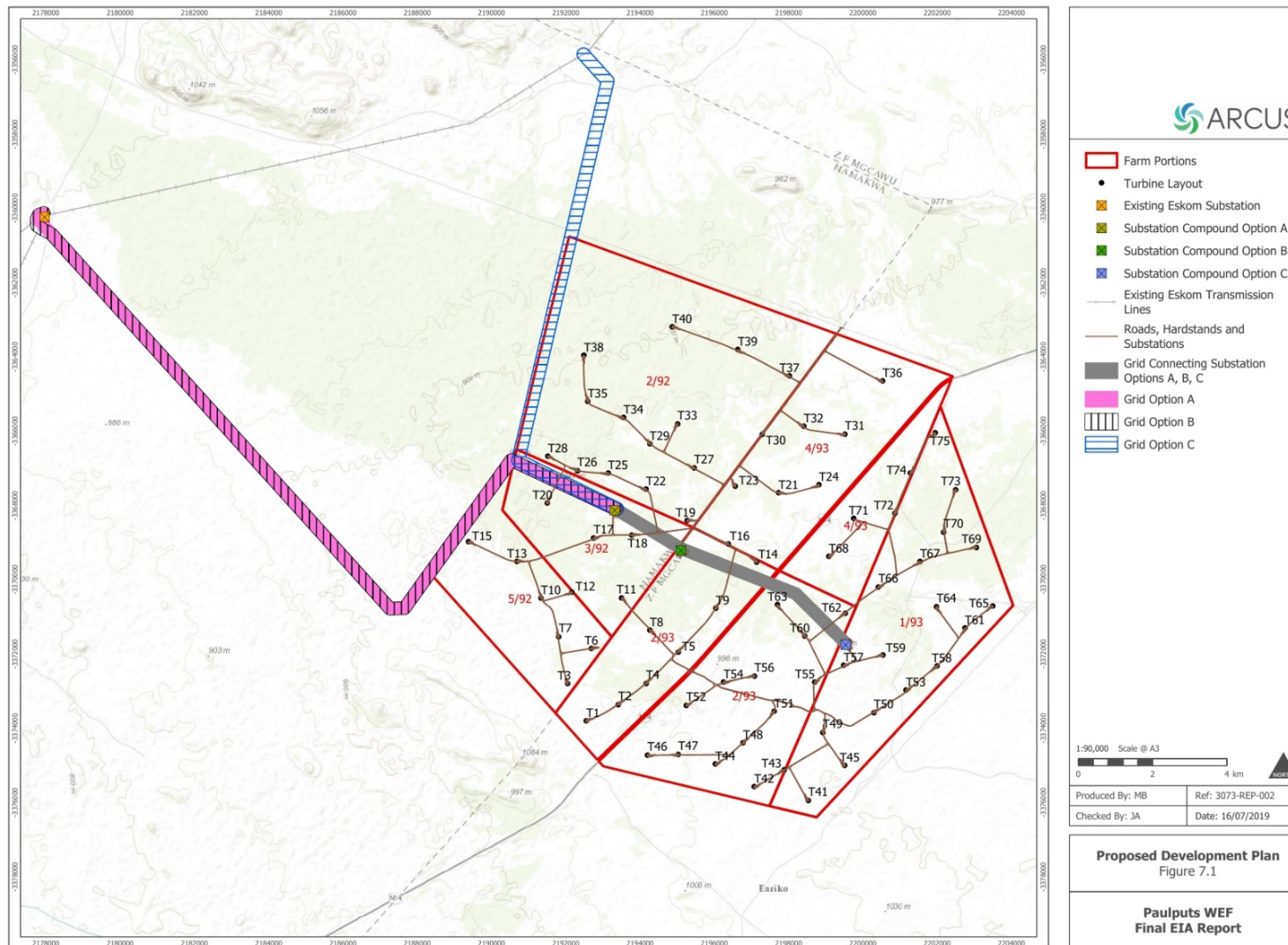


Figure 1: Approved Paulputs WEF Development Plan indicating the OHPL options and substation options assessed.

Paulputs Wind Energy Facility (RF) (Pty) Ltd ('PWEF'), a wholly owned subsidiary of WKN Windcurrent SA (Pty) Ltd, was granted environmental authorisation for the 300 MW (75 Turbine) Paulputs Wind Energy Facility (WEF) and its associated 132 kV grid connection on 11 December 2019 by the Department of Forestry, Fisheries and Environment (DFFE) (DFFE Reference No. 14/12/16/3/3/2/1120) (Figure 1). PWEF are proposing to give permission to Paulputs Wind Energy Facility North (RF) (Pty) Ltd and Paulputs Wind Energy Facility South (Pty) Ltd to split and amend the Environmental Authorisation (EA) into three amendment applications for EA.

In addition to the amendments above, the Applicant - Paulputs Wind Energy Facility South (RE) (Pty) Ltd ('Paulputs South'), intends to apply for Environmental Authorisation for the construction and operation of the Paulputs South WEF Grid Connection and associated infrastructure - which includes a substation yard and BESS.

Arcus Consultancy Services South Africa (Pty) Ltd ('Arcus') has been appointed to act as the project manager and independent environmental consulting firm to undertake the necessary Part II EA Amendment Applications and Basic Assessment Process. The Amendment Applications have been undertaken in accordance with Chapter 5 and Regulation 32(1)aa of the NEMA, 1998 EIA regulations, 2014, as amended. The Paulputs WEF ('PWEF') is authorised for the maximum height to tip of the blade of 230m, with a hub height of up to 140m, a rotor diameter of up to 180m and a blade length of up to 90m. PWEF are proposing to give permission to Paulputs Wind Energy Facility North (RF) (Pty) Ltd and Paulputs Wind Energy Facility South (Pty) Ltd to split and amend the Environmental Authorisation (EA) into three amendment applications for EA.

The summary of each amendment application is defined below. These amendments will be referred to as 'the projects' going forward in this document.

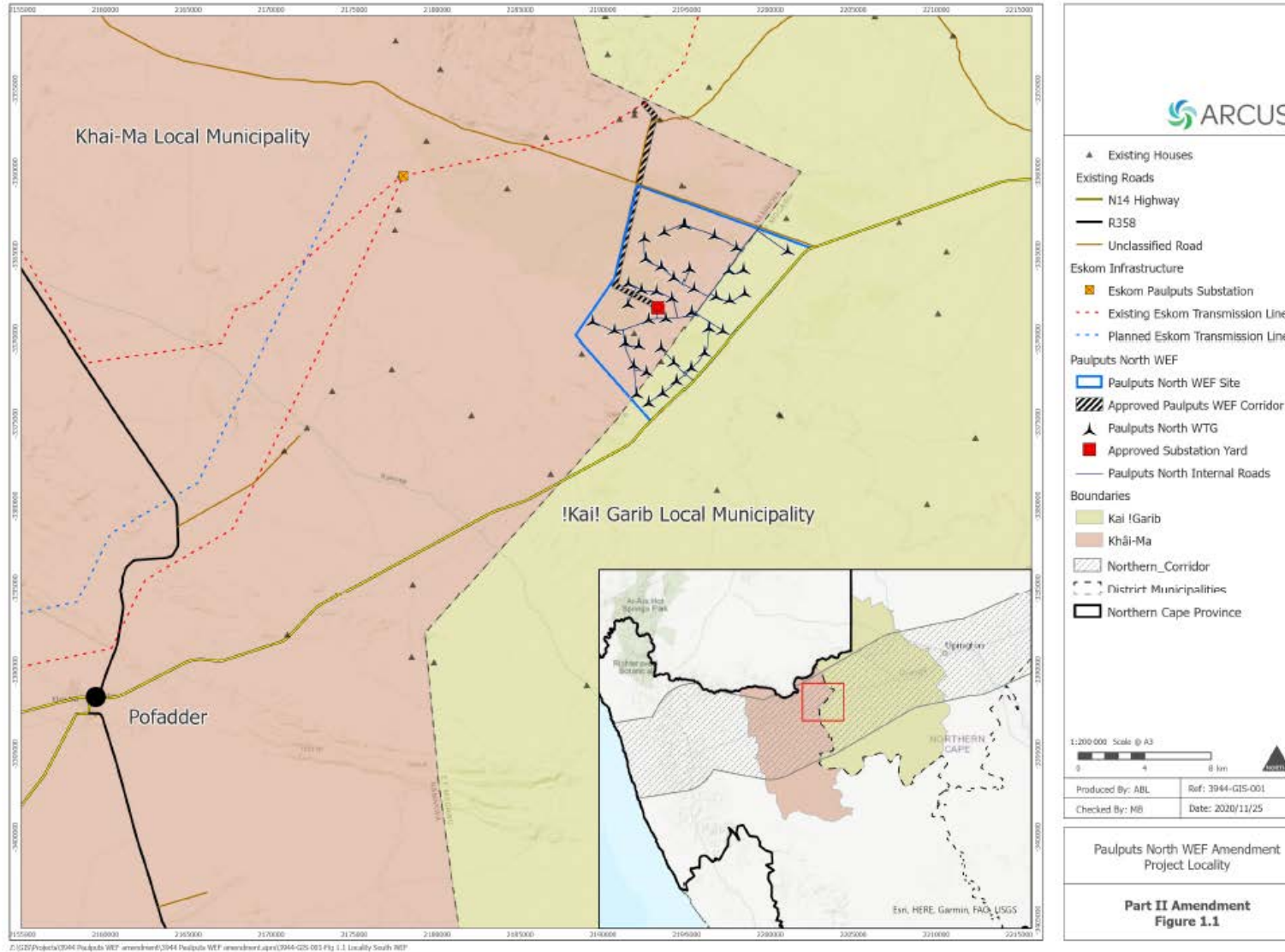


Figure 2: Paulputs North WEF Locality and the authorised Paulputs North WEF Grid Connection Locality

- **Paulputs North Amendment: (Figure 2)** Paulputs Wind Energy Facility North (RF) (Pty) Ltd ('Paulputs North') intends to construct and operate a 150MW WEF (Paulputs North WEF) consisting of up to 40 turbines, with a hub height of up to 180m, blade length of up to 110m and a rotor diameter of up to 220m. This authorisation will also include the authorised Paulputs WEF preferred on-site substation and a proposed Battery Energy Storage Facility in the area authorised for temporary laydown. All infrastructure is to be located on the north west of the N14 Highway. This amendment application and report will be referred to as the 'proposed amendment';
- **Paulputs North Grid Connection Amendment: (Figure 2)** PWEF give permission to Paulputs Wind Energy Facility North (RF) (Pty) Ltd ('Paulputs North') to remove the authorised 132 kV Grid Connection (Option C) from its authorisation in favour of ownership by Paulputs Wind Energy Facility North (RF) (Pty) Ltd ('Paulputs North') for use at the Paulputs North WEF site. The approved grid connection will be taken over by Eskom in the future and thus requires its own Environmental Authorisation. This amendment application and report will be referred to as the 'proposed amendment'; and

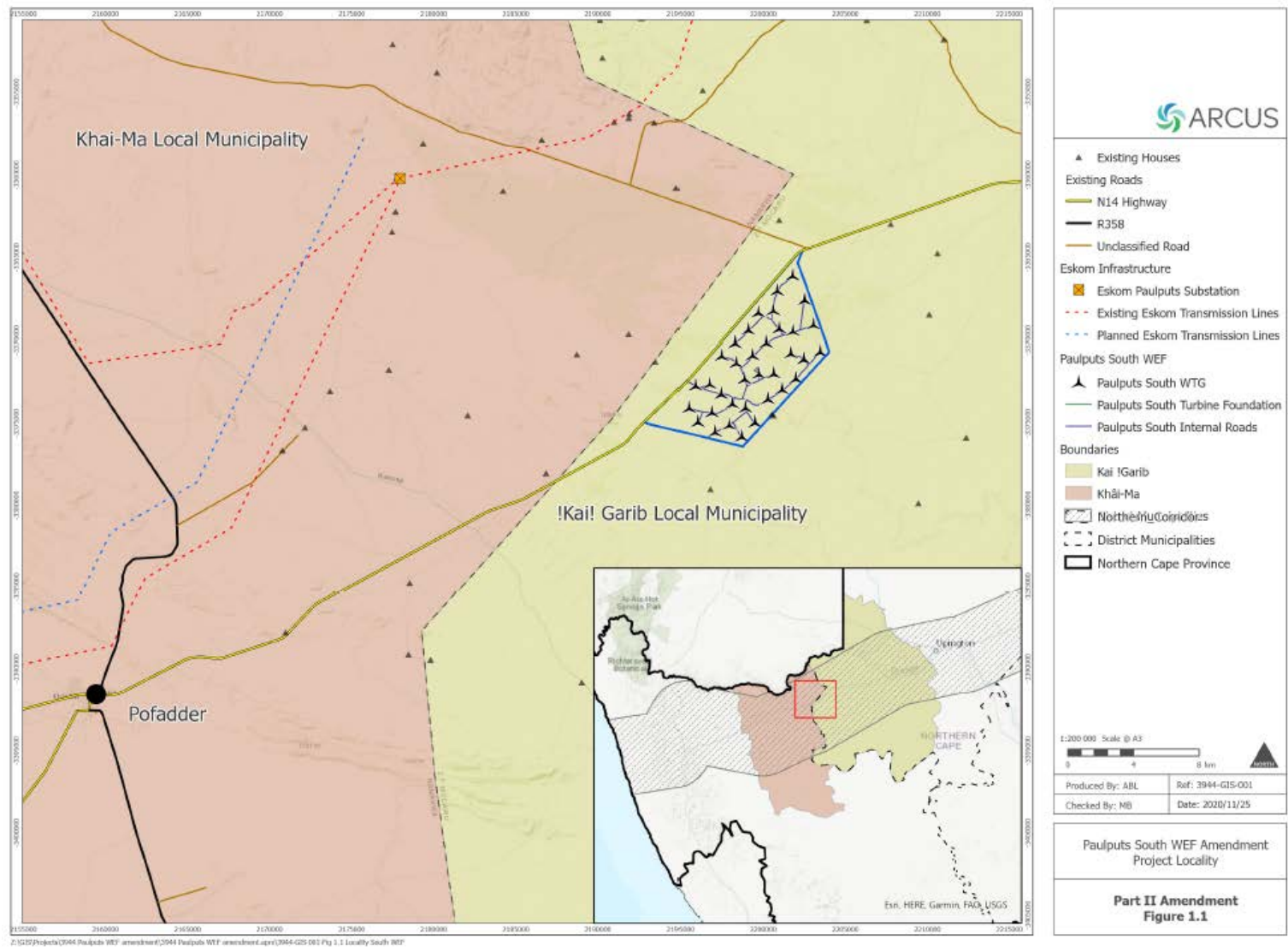


Figure 3: Paulputs South WEF Locality

- **Paulputs South Amendment: (Figure 3)** Paulputs Wind Energy Facility South ('Paulputs South') intends to construct and operate a 150MW WEF (Paulputs South WEF) consisting of up to 35 turbines, with a hub height of up to 180m, blade length of up to 110m and a rotor diameter of up to 220m

The three applications will be submitted to the Department of Forestry, Fisheries and Environment acting as the Competent Authority.

The authorised Paulputs WEF, grid connection and substation was proposed to be located approximately 35 km north-east of Pofadder and approximately 85 km north-west of Kakamas in the Northern Cape Province. The authorised Paulputs WEF was proposed to be situated in two district municipalities, the Namakwa District Municipality and the ZF Mgcawu District Municipality, and within the Khâi-Ma Local Municipality and the Kai !Garib Local Municipality.

## PROJECT DEVELOPMENT DETAILS: BASIC ASSESSMENT

---

Paulputs Wind Energy Facility (RF) (Pty) Ltd ('PWEF'), a wholly owned subsidiary of WKN Windcurrent SA (Pty) Ltd, was granted environmental authorisation for the 300MW (75 turbines) Paulputs Wind Energy Facility (WEF) and its associated 132kV OHPL on 11 December 2019 by the Department of Environment, Forestry and Fisheries (DEFF) (DEFF Reference No. 14/12/16/3/3/2/1120). As part of the original Environmental Impact Assessment (EIA), three alternative OHPL options (A, B and C) and three alternative on-site substation options (A, B and C) were assessed. The Competent Authority (CA), DEFF, chose to only issue a favourable authorisation for the preferred OHPL option 'C' and on-site substation option 'A' (Figure 1).

To comply with the Renewable Energy Independent Power Producer Procurement Programme (REIPPPP) bidding requirements, the abovementioned 300MW Paulputs WEF is being split into the 150MW Paulputs South WEF and the 150MW Paulputs North WEF (being split as part of a separate amendment application). The authorised OHPL option 'C' and on-site substation option 'A' will be used for Paulputs North WEF and a new authorisation for additional electrical infrastructure is now required to connect Paulputs South WEF to the National Grid.

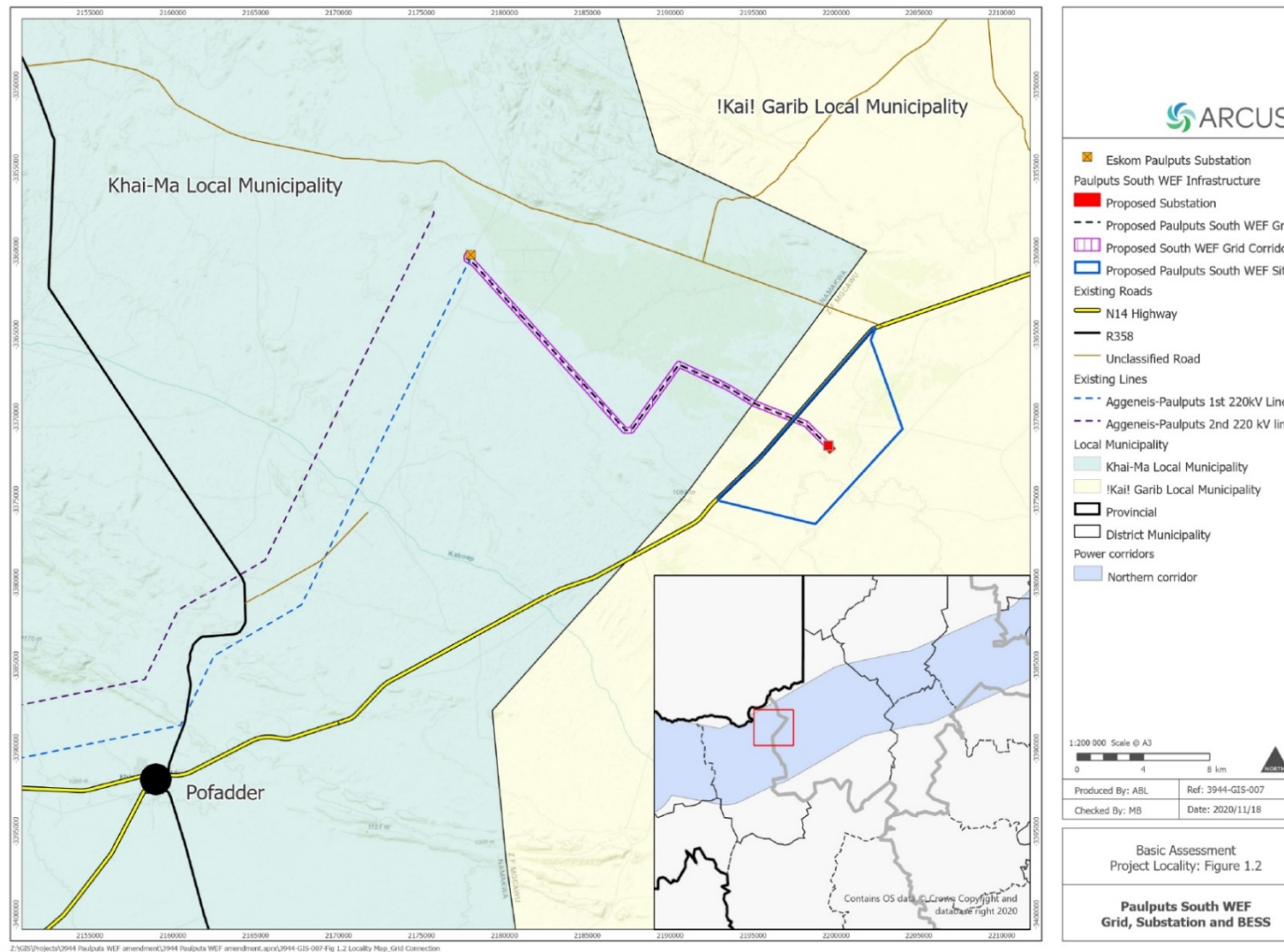


Figure 4: Locality map showing the demarcated 300m corridor for the Paulputs South WEF OHPL

As a result of the decision above, WKN Windcurrent SA (Pty) Ltd, under the Special Purpose Vehicle (SPV) Paulputs Wind Energy Facility South (RE) (Pty) Ltd ('Paulputs South'), is seeking Environmental Authorisation for the alternatives not approved in the original EIA. Paulputs South intends to construct and operate the Paulputs South WEF OHPL and Substation yard (the 'proposed development') (**Figure 4**) which, as read above, is vital for connecting Paulputs South WEF to the National Eskom Grid and for ensuring the Paulputs South WEF's successful contribution to the REIPPPP.

Both the OHPL and substation above were assessed as part of the approved Paulputs WEF (Reference No. 14/12/16/3/3/2/1120), and as such, the BAR assessment will serve to validate the information contained within the approved EIA report (Arcus, 2019) for the Paulputs WEF such that:

- The proposed OHPL route was originally referred to as the OHPL Option A; and
- The Proposed On-site Substation area was originally referred to as the Substation Option C.

The proposed development is located approximately 35 km north-east of Pofadder and approximately 80 km west of Kakamas and is situated in two district municipalities, the Namakwa District Municipality and the ZF Mgcawu District Municipality, and within the Khâi-Ma Local Municipality and the Kai !Garib Local Municipality, Northern Cape Province.

In terms of Regulation 11 of the NEMA EIA Regulations, 2014 (as amended), the Applicant ('Paulputs South') requested that the Department consider issuing two separate Environmental Authorisations for (1) A OHPL and (2) A Substation yard, including BESS, as the OHPL will eventually be taken over by Eskom. This approach has been approved by the DEFF on 08 September 2020 and one combined Basic Assessment Report and Application has been submitted for consideration.

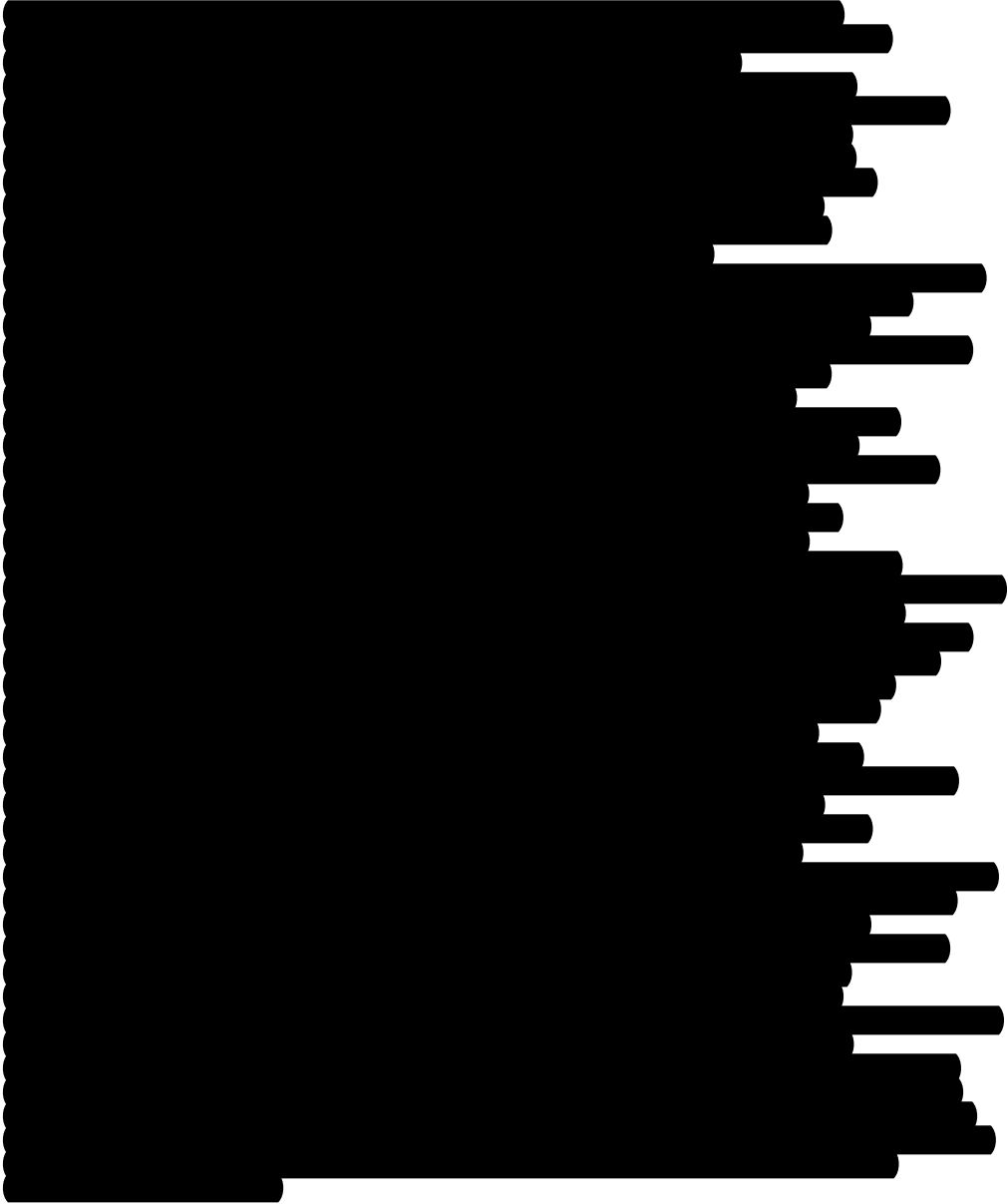

WKN-WindCurrent ('WKN') under the SPV, Paulputs WEF (RF) (Pty) Ltd, received environmental authorisation for the Paulputs Wind Energy Facility (WEF) on 11 December 2019, DEFF Reference No. 14/12/16/3/3/2/1160. Paulputs WEF is currently authorised for a maximum of 75 wind turbines with a total generation capacity of 300 MW, each with a maximum hub height of 140 m (rotor diameter height 180 m), one on-site substation (Option A) and an Overhead Power Line (grid connection) (Option C).

Two separate Part II Amendment Application is being undertaken to split the authorised Paulputs WEF into (1) Paulputs WEF North and (2) Paulputs WEF South - divided by the N14 National Highway. This letter addresses the Basic Assessment undertaken in respect of a 132 kV on-site substation and 132 kV Grid Connection for the Paulputs WEF South.

Paulputs Wind Energy Facility South (Pty) Ltd ('Paulputs WEF South') are proposing the construction and operation of:

- Paulputs WEF South 132 kV, double circuit, loop-in/loop-out Grid Connection
- Paulputs WEF South 4 Ha on-site substation and battery storage.

Both the 132 kV grid connection and on-site substation were assessed as part of the approved Paulputs WEF (Reference No. 14/12/16/3/3/2/1160), however the DEA:DEFF only considered the preferred alternative for the approval of the EA. The Applicant appeals to the DEA:DEFF to consider allowing for a combined Environmental Authorisation (EA) Application and Basic Assessment report to be submitted in terms of Regulation 11 (3) and Regulation 11 (4).

**Regarding Regulation 11 (3 and 4) Motivation:** The Applicant intends to undertake activities triggered in respect of the on-site substation, as well as activities triggered in respect of the grid connection, within the same development, of which both are located on the Paulputs WEF South site. The grid connection will terminate at the Paulputs Eskom Substation. The proposed development of the on-site substation and grid connection are interrelated - the development of one may not proceed without the other. Combining the on-site substation and grid connection into a single basic assessment report will be preferable to simplify the EA Application process.

Following the above motivation, the Applicant would require the receipt of separate EA's, as the Grid Connection EA is expected to be transferred to Eskom after construction of the overhead powerline.



Impacts (including cumulative impacts) in respect of the on-site substation and grid connection have already been assessed as part of the Approved Paulputs WEF. For the submission of this basic assessment application, the original assessments undertaken by independent specialists (August 2019) have been revisited and verified. Verification letters will be submitted, alongside the original assessments, with this basic assessment report.

**Conclusion:**

In conclusion, the Department can expect the submission of one basic assessment EA application, for which two separate Environmental Authorisations is requested.

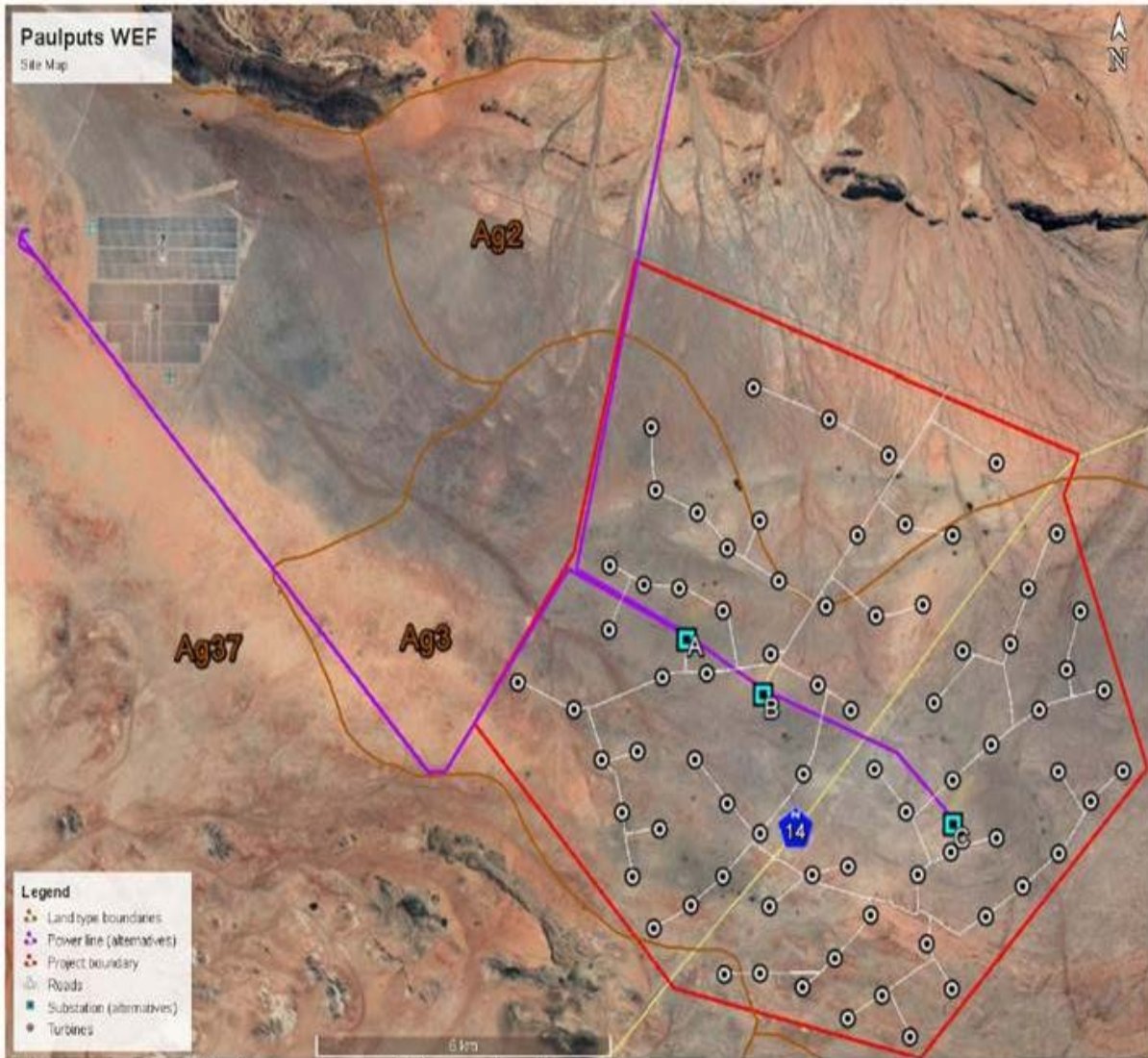

The main correspondence received was from I&APs requesting to be registered on the I&AP database or for their details to be amended or removed in the database. These comments have not been included in the responses table, but are contained within Appendix 6. Three separate comments were received from Transnet requesting that the EAP provide a KMZ of the proposed development.

Comment was received from the DFFE in response to the EAPS request that the DFFE issue two separate EAs, assessed in one basic assessment report. A comment from a stakeholder was for clarity on the proposed development proposed project start date.
