## 1 Introduction

PalRho Explorations Pty Ltd (PalRho) is a subsidiary of Ivanhoe Mines Ltd. PalRho intends to obtain a Prospecting Right through the completion of a Prospecting Right Application (PRA) for the Farm Blinkwater 244KR in terms of Section 16 of the Minerals and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) (MPRDA). The proposed project triggers Listed Activities in terms of the Environmental Impact Assessment (EIA) Regulations, 2014 (GN R982 of 4 December 2014, as amended) (the “EIA Regulations, 2014”) promulgated under the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA).

PalRho appointed Digby Wells Environmental (Digby Wells) as the Environmental Assessment Practitioner (EAP) to independently facilitate the EA application processes relevant to the proposed prospecting activities.

PalRho do not have any authorisations granted on the above-mentioned farm on which the proposed activities will be undertaken and as such require the relevant environmental authorisation from the Limpopo Department of Mineral Resources and Energy (DMRE). The minerals to be prospected includes Platinum Group Elements (PGE’s) and associated minerals like Gold, Copper, Nickel, Vanadium, Titanium, Chromium, Iron and Phosphorus etc..

The proposed prospecting sites are located 10 kilometres southwest of the town of Mokopane in the Limpopo Province within an area dominated by sediments of the Transvaal Supergroup and intrusive rocks of the Bushveld Complex, namely the Northern Limb of the Bushveld Complex. Table 1-1 Below present the locality setting and the extent of the farm area to be impacted by the proposed activities to be undertaken.

To Note: There are existing community villages located within the surrounds of the farm properties which fall under the Limpopo Provincial House of Traditional Leaders and Mogombane Tribal Authority who will be regarded as interested parties to the project to ensure an inclusive consultation process is undertaken. The communities that have been identified are Ga-Lekalakala, Mokopane Extension 14, Sekgakgapeng and Chroompark.

This report details the processes and activities which were undertaken as part of the Public Participation Process (PPP) as well as the methods of public consultation in support of the PRA.

## 2 Legal Framework

A phased-consultative approach has been adopted to carry-out the PPP activities as a legislative requirement in terms of Chapter 6 of the EIA regulations, 2014 (as amended) in accordance with Section 24(5) and 44 of the NEMA. The phased-consultative approach includes the following, namely:

- Phase 1-Application and Submission of Stakeholder Engagement Plan
- Phase 2-Announcement phase
- Phase 3-Consultation phase; and
- Phase 4- Decision making phase by the DMRE.

Phase 1,2 &3 have been completed and the last phase of the process is the decision-making phase of which the DMRE will issue a decision on the outcome of the application.

## 3 Public Participation Process Objectives

The objectives of the Announcement phase and Consultation Phase were as follows:

- To provide information and the environmental-legal process followed for the proposed project;
- To identify and register Interested and Affected Persons (I&APs);
- To provide I&APs with an opportunity to comment on the proposed project;
- To utilise local knowledge to identify and record material environmental and social issues and concerns associated with the proposed project;
- To consult with registered I&APs who are impacted by the proposed project; and
- To record all issues and comments for inclusion into the Draft and Final Basic Assessment Report (BAR).

## 4 Approach and Methodology for Public Participation

The methodology undertaken and implemented for the Public Participation Process is briefly outlined below:

### 4.1 Public Participation Activities Undertaken

The following activities were undertaken during the second and third phase of the proposed project:

#### 4.1.1 Compilation of Stakeholder Database

The following steps were followed prior to placement of sites notices:

- Existing information was received from the Applicant with regards to the directly affected farm portions;

- Digby wells then conducted windeed searches to verify the ownership of the directly affected farm portions and a land tenure plan was compiled; and
- A Public Participation Plan was developed and submitted to DMRE detailing the approach and activities to be undertaken with stakeholders.

As part of the Public Participation Process, the following information material was compiled:

- Notification Letter;
- Background Information Document;
- Site Notice; and
- Newspaper Advertisement.

A site visit was conducted to place site notices in and around the project, the locations of these site notices was chosen based on the rate at which the place is frequented. The following activities were then carried out after placement of site notices:

- Information about outstanding property ownership was gathered;
- Additional stakeholders were identified when the site notices were placed in the surrounding areas;
- Government officials were identified through the internet and verified telephonically; and
- Additional stakeholders were identified after the Draft BAR was made public, the stakeholders requested to be added as I&APs and a consolidated database was then compiled with all the I&APs.

#### 4.1.2 Public Participation Communication Channels

The legislative requirements indicate that specific materials and communication tools be utilised as part of the Public Participation Process to identify, inform and engage with I&APs as outlined below:

Digby Wells developed and submitted a Public Participation Plan in terms of the Covid-19 Regulations (GN R 650 of 5 June 2020) to the Limpopo DMRE. The Public Participation Plan outlined measures and actions to be adopted during the project stakeholder consultations especially in case of Focus Group Meetings. This was submitted to the relevant DMRE Case Officer on 19 of March 2021.

- **Background Information Document (BID):** BIDs with Comment and Registration Form (CRF) were emailed to stakeholders on **31 March 2021**. The BID entailed a project description, geographic location of the project, legislative processes, and requirements the stakeholder engagement and registration processes as well as contact details of the Digby Wells Stakeholder Engagement Office. A CRF was attached to the BID and provided for stakeholders to use for registration as I&APs or to submit comments. The BID was available in English and Sepedi. Information regarding the availability of the Draft BAR was also provided;

- **Newspaper advertisement:** Two newspaper advertisements in Sepedi and English were placed in the **Seipone Madireng (Sepedi)** on **31 March** and **Bosveld Local Newspaper (English)** on **1 April 2021**. The advertisements included a brief project description, legal framework, the competent authorities, details of the appointed EAP, and the registration process for I&APs;
- **Announcement Letter:** A letter was sent via email in English which contained information about the proposed project, applicable legislation, details of the environmental process and information about availability of the Draft BAR for public comment was emailed to stakeholders on the database on **31 March 2021**;
- **Site notices:** Site notices in both Sepedi and English were erected at various places on **31 March 2021** as indicated in Table 4-1 which contained a brief project description, legal framework, the competent authorities and details of the EAP as well as the registration process for I&APs; and
- **SMS:** An SMS was sent to registered I&APs on 31 March 2021 to announce the availability of the Draft BAR for public comment

### 4.1.3 Stakeholder Consultation

Focus Group Meetings (FGMs) were conducted with directly and indirectly affected landowners, district and local municipality and the tribal authority. The comments of all I&APs were captured on the Comments and Response Report (CRR). The aim of these FGMs was to present the proposed project to I&APs and record their comments. Stakeholders were grouped accordingly, and the following approach was then adopted:

#### 4.1.3.1 Landowners

The information about landowners was retrieved from Windeed searches and assistance from adjacent landowners. A landowner assisted in providing information about the project area, a BID was also distributed to the landowner. The various landowners identified subsequently contacted telephonically and via Email with regards to site access request to their properties and confirmation of meeting details.

#### 4.1.3.2 National, District and Local Authorities

##### 4.1.3.2.1 **Cooperative Governance, Human Settlements and Traditional Affairs (CGHSTA)**

The CGHSTA was notified of the proposed project through the distribution of the BID and Notification Letter regarding the availability of the Draft Basic Assessment Report for public review by email correspondence on 31 March 2021. Subsequently, a follow up email correspondence was sent to the Department to request a written confirmation on the legal dispute between the leadership structures of the Mogombane Tribal Authority on 12 April 2021. No response was received on this email and as such, the stakeholder engagement specialist from Digby Wells personally visited the Provincial CGHSTA offices and directly



engaged with the Deputy Director of Legal Services on 16 April 2021. He then provided a brief background; emphasising the sensitive nature of this issue and dynamics of the leadership of the Mogombane Tribal Authority. It was indicated that the Farm Lisbon 288 KR Portion 1 is owned by the Mogombane Tribal Authority and that the legal dispute is related to the leadership progression. A total of five individuals are currently contesting for the leadership of the Chieftaincy of the Mogombane Tribal Authority and that the outcome of the legal case will be finalised with the High Commission. To this effect, Digby Wells has since engaged with the different representatives of the Mogombane Tribal Authority and other representatives from the royal family attended the Focus Group Meeting held on 20 April 2021.

#### **4.1.3.2.2 Waterberg District Municipality**

The Waterberg District Municipality was informed of the proposed project initially through the distribution of the BID and Notification Letter regarding the availability of the Draft Basic Assessment Report for public review by email correspondence on 31 March 2021. Thereafter, the stakeholder engagement specialist from Digby Wells visited the Waterberg District in person on 16 April 2021 to request a meeting with the relevant authorities from the Municipality. The office of the speaker and the secretary to the Municipal Manager were informed of the project and agreed to the meeting request. The meeting was scheduled and held with the Department of Planning and Development on 20 April 2021.

#### **4.1.3.2.3 Mogalakwena Local Municipality**

It should be noted that the BID and Notification Letter regarding the availability of the Draft Basic Assessment Report for public review were distributed to the Mogalakwena Local Municipality on 31 March 2021. Subsequently, telephone correspondences were made on 12, 13, 14 and 15 April 2021 to the Municipality to follow up on whether the information about the proposed project was received and to further request for a meeting without success. To this effect, the stakeholder engagement specialist from Digby Wells directly visited the Municipality on 16 April 2021 to engage in person with the relevant officials.

The Office of the Speaker from the Mogalakwena Local Municipality confirmed that the information pertaining to the project and the request for a meeting was received. However; delayed the response due to outstanding legacy issues between Ivanplats and the Municipality in respect to Mine Community Development projects. The Applicant was informed of this information and a separate meeting was held between the relevant representative from Ivanplats and the Mayoral Office on 21 April 2021. Subsequent to this meeting, Digby Wells was given permission to engage with the Municipality. A meeting was then arranged with the Environmental Manager from the Planning and Development Department as held on 3 May 2021. The Environmental Manager indicated that she has not received any information pertaining to the project and requested copies of the Draft Basic Assessment Report in order to provide written comments. Digby Wells has since re-submitted the relevant Basic Assessment Reports directly to the Environmental Manager for comment. This information was sent by email correspondence on 03 May 2021.

#### 4.1.3.3 Stakeholder Comments

All comments raised by I&APS during the FGMs and commenting period have been captured in the CRR which will be attached as an Appendix in this report. Once comment period has lapsed stakeholders have an opportunity to directly send their comments to the DMRE.

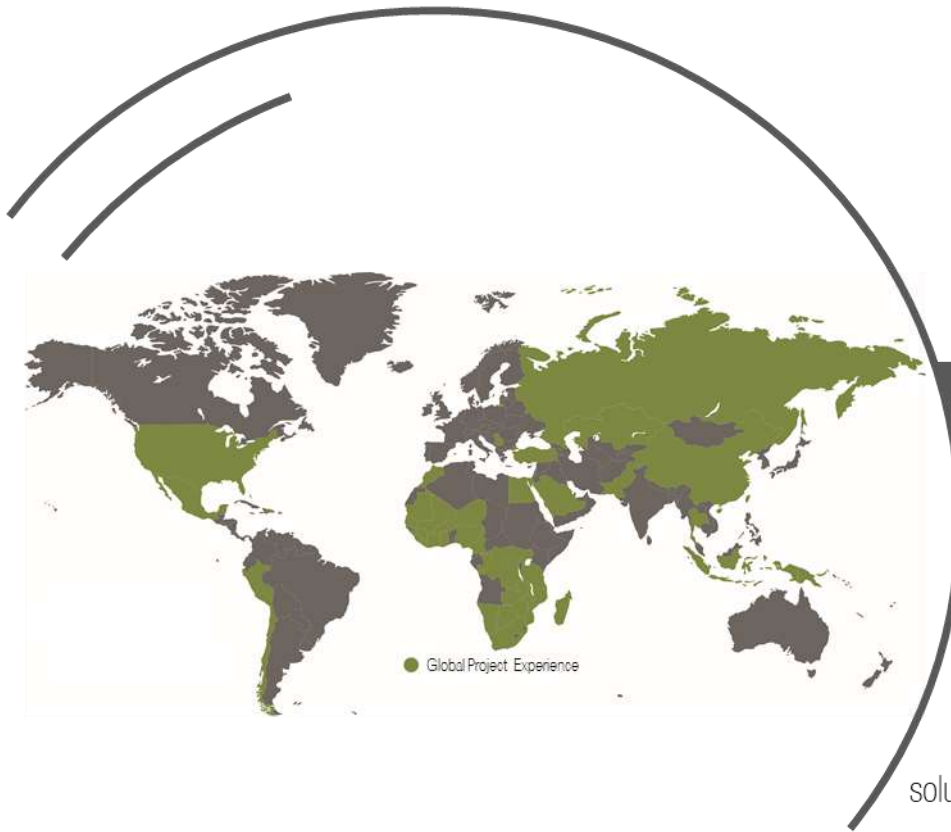

## 1. Introduction

PalRho Exploration Proprietary Limited (hereinafter PalRho), a subsidiary of Ivanhoe Mines Ltd. (hereinafter Ivanhoe Mines) intends to obtain Prospecting Rights through the completion of separate Prospecting Right Applications (PRAs) on the Farms Blinkwater 244KR, Lisbon 288KR and Moorddrift 289KR respectively in terms of Section 16 of the Minerals and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) (MPRDA).

PalRho has appointed Digby Wells Environmental (hereinafter Digby Wells) as an independent Environmental Assessment Practitioner (EAP) to submit the Environmental Authorisation (EA) applications and undertake the necessary environmental and social studies for the PRAs. This is done in order to fulfil the legal requirements of the MPRDA and the project-triggered Listed Activities in terms of the Environmental Impact Assessment (EIA) Regulations, 2014 (GN R982 of 4 December 2014, as amended) (the "EIA Regulations, 2014") promulgated under the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA).

As part of the EA process, a Public Participation Plan is required to inform and facilitate the deliberations with identified Interested and Affected Parties (I&APs) with the intension to:

- Provide background and description of the proposed prospecting activities;
- Present an overview of the legislative framework to be followed for the EA process including the public participation process (PPP);
- Provide a platform for open dialogue and meaningful participation by all identified I&APs within the ambit of the COVID-19 national regulations and associated restrictions; and
- Invite all I&APs to register as stakeholders in order to provide comments, raise issues or concerns, and/or provide suggestions to enhance the positive impacts and mitigate or limit negative impacts of the prospecting activities.

The Public Participation Plan activities will be conducted within a regulated framework in compliance with the Covid-19 Regulations (GN R 650 of 5 June 2020) as it relates to national environmental management permits, in conformance with Alert Level 1 as adjusted (GN R 151 of 28 February 2021) which applies nationally and consideration of Ivanhoe Mines Sustainability Report, 2019.<sup>1</sup>

### 1.1. Background and Locality

PalRho do not have any authorisations granted on the above-mentioned farms on which the proposed activities will be undertaken and as such require the relevant Prospecting Rights and EAs from the Limpopo Department of Mineral Resources and Energy (DMRE).

The minerals to be prospected includes Platinum Group Elements (PGE's) and associated minerals such as Gold, Copper, Nickel, Vanadium, Titanium, Chromium, Iron and Phosphorus. The proposed prospecting sites are located 10 kilometres southwest of the town of Mokopane in the Limpopo Province within an area dominated by sediments of the Transvaal Supergroup and intrusive rocks of the Bushveld Complex, namely the Northern Limb of the Bushveld Complex. Table 1-1 below presents the DMRE EA Application reference numbers for each application, locality setting and extent of the farm areas to be impacted by the proposed prospecting activities to be undertaken.

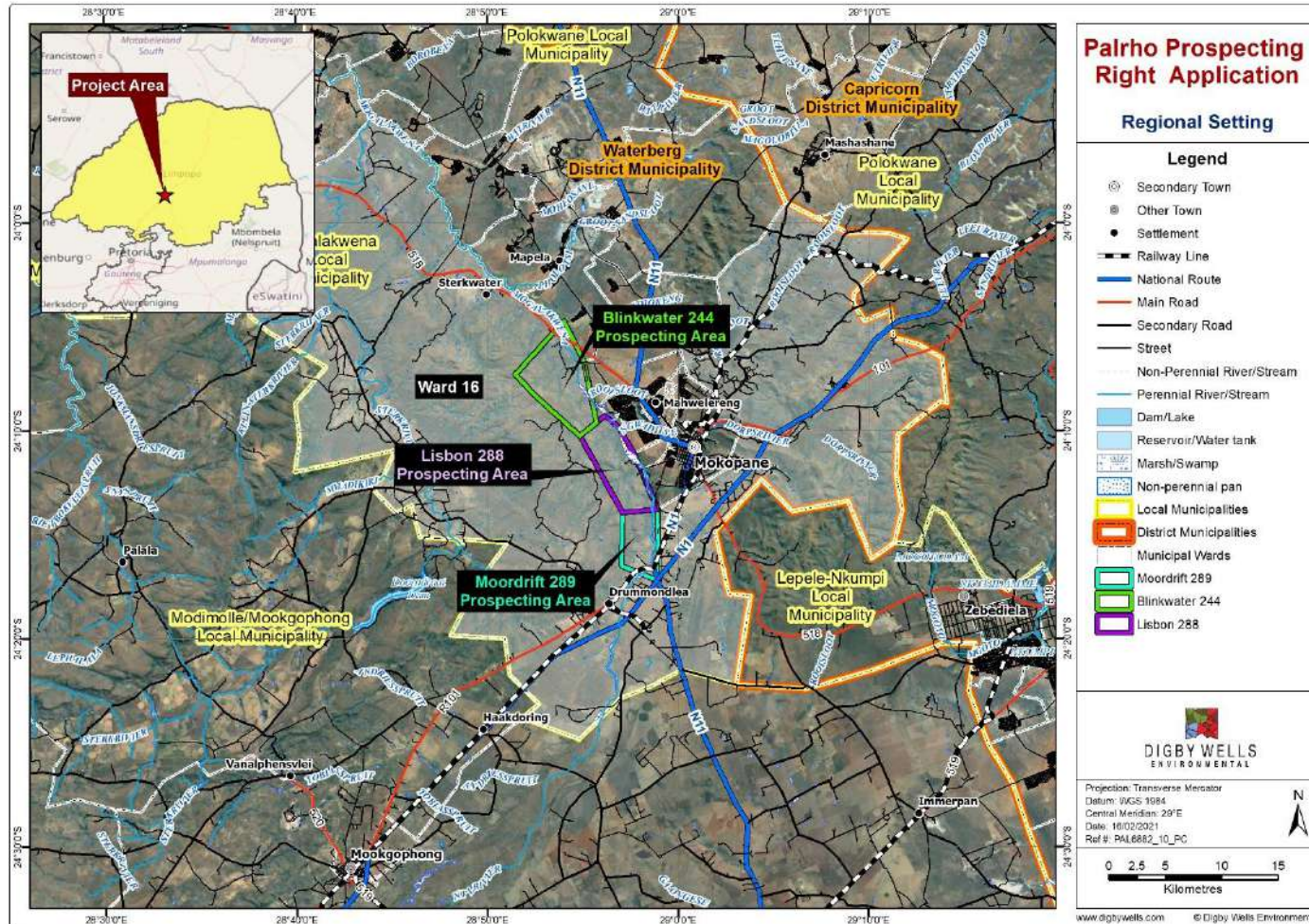

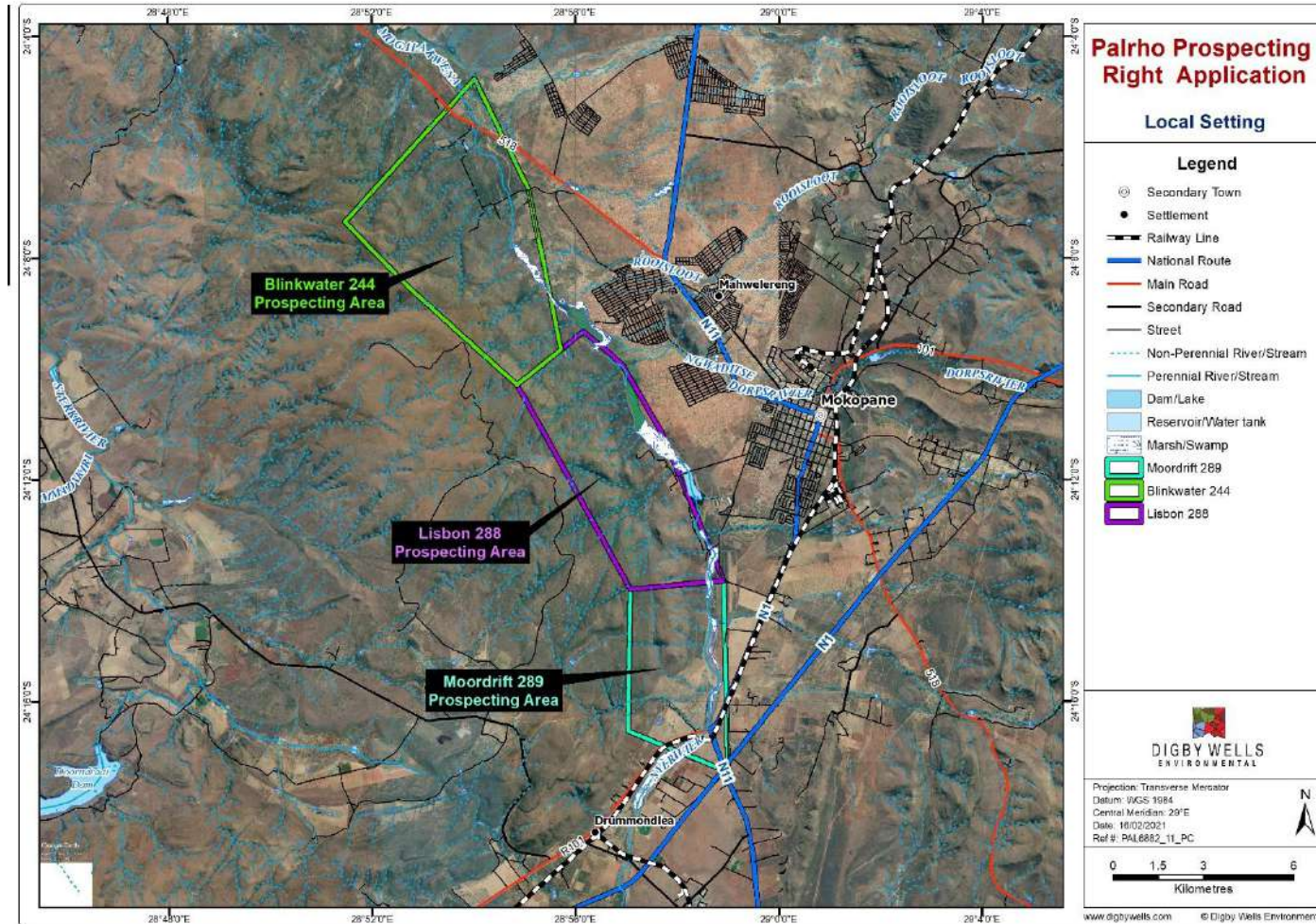


## 1.2. Purpose and Approach for Public Participation Plan

The purpose of this document is to provide a high level overview of the activities to be concluded as part of the PPP. Digby Wells has adopted an integrated-approach to undertaking the PPP, with the view of consolidating the PPP activities of the three EA applications to avoid stakeholder fatigue. This Public Participation Plan must be viewed as a living document that will continuously be refined based on the interactions and comments raised by identified and registered I&APs of which the outcomes will be captured in the environmental reports to be compiled for this application.

## 2. Policy and Legislative Framework

This Public Participation Plan is governed by the national South African legislation framework, including various Acts and Regulations. Integral to these legal requirements is the requisite engagement with I&APs, including but not limited to regulatory authorities, traditional authorities, potential impacted host communities and other interest groups to establish long lasting, collaborative partnerships.

This section provides a summary of the relevant policy and regulatory framework that informed the development of the Public Participation Plan.

### 2.1. National and Local Legislation

For purposes of this document, the applicable legislative framework will follow the requirements governed by the MPRDA, EIA Regulations, 2014 (as amended), the requirements around SARS-Cov-2 (COVID-19) Regulations and Ivanhoe Mines company specific policies that govern engagement with interested and affected parties.

It should be noted that three separate EA applications have been lodged with the DMRE as the competent authority for consideration and Digby Wells will compile and submit three separate Basic Assessment Reports relevant to each application for approval. However, since the prospecting areas are contiguous and are undertaken by the same applicant a combined PPP will be undertaken for all three applications.

The following section presents a summary of the applicable regulatory framework as indicated below.

### 2.2. National Legislation

Although most of South Africa's legislation includes aspects on stakeholder engagement, this section focuses on pieces of legislation most relevant to stakeholder engagement in general and the mining industry specifically.

#### 2.2.1. The South African Constitution

Although it does not directly call for stakeholder engagement, the Constitution outlines human rights with the intention of establishing "a society based on democratic values, social justice and fundamental human rights", which is achieved through the promotion of human dignity, equality and the advancement of human rights and freedoms. Some of the human rights that are explicitly stated in the Constitution are a person's right to equality, freedom of expression and association, political and property rights, housing, healthcare, education, access to information, and access to courts. The latter two rights are relevant to stakeholder engagement, i.e. affording stakeholders the opportunity (right) to project information and access to a grievance mechanism (as unresolved grievances can be referred to a court of law).

### **2.2.2. The Minerals and Petroleum Resources Development Act, 2002**

The MPRDA regulates the minimum consultation required with stakeholders when applying for prospecting or mining rights. This entails a 30-day window period in which interested and affected persons are allowed to submit their comments on a prospecting or mining right application, but the Act does not specify the lengths to which an applicant must go to elicit comments. However, once an application has been approved, the applicant is required to submit an Environmental Management Plan (EMP), which is regulated by the NEMA and which requires extensive stakeholder consultation. Recent court case *Samancor Chrome Limited v VDH Holdings (Pty) Ltd and 10 Others* concluded that S22 of the MPRDA provides that the applicant must show that it has taken reasonable steps to notify and consult with interested and affected parties and therefore does not place a duty on the applicant to ensure that the affected persons exercise their rights. If the I&APs were provided an opportunity to engage and they chose not to do so, this does not equate to a denial of the right to be consulted.

The Amendment Regulations (Government Notice (GN) R420 of 27 March 2020) to the Mineral and Petroleum Resources Development Regulations, 2004 (GN R 527 of 23 April 2004) is more specific in terms of consultation requirements specifically Regulation 3A and 3B. The MPRDA AA has redefined community as a “group of historically disadvantaged persons with interests or rights in a particular area of land on which the members have or exercise communal rights in terms of an agreement, custom or law”. Where such persons are found, the MPRDA Amendment Act (AA) states that consultation with the community is required and that such consultation or engagement should be extended to all communities directly affected by mining. Furthermore, the applicant is required to submit a Social and Labour Plan (SLP) in terms of Section 5a (c) of the Act including for prospecting activities.

The MPRDA AA Section 12 does not limit this consultation period to 30 days but instead stipulates that the applicant is required to “consult in the prescribed manner with the landowner, lawful occupier and any interested and affected party and to include the result of the consultation in the relevant environmental reports”. These environmental reports are under the auspices of NEMA.

### **2.2.3. The National Environmental Management Act, 1998**

One of the core functions of NEMA is to facilitate and promote stakeholder engagement in environmental governance. To this end, NEMA stipulates that one of the general objectives of integrated environmental management is to “ensure adequate and appropriate opportunity for public participation in decisions that may affect the environment”.

Chapter 6 of the NEMA EIA Regulations, 2014, Regulations 39 – 44 (GN R982 of 04 December 2014) of ) details the requirements for public participation during environmental impact assessment processes. These requirements stipulate the following:

- Regulation 39. (1) If the proponent is not the owner or person in control of the land on which the activity is to be undertaken, the proponent must, before applying for an

environmental authorisation in respect of such activity, obtain the written consent of the landowner or person in control of the land to undertake such activity on that land; and

- Regulation 40. (1) The PPP to which the Basic Assessment Report (BAR) and Environmental Management Programme report (EMPr), and where applicable the closure plan, submitted in terms of regulation 19 is subjected to, must give all potential or registered interested and affected parties, including the competent authority, a period of at least 30 days to submit comments on each BAR and EMPr.

(2) The public participation process contemplated in this regulation must provide access to all information that reasonably has or may have the potential to influence any decision with regard to an application unless access to that information is protected by law and must include consultation with-

- a) the competent authority;
- b) every State department that administers a law relating to a matter affecting the environment relevant to an application for an environmental authorisation;
- c) all organs of state which have jurisdiction in respect of the activity to which the application relates; and
- d) all potential, or, where relevant, registered interested and affected parties.

#### **2.2.4. The Disaster Management Act, 2002 (Act No. 57 of 2002): Amendment of regulations issued in terms of Section 27(2) for Alert Level 1**

The purpose of this directive issued by the Minister of Cooperative Governance and Traditional Affairs is to amend the regulations in order to align with the requirements specific to Alert Level 1 as means to reduce the threat posed by the SARS-Cov-2 (COVID-19) pandemic and to alleviate, contain and minimise the effects of the national state of disaster. In particular to provide directions to ensure fair licensing processes and public participation processes as required by the laws contemplated. Digby Wells will comply with the regulations during the PPP activities to be concluded for this application as outlined in Section 3 below.

### **2.3. District and Local Legislation**

Digby Wells will consider applicable legislation under the Waterberg District Municipality and Mogalakwena Local Municipality in order to ensure alignment prior to commencement of any prospecting activities. This includes but not limited to:

#### **2.3.1. Mogalakwena Municipality (By-Laws SPLUMA, 16 August 2016): Chapter 2 (10) Local Spatial Development Framework and Chapter 4: Land Use and Rezoning for specific land use**

The by-law requires more details in respect of a proposal provided for in the municipal spatial development framework or necessary to give effect to the municipal spatial development framework and or its integrated development plan and other relevant sector plan. Furthermore,

Zoning may be made applicable to a land unit or part thereof and zoning need not follow cadastral boundaries.

### 2.3.2. District and Local Integrated Development Plans

**To Note:** The Waterberg District Municipality and Mogalakwena Local Municipality Integrated Development Plans (IDPs) will be considered should the prospecting activities be proven to be feasible to proceed to Mining Right Application process. In such instances, PalRho will be required to consider Mine Community Development projects as part of their Social and Labour Plan (SLP) process.

## 2.4. Ivanhoe Mines Company Policies

Ivanhoe mines is committed to accelerating progress towards The United Nations' Sustainable Development Goals (SDG) as adopted by Member States in 2015 as a universal call for action to end poverty, protect the planet, and ensure that all people enjoy peace and prosperity by 2030; termed the 2030 Agenda for Sustainable Development (the 2030 Agenda).

According to the Sustainability Report, 2019; Ivanhoe Mines aims to deliver the SDGs at each of their principal projects, based on a mapping analysis which assessed current SDG compliance with regard to our current initiatives and practices.

The Report presents the strategic roadmap with input from management and stakeholders, with the aim of ensuring that initiatives and practices achieve the maximum return on investment and benefit over time.

Ivanhoe Mines key strategic priorities are to:

- Ensure focused Leadership - through actions;
- The value of human resources;
- Respecting and promoting diversity;
- Sustainable community partnerships;
- Environmental responsibility and innovation;
- The right to work, safety, health and skills development;
- Respect for human rights with the Universal Declaration of Human Rights (UNDHR) as guidance;

PalRho as a subsidiary company of Ivanhoe Mines follows suite of these priorities and towards the proposed project.

### 3. Public Participation Methodology

The MPRDA AA requires that a meaningful consultation process to be undertaken with all I&APs including the competent authority responsible for the EA application. Meaningful consultation now “*means that the applicant has in good faith facilitated public participation in such a manner that reasonable opportunity was given to provide by the landowner, land occupier or I&APs in respect of the land subject to the application about the impact of the prospecting or mining activities would have to his or her right of use of the land by availing all relevant information pertaining to the proposed activities enabling the parties to make an informed decision regarding the impact of the proposed activities.*”

Furthermore, “*I&APs means a natural or juristic person or an association of persons with a direct interest in the proposed or existing prospecting or mining operation or who may be affected by the proposed or existing prospecting or mining operation.*” These include, but are not limited to:

- Mine Communities;
- Landowners Traditional Council as defined in section 1 of the Traditional Leadership and Governance Framework Act, 2003;
- Land Claimants who have lodged claims in terms of the Restitution of Land Rights Act, 1994 which have not been rejected or settled in terms thereof;
- Lawful land occupier;
- Holders of informal rights to land as defined in section 1 of the Interim Protection of Informal Land Rights Act, 1996;
- The Department responsible for Agriculture, Land Reform and Rural Development;
- The Department responsible for Co-operative Governance and Traditional Affairs;
- The Department responsible for Human Settlements, Water and Sanitation;
- Any other person (including on adjacent and non-adjacent properties) whose socio-economic conditions may be directly affected by the proposed or existing prospecting or mining operation;
- The Local Municipality;
- Civil society; and
- The relevant Government Departments, agencies and institutions responsible for the various aspects of the environment and for infrastructure.

#### 3.1. Identification of Potential Interested and Affected Parties

It is important to conduct a stakeholder mapping of the proposed prospecting activities in order to determine the level of effort required for each stakeholder group. In general, those stakeholders requiring the greatest engagement effort are those who are most affected and/or



have the highest level of influence over the proposed prospecting activities. The level of influence of each I&APs will only be assessed during the public participation activities.

As such, Digby Wells has categorised I&APs as follows:

- Individuals, groups or local communities that may be **affected** by the prospecting activities, positively or negatively, and directly or indirectly; and
- Parties who are **interested** in the prospecting activities because of their legal mandate, business interest, knowledge, social and/or political influence.

The following section outlines the I&APs who have been identified to be consulted with at the time of compiling this Public Participation Plan. The identification of potential I&APs is a continuous process and new stakeholders may be identified during the course of the EA process and will subsequently be recorded accordingly. 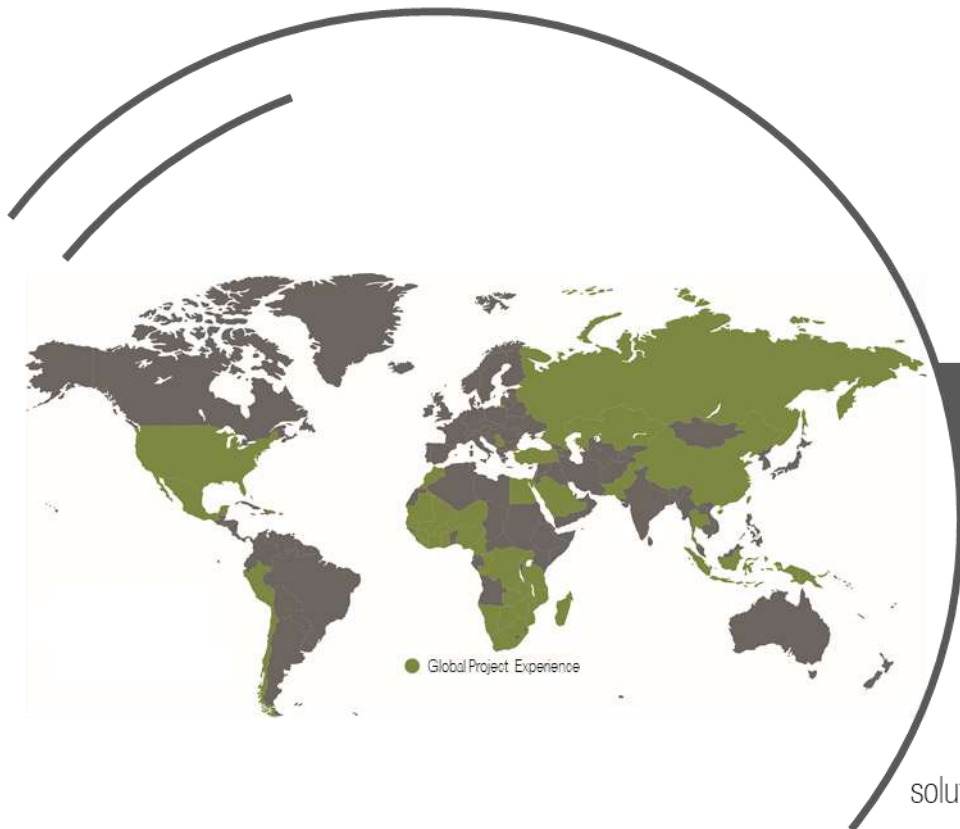

## 1 Purpose of this Document

The purpose of this Background Information Document (BID) is to provide all Interested and Affected Parties (I&APs) with information regarding the proposed prospective activities to be undertaken by PalRho Exploration Proprietary Limited (hereinafter PalRho) on the Farms Blinkwater 244KR and Lisbon 288KR situated near the town of Mokopane within the Mogalakwena Local Municipality and the jurisdiction of Waterberg District Municipality in Limpopo Province. This document aims to:

- Provide a description of the proposed prospecting activities;
- Provide an overview of the required environmental authorisation process to be followed;
- Present details of the regulated Public Participation Process (PPP) to be followed; and
- Invite all I&APs to register as stakeholders in order to provide comments, raise issues or concerns, and/or provide suggestions for the enhanced benefit of the Project.

## 2 Background

PalRho is a subsidiary of Ivanhoe Mines Ltd. PalRho intends to obtain separate Prospecting Rights through the completion of a Prospecting Right Application (PRA) for the respective Farms in terms of Section 16 of the Minerals and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) (MPRDA). The proposed project triggers Listed Activities in terms of the Environmental Impact Assessment (EIA) Regulations, 2014 (GN R982 of 4 December 2014, as amended) (the "EIA Regulations, 2014") promulgated under the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA).

PalRho do not have any authorisations granted on the above-mentioned farms on which the proposed activities will be undertaken and as such require the relevant environmental authorisations from the Limpopo Department of Mineral Resources and Energy (DMRE). The minerals to be prospected includes Platinum Group Elements (PGE's) and associated minerals like Gold, Copper, Nickel, Vanadium, Titanium, Chromium, Iron and Phosphorus.

## 3 Location of Proposed Prospecting Activities

The proposed prospecting sites are located 10 kilometres southwest of the town of Mokopane in the Limpopo Province within an area dominated by sediments of the Transvaal Supergroup and intrusive rocks of the Bushveld Complex, namely the Northern Limb of the Bushveld Complex. Table 3-1 below presents the locality setting and extent of the farm areas to be impacted by the proposed prospecting activities to be undertaken.

To Note: There are existing community villages located within the surrounds of the farm properties which fall under the Limpopo Provincial House of Traditional Leaders and Mokopane Traditional Council who will be regarded as interested parties to the project to ensure an inclusive consultation process. The communities that have been identified are Mmalepeteke, Sekgoboko, Marateng, Sekgakgapeng; and Chroompark.

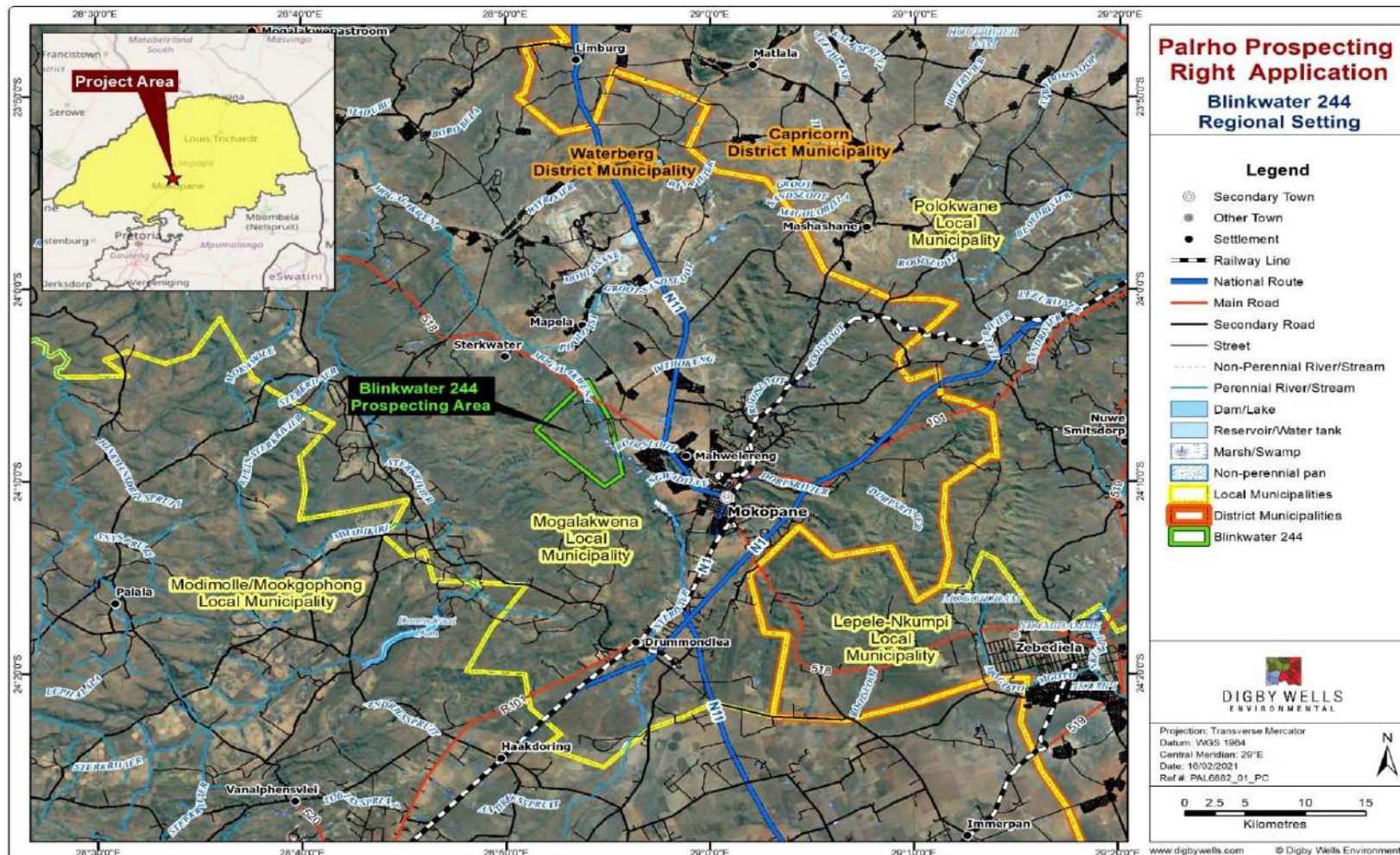


Figure 3-1: Regional Setting for the Proposed Blinkwater 244 Prospecting Right

Figure 3-1 and Figure 3-1 below shows the Regional Setting of the proposed prospecting sites on Blinkwater 244 and Lisbon 288 respectively in relation to the boundaries of Ward 16 of the Mogalakwena Local Municipality and Limpopo Provincial House of Traditional Leaders and Mokopane Traditional Council.

### 3.1 Description of Proposed Prospecting Activities

A Prospecting Right is a permit which allows a survey or investigation of an area of land for the purpose of identifying an actual or probable mineral deposit. Should the Prospecting Right be granted, the following activities will be undertaken in a phased-approach in line with the Prospecting Work Programme (PWP), namely:

#### 3.1.1 Establishment Phase

The following activities will be undertaken during the site-establishment phase:

- Electro-magnetic survey;
- The establishment of temporary access route / tracks which will make use of the shortest distance from an existing road
- Site clearance and vegetation removal for the drill rig (145 m<sup>2</sup>);
- The establishment of sumps / trenches to separate and store oil, sludge and water; and
- Stockpiling of topsoil.

#### 3.1.2 Operational Phase

The activities during the operational phase will include:

- Geochemical soil sampling;
- Geological mapping;
- Outcrop sampling;
- Obtain permissions to drill onsite; and

- Drilling and retrieval of the samples for analysis.

### 3.1.3 Closure and Rehabilitation Phase

The closure and rehabilitation phase will include:

- Dismantling and removal of infrastructure; and
- Rehabilitation (topsoil cover, ripping and vegetation establishment).

No permanent infrastructure will be constructed as part of the prospecting activities. The prospecting activities will include both invasive and non-invasive methods. Non-invasive methods include data capturing of all relevant geological data, a geophysical survey which utilises digital data to confirm proposed drill locations and structures as well as analytical work of the samples taken. Invasive methods will include the core drilling (approximately ten holes per prospecting site, therefore a total of 30 holes will be drilled) to ascertain the stratigraphy sequence and reef horizons of the ore body.

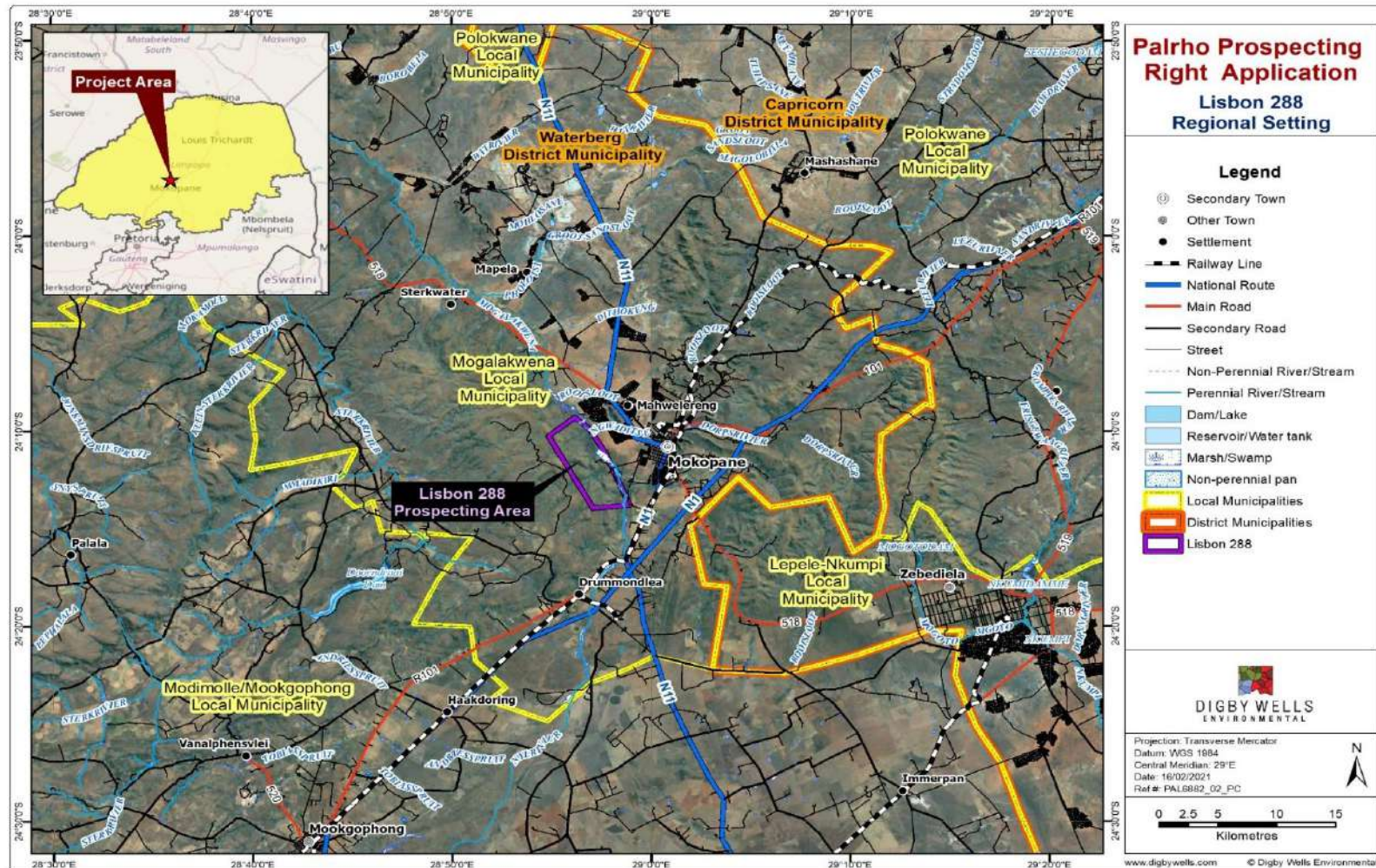


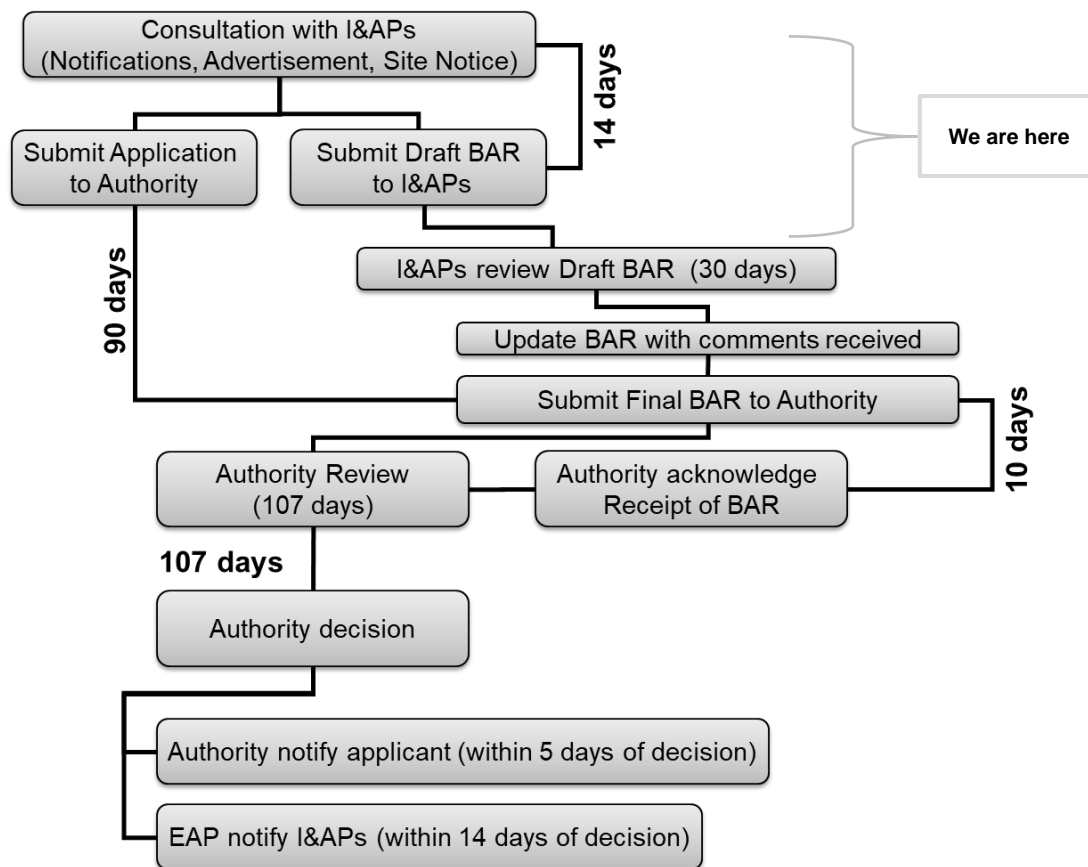
Figure 3-2: Regional Setting for the Proposed Lisbon 288 Prospecting Right



## 4 Proposed Timelines and Scheduling of the Prospecting Activities

A Basic Assessment (BA) process must be followed to obtain EA for any of the listed activities contained in Listing Notice 1 (GN R 983) as described in Regulation 19 and Regulation 20 of the EIA Regulations, 2014 (as amended). The BA requires a comprehensive public consultation process and is governed by a 197-day timeframe, from the date of submission of the EA application until the application is either approved or rejected by the competent authority.

## 6 Public Participation Process

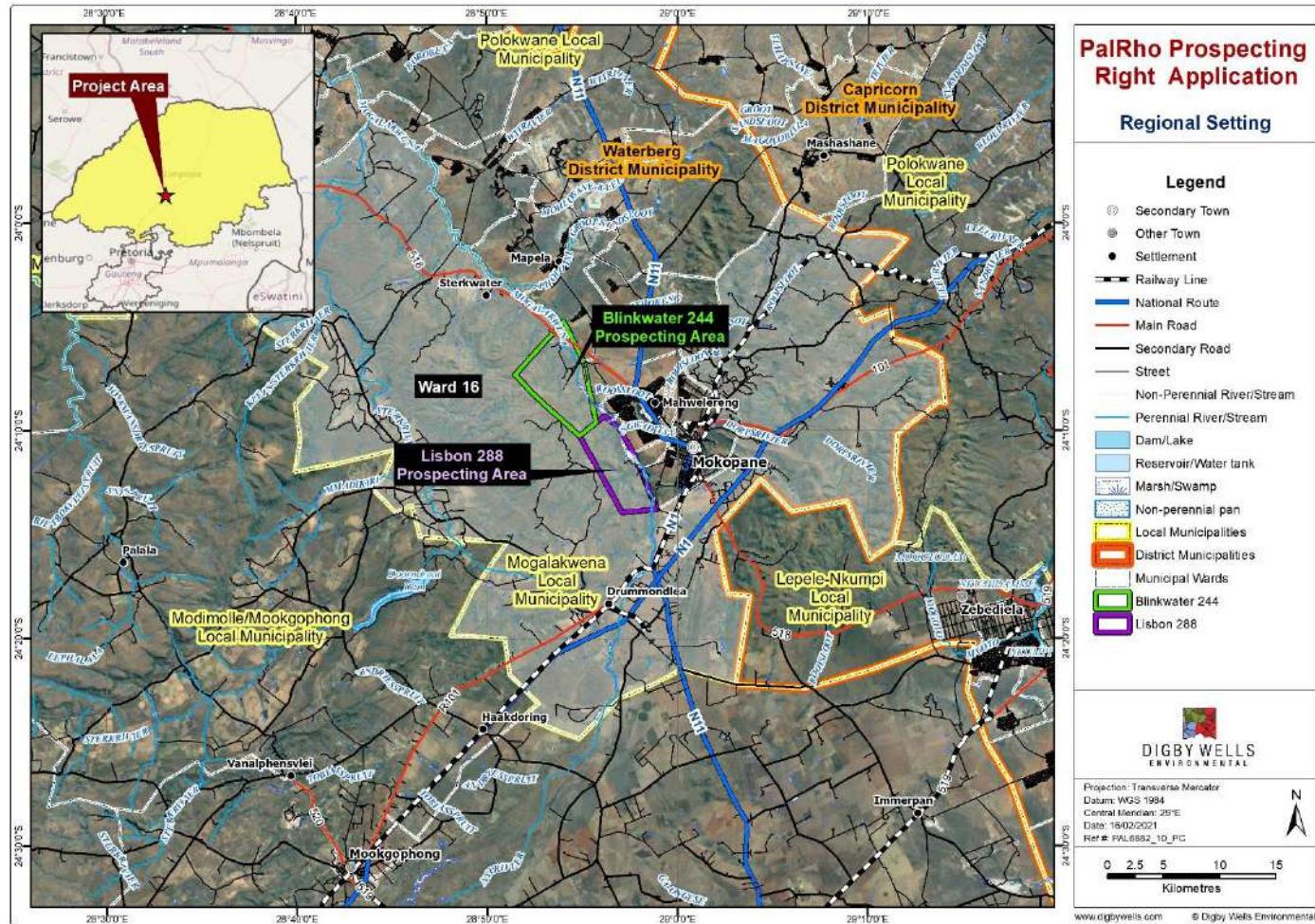

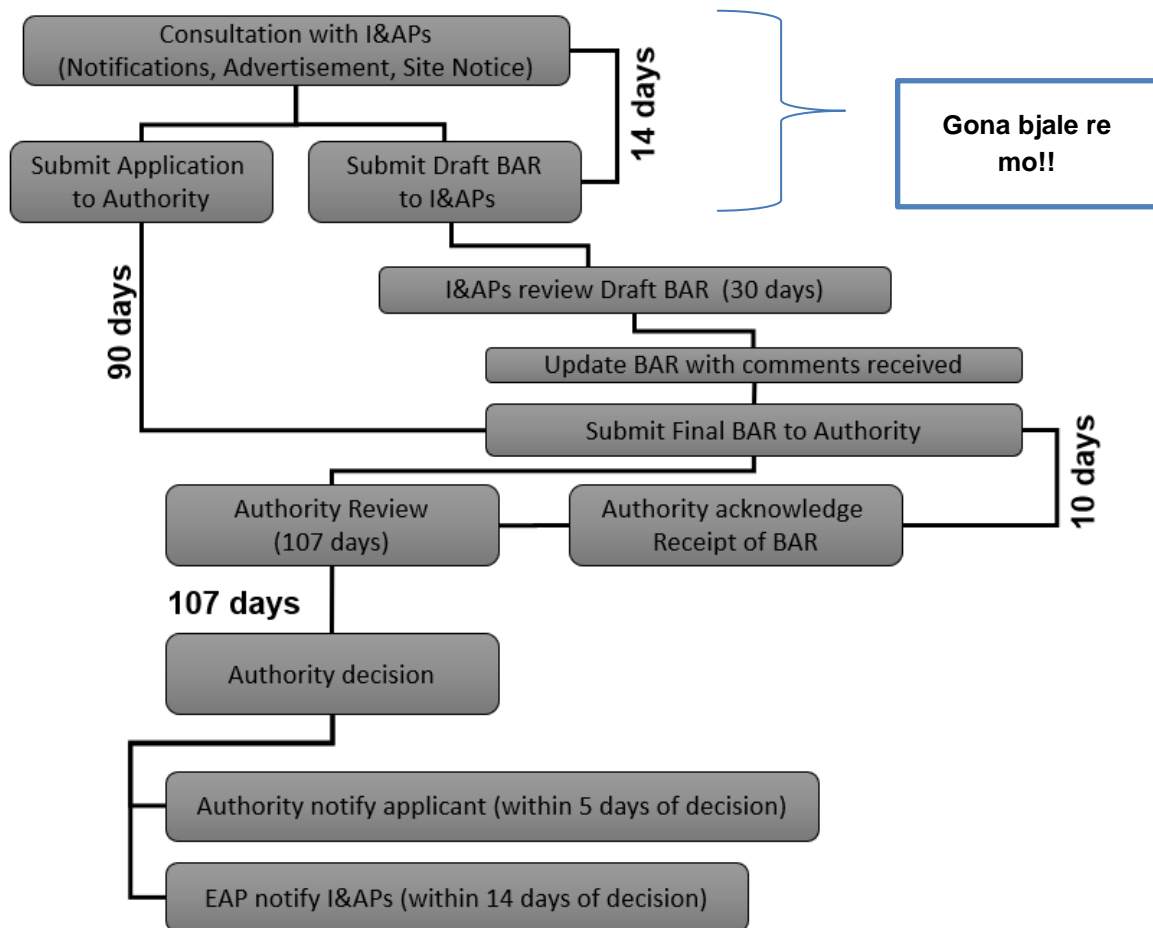
