Inkonzo ecetywayo ye- WWTW iza kunceda umbindi wedolophu yaseLusikisiki kunye nemizi efumana umvuzo ophantsi, iivenkile, udederhu lweevenkile, izindlu ezifumana umvuzo omncinci ezikufutshane nase Lusikisiki, izindlu zangasese zoluntu, isiBhedlela iSt Elizabeth, isitishi samapolisa esicetywayo esitsha, iKholeji yoQeqesho ziTitshala yaseLusikisiki, kunye neNtolongo yaseLusikisiki.

Notice is given in terms of Regulation 54, Government Notice No. R. 543 under the EIA regulations promulgated under Section 24 (5) of the National Environmental Management Act (Act No. 107 of 1998 - NEMA) of the intent to carry out the following activities:

Description of Activity

The proposed project calls for the construction and installation of a waste water treatment works (WWTW), an inception sewer and sewerage reticulation network (approximately 40 km in length) within and around the town of Lusikisiki (Ingquza Hill Local Municipality). Numerous properties will be affected by the proposed pipelines. The proposed WWTW will service the Lusikisiki town centre and middle income houses, shops, shopping malls, low income houses in close proximity to Lusikisiki, public toilets, the St Elizabeth Hospital, the proposed new police station, the Lusikisiki Teachers Training College, and the Lusikisiki Prison.

Two alternative sites have been proposed for the location of the WWTW (see map below for approximate locations). The centre coordinates of these sites are presented in the table below.

Applications have been submitted to the relevant competent authorities in terms of the requirements of the NEMA and the National Environmental Management: Waste Act (Act No. 59 of 2008 - NEMWA). A detailed map showing the extent of the proposed development is available on request and can be downloaded at the EIMS website (www.eims.co.za).
