The exemption application pertained to the lapsing of the initial application period with regards to Section 67(1) of the EIA Regulations, whereby the regulated 6 months period between the submission of the application and the submission of the Draft Scoping Report was exceeded. The said exemption was granted by MDEDET on the 10th September 2013, exempting the project from the provisions of Section 54(2)(a), (b), and (c) of the EIA Regulations which relates to the requirements of the Public Participation Process.
