## EXECUTIVE SUMMARY

### 1. PROPOSED ACTIVITY

#### 1.1 Background to Proposed Project

The Kabokweni 22/11kV substation is currently overloaded. The area has a high electrification growth and backlogs. There are worst performing feeders which contributes on SAIDI and SAIFI, impacting negatively on the performance of the region. Some feeders have capacity constraints and experiencing low voltages. The establishment of Gutshwa 1x20MVA 132/11kV substation will help to split some of the feeders and de-load Kabokweni S/S. This solution will also cater for the future growth in Kabokweni

#### 1.2 Proposed Activities

The proposed project includes:

- Build the 1x20MVA 132/11kV Gutshwa Substation.
- Build ±12km of chickadee line from Legogote Switching Station to the new Gutshwa Substation.
- Upgrade Legogote T Station into a switching station.

#### 1.3 Activity Listing

The **construction of facilities or infrastructure for the transmission and distribution of electricity** is a listed activity according to the Environmental Impact Assessment (EIA) Regulations R543, 2010 and it must be adhered to in terms of Sections 24(2)(a) and 24(d) of the National Environmental Management Act (NEMA), Act no 107 of 1998. The proposed activity is listed in

##### **Listing Notice 1, R544 of June, 2010:**

- **Activity No 10(i):** The construction of facilities or infrastructure for the transmission and distribution of electricity outside urban areas or industrial complexes with a capacity of more than 33 but less than 275 kilovolts;
- **Activity No 23(ii):** The transformation of undeveloped, vacant or derelict land of more than 1 ha but less than 20 ha to institutional use outside and urban area.

##### **Listing Notice 3, R546 of June, 2010:**

- **Activity 3(b)(ii)(gg):** The construction of masts or towers for telecommunication broadcasting or radio transmission purposes where the mast will exceed 15m in height. Outside urban areas, within 10km from a national park.
- **Activity 4(ii) (gg):** The construction of a road wider than 4m outside urban areas, within 10km from a national park.

This listing requires the **Applicant** to carry out a Basic Assessment Process.



## 1.4 Alternatives

Four (4) alternatives were evaluated; two alternative routes were identified and investigated (paragraph A & B), the 2 alternative positions for the new Gutshwa Substation, as discussed in paragraph C as well as the No Go Alternative, discussed in paragraph D. The summary of the routes, as discussed in paragraph A & B; both alternatives start at Legogote Switching Station and follows the same route in a northern direction alongside the servitude of an existing power line.

### A. Route Alternative 1

After 200m from the Legogote Switching Station alternative 1 turns in a north western direction for 1 km along the existing power line. It deflects in a northwesterly direction west for 6.325km, turns south for 2,986km and then turns west. It connects with the alternative 1 position of the proposed Gutshwa substation while the proposed alternative 2 position is a further 1km away. Alternative 1 is  $\pm 11.4$ km.

### B. Route Alternative 2

Starting at the Legogote switching station the proposed Alternative 2 route turns after 200m in a north western direction, alongside the existing power line servitude for 3,936km, then deflects to the west for 3,8km and connects with alternative 1 into a southern direction. After 2,986km it connects with the alternative 1 position of the new proposed Gutshwa substation while the proposed alternative 2 position is a further 1km away. Alternative 2 is  $\pm 11.7$ km.

### C. Gutshwa Substation 1 & 2

Both proposed sites for Gutshwa substation can be described as degraded woodland. Both sites do not contain unique features that will make those specific areas critically more significant than the rest of the degraded woodland in the study area. The proposed construction of the new substations should have a LOW habitat transformation impact, irrespective of which one of the two alternatives sites is used.

### D. No Go Alternative

The no go alternative means that the proposed power lines and substation will not be constructed. The result will be:

- Problems of low capacity power within the Legogote-Gutshwa area will not be resolved.
- Employment opportunities for local community will be lost.
- ESKOM will not be able to fulfill its bigger mandate of supplying power to all South Africans

## 2. PROPERTY DESCRIPTION

### 2.1 Location and Particulars of Property

ESKOM propose to transfer power from the Legogote Switching Station ( $\pm 12$ km) to the new proposed Gutshwa Substation via 132kV power line. A number of farm portions, as indicated in Appendix E of the report, will be affected. Both the proposed routes are closer than 10km from the border of the Kruger National Park.

### 2.2 Current Land Use & State

The properties on which the line is proposed are used for various purposes ranging from agriculture activities such as grazing and cultivation of crops, natural vegetation, existing power lines and formal and informal settlements. For the substation the land use is grazing and cultivation of crop.

### 2.3 Description of the Environment

A typical Lowveld climate prevails with seasonal summer rainfall, warm summer temperatures and dry winters. Map ranging between 550 and 800mm (increasing with altitude). Frost is infrequent. The general study area consists of plains Bushveld typical of the eastern Lowveld. The most serious transformation of the natural environment consists of cultivation of crops and formal and informal settlements which have transformed significant areas of natural land in the past few years (Van der Walt, 2012). The geology is granite and gneiss, mostly of the Nelspruit suite, forming hills with large boulders. Soils are shallow, coarse litosols, comprised of Glenrosa or Mispah soil types.

According to Mucina and Rutherford, 2006 the study area is described as Pretoriuskop Sour Bushveld and Lowveld Riverine Forests (Van der Walt, 2012). The Mpumalanga Biodiversity Conservation plan (MBCP), 2006 indicates that the area varies from “no natural vegetation” to “least concern”. The general biophysical descriptions according to Van Der Walt, 2012 are:

**“Degraded woodlands”**: This is a woodland community that has been severely degraded as a result of the local population reliance on the environment. No Red Data List (RDL) or endemic species were recorded. Due to the degraded state of this woodland it is rated as “Low” ecological importance and sensitivity.

**“Degraded riparian areas”**: This vegetation community is limited to the stream and river banks of the proposed power line routes and has been severely degraded because of human activities such as sand mining and wood harvesting. Although this community has been severely degraded it retains important stabilizing and ecological function. Characteristic Lowveld riparian trees are still present and therefore this community is rated as “Medium-Low” sensitivity.



**“Transformed land”:** these areas have been changed by human activities such as formal and informal settlements, crop production, and road infrastructure in such extent that all natural habitats, biota and ecosystem functions have been lost.

The MBCP,2006 rating for the biodiversity significance zoning of the study area is “No natural habitat remaining” and “least concern”. The “degraded woodland” and “degraded riparian areas” are both severely degraded because of the reliance on the environment and includes activities such as sand mining in the riparian areas, overgrazing, vegetation clearance for crop production and destruction of trees for fire wood and construction material. No RDL species were identified on the affected area but one (1) legally protected tree species were found. Permits have to be obtained from Department of Agriculture, Fishery and Forestry (DAFF) and Mpumalanga Tourism and Park Agency (MTPA) if protected trees or plant species are to be removed or destroyed.

### **3. PUBLIC PARTICIPATION PROCESS**

#### **3.1 Approach**

A public participation process was followed according to the Section 54 of the EIA regulations, R543, (2010). This process was executed as elaborated in the following section.

All possible Interested & Affected parties (I&AP's) were contacted and afforded an opportunity to meaningfully participate in the process. Contact was made with property owners and key interested & affected parties. Consultation meetings and one-on-one consultations were held with the tribal offices. Some issues and concerns were raised during the consultations and all these issues are recorded in the public participation report. (See attached Appendix E for the PPP and Report)

All issues raised have been properly addressed and before the report is submitted to the competent authority, it will be subjected to public review for forty days for scrutiny and comments thereof. This also gives the I&AP's an opportunity to voice their concerns regarding the proposed project. The draft report will also be available on the Environmental Assessment Practitioner (EAP) website for download to review.

#### **3.2 Further Participation**

After the forty (40) day I&AP comment period, all issues raised will be recorded and included in the Final Draft BAR. The Final Draft BAR will be available for reviewing for another 21 days. After the issuing of the Environmental Authorization (EA), the decision will be communicated to all registered I&AP's and they will be afforded the opportunity to appeal against any decision.

## 4. IMPACT ASSESSMENT

This phase identified and analyzed the potential impacts of the activities of the proposal on the biophysical and socio-economic components of the environment. Activities throughout the project; i.e. Design/Pre-construction, construction, operational and decommissioning phases were considered during the assessment. Both negative and positive impacts were assessed, negative for mitigation and positive for enhancement. The assessment also covered various areas of specialization such as biodiversity, Avi-fauna and cultural heritage. The Specialist studies for the proposed construction and operation of the proposed 132kV power line from Legogote Switch Station to the newly proposed Gutshwa Substation was undertaken to determine the possible impacts likely to arise due to the construction and operation phase. The findings of the three (3) specialists are summarized as follows:

### 4.1. Terrestrial Biodiversity

Due to the requirement of vegetation removal for ESKOM power lines it has a negative impact on vegetation communities with tall trees. Servitude (corridors) of 31m wide is required for the 132kV distribution lines and in dense (closed) and medium to high vegetation communities, the practice will be to remove all the vegetation across the servitude width for fear of damage of the power lines due to the falling of trees and accidental fires which can cause power failures. Loss of habitat will thus be of a much higher magnitude in woodlands and especially in sensitive areas such as streams, wetland or riparian areas. The loss and modification of important habitats can only be minimized by firstly aligning the servitude to make use of existing access roads and disturbed areas and avoiding sensitive habitats and by placing structures/poles on pre-selected sites of low floral importance. One legally protected tree species *Sclerocarya birrea* were found and no RDL species were identified on the affected area.

The possibility exists that several important fauna species may occur in both the alternative servitudes, but due to the mobility of most terrestrial fauna, it is not anticipated that any of the taxa will be directly threatened by the activities. The major impact on terrestrial fauna is expected to result from fragmentation of habitat. Impacts on terrestrial fauna can be minimized by using existing roads and disturbed areas and avoiding sensitive habitats such as rocky outcrops and wetlands.

The biodiversity investigation indicates that both alignments vary in sensitivity from a “Low” to “Medium” rating depending on specific aspects and features. **Alignment alternative 1 is recommended for the total length of the power line and any one of the 2 proposed substation sites are recommended by the ecologist, Mr. D. Van der Walt** (see attached Appendix D for the Biodiversity Report, August 2012).



#### 4.1.2 Avi-fauna Assessment

There are many negative interactions between wildlife and electricity structures in Southern Africa, but the two most common problems are the electrocution of birds and birds colliding with power lines as well as electrical faults caused by bird excreta when roosting or breeding on electrical infrastructure. Disturbance and habitat destruction during the construction and maintenance activities associated with electrical infrastructure can also interfere with bird activities.

The construction of the proposed new Legogote- Gutshwa 132kV power line poses a limited threat to the birds occurring in the vicinity of the new infrastructure. The power line poses a **medium** collision risk, mostly to non-Red Data species and a **medium** electrocution risk, in particular to vultures. The habitat transformation caused by the power line will have a **Low-Medium** impact on birds and should only affect non Red Data species at local level, provided the large trees are not extensively destroyed. **Alignment alternative 1 is recommended for the total length of the power line and any one of the 2 proposed substation sites are recommended by the bird specialist, Mr. C Van Rooyen** (see attached Appendix D for the Bird Impact Assessment Report, August 2012)

#### 4.1.3 Heritage Impact Assessment

The two proposed power line options were surveyed by Archaetnos CC and found that the area is largely disturbed by past human activities such as housing and agriculture. No sites of cultural heritage significance have been found. The area is largely disturbed by human activities such as different agricultural fields. According to Van Vollenhoven, August 2012, there is no distinction between route alternative 1 or 2. Though route alternative 1 is more disturbed and therefore the chances to find heritage sites are less. **Alignment alternative 1 is recommended for the total length of the power line and any one of the 2 proposed substation sites are recommended by the archaeologist, Dr. A van Vollenhoven** (see attached Appendix D for the Cultural Heritage Resources Report, August 2012)

### 4.4 Proposed Mitigation Measures

The following preventative and mitigation measures must be incorporated in the planning, construction and operational phases of the power line.

#### I. Planning Phase

- The **ESKOM Holdings** must be committed to a conservation approach during the planning phase;
- Sensitive habitats must be avoided or least sensitive crossings must be used as mitigation;
- Potential impacts on biodiversity can be mitigated by planning the power line alongside existing power lines and roads; and by considering easy and existing access.
- Riparian vegetation at river crossings and indigenous forests must be avoided altogether where possible by by-passing or by suspending the lines across from high ground to higher ground. If this is not achievable such habitats must only be disturbed where absolutely necessary and prominent trees must be avoided. It is recommended that only a minimal opening, large enough for the lines to cross without interference is created in such areas;
- Of special importance is the legally protected tree species (*Schlerocarya birrea*) that was identified in the affected areas and could be affected by the construction phase.
- The necessary plant destruction permits must be obtained from the regulating authorities prior to construction;
- A specialist must assist the surveyor to ensure that the above recommendations are followed.



- The spans that cross drainage lines should be marked with “Bird Flight Diverters”.
- Poles for the power line should be fitted with bird perches on top of the poles.

## II. Construction Phase

- The proponent must be committed to a conservation approach of practice and the actual footprint of construction/disturbance must be kept to a minimum;
- As much of the natural environment as possible must be conserved (minimal construction of access roads and bush clearing);
- Relocation of important species, identification and demarcation of specimens and sub-habitats not to be disturbed will have to be done beforehand by a specialist;
- Important species (fauna as well as flora) that will be threatened by the development must be relocated to safer habitats by suitable specialists;
- Preventative erosion control measures to be put in place.

## III. Operational Phase

- Maintenance crews must be educated with regards to the importance of biodiversity;
- Maintenance of the lines and servitudes must be done in such a manner to conserve vegetation and create the least disturbance as possible, especially at river crossings and in pristine natural areas and habitats;
- The operational phase must be monitored by ESKOM environmental officials to ensure that adequate mitigation measures are in place and to take reactive measures in places where impacts pose problems.

## 5. CONCLUSION AND RECOMMENDATIONS

For an option or project to be sustainable, it needs to demonstrate economic viability, social equity and soundness, and ecological integrity within a framework of good governance. All three of these dimensions of sustainability need to be taken into account when assessing a proposed option or project, taking due cognizance that the three dimensions are seldom in perfect balance, often dictated by local circumstances. Thus the preferred route chosen at the end of the analysis is one that has minimal impacts both ecologically, socially and in terms of heritage.

From the analysis given in the specialist reports and other site impact assessments, proposed **Alternative 1** was suggested by all the specialists as the route that will have the minimal impacts and thus is the recommended route. Although both proposed sites for the new Gutshwa substation were suggested, **Alternative 1 is recommended**. It is however recommended that the mitigation measures presented in the Environmental Management Program (EMPr) be fully implemented. If there is vagueness in the wording and actions to be undertaken, clarifications must be sought from the environmental consultant and specialists involved in the compilation of the report. The contact details are presented within the main report.

#### 1.1 Background to Proposed Project

Kabokweni 22/11kV substation is overloaded. The area has a high electrification growth and backlogs. There are worst performing feeders which contributes on SAIDI and SAIFI, impacting negatively on the performance of the region. Some feeders have capacity constraints and experiencing low voltages. The establishment of Gutshwa 1x20MVA 132/11kV substation will help to split some of the feeders and de-load Kabokweni S/S. This solution will also cater for the future growth in Kabokweni

#### 1.2 Proposed Activities

The proposed project includes:

- Build the 1x20MVA 132/11kV Gutshwa Substation.
- Build 12km of chickadee line from Legegote Switching Station to the new Gutshwa Substation.
- Upgrade Legogote T Station into a switching station.

**Two alternative routes were identified and investigated as well as 2 alternative positions for the new constructed Gutshwa Substation were proposed. The following is the summary of the routes; starting at Legogote Switching Station both alternatives follows the same route in a northern direction alongside the servitude of an existing power line.**

**A. Route Alternative 1**

After 200m from the Legogote Switching Station alternative 1 turns in a north western direction for 1 km along the existing power line. It deflects in a north westerly direction west for 6.325km, turn south for 2,986km and then turn west. It connects with the alternative 1 position of the proposed Gutshwa substation while the proposed alternative 2 position is a further 1km away. Alternative 1 is  $\pm 11.4$ km

**B. Route Alternative 2**

Starting at the Legogote switching station the proposed Alternative 2 route turns after 200m in a north western direction, alongside the existing power line servitude for 3,936km, then deflects to the west for 3,8km and connects with alternative 1 into a southern direction. After 2,986km it connects with the alternative 1 position of the new proposed Gutshwa substation while the proposed alternative 2 position is a further 1km away. Alternative 2 is  $\pm 11.7$ km

**C. Gutshwa Substation 1 & 2**

Both proposed sites for Gutshwa substations can be described as degraded woodland. Both sites do not contain unique features that will make those specific areas critically more significant than the rest of the degraded woodland in the study area. The proposed construction of the new substations should have a LOW habitat transformation impact, irrespective of which one of the two alternatives sites is used.

**D. No Go Alternative**

The no go alternative means that the proposed power lines will not be constructed and the result will be:

- Problems of low capacity power within the Legogote-Gutshwa area will not be resolved.
- Employment opportunities for local community will be lost.
- ESKOM will not be able to fulfil its bigger mandate of supplying power to all South Africans

### 2.1. IMPACTS EVALUATION

Both alternatives have medium-low scores, indicating that the environment has already been impacted significantly. Alternative 1 will have the lowest risk and management of impacts because of the more disturbed area. Alternative 1 crosses fewer roads and rivers/streams and is shorter than Alternative 2. Alternative 1 also has a reduced number of potential sensitive receptors. Although Alternative 1 is less sensitive than Alternative 2, the management and monitoring of impacts will be the same. Both alternative 1 and 2 positions for the proposed Gutshwa Sub Stations will have minimum negative environmental impact. **Alignment alternative 1 is recommended for the total length of the power line and any one of the 2 proposed substation sites are recommended by the 3 specialists.**

THIS ALTERNATIVE MEANS THAT THE PROPOSED PROJECT WILL NOT BE IMPLEMENTED AND NO ELECTRICITY WILL BE AVAILABLE FOR PEOPLE IN REMOTE RURAL RESIDENTIAL AND BUSINESS AREAS OF MBOMBELA LOCAL MUNICIPALITY. THUS THIS ALTERNATIVE IS NOT RECOMMENDED AS THE PRESENT PROBLEM WILL PERSIST.

Both alternatives have medium-low scores, indicating that the environment has already been impacted significantly. Alternative 1 will have the lowest risk and management of impacts because of the more disturbed area. Alternative 1 crosses fewer roads and rivers/streams and is shorter than Alternative 2. Alternative 1 also has a reduced number of potential sensitive receptors. Although Alternative 1 is less sensitive than Alternative 2, the management and monitoring of impacts will be the same. Both alternative 1 and 2 positions for the proposed Gutshwa Sub Stations will have minimum negative environmental impact.
