REQUEST FOR EXTENSION: APPLICATION FOR ENVIRONMENTAL AUTHORISATION FOR THE PROPOSED ESKOM NORTHERN KWAZULU-NATAL STRENGTHENING PROJECT: NORMANDIE-IPHIVA 400KV POWERLINE, WITHIN THE ABAQULUSI, eDUMBE, JOZINI, MKHONDO, NONGOMA AND uPHONGOLO LOCAL MUNICIPALITIES, IN THE uMKHANYAKUDE, GERT SIBANDE AND ZULULAND DISTRICT MUNICIPALITIES, KWAZULU-NATAL AND MPUMALANGA PROVINCES

Your letter dated 13 December 2017 and received by the Department on 08 January 2018, requesting an extension of timeframes for the submission of the final Environmental Impact Assessment Report (EIAR) for the abovementioned project, has reference.

You indicated that the biodiversity specialist studies and the associated consultations with Ezemvelo KZN Wildlife (EKZNW) have identified issues related to Biodiversity Economy Nodes and proposed Biodiversity Expansion Areas that were not known at the time of initial consultation with EKZNW, and which could not be anticipated prior to the undertaking of these assessment and consultation. As a result of this new information, you recommended that the scope of the biodiversity specialist studies and impact assessment be expanded to fully consider the impact of the proposed project on these sensitive areas. This would include identifying and assessing deviations to the corridors presented in the Scoping Report that has been accepted for further assessment, in order to avoid significant impacts on protected species.

In light of the above, you have requested an extension of timeframes for the submission of the final EIAR in terms of regulation 3(7) of GN R. 982 of the EIA Regulations, 2014 (as amended), which states that:

"In the event where the scope of work must be expanded based on the outcome of an assessment done in accordance with these Regulations, which outcome could not be anticipated prior to the undertaking of the assessment, or in the event where exceptional circumstances can be demonstrated, the competent authority

may, prior to the lapsing of the relevant prescribed timeframe, in writing, extend the relevant prescribed timeframe and agree with the applicant on the length of such extension.”

Based on the information provided by you, the Department therefore accepts and grants your request to extend the timeframes for the submission of the final EIAr for the abovementioned project by **50 days**. In this regard, you are further reminded of regulation 3 (8) of GN R. 982 of the EIA Regulations, 2014 (as amended), which states that any public participation process must be conducted for a period of at least 30 days.

You are also hereby reminded of Section 24F of the National Environmental Management Act, Act No 107 of 1998, as amended, that no activity may commence prior to an environmental authorisation being granted by the Department.
