As mentioned on the phone, Our company, KBK Engineers (Pty) Ltd, has been appointed by the South African National Roads Agency (SOC) Limited (SANRAL) to perform consulting engineering services for the improvement of the road N2 from VERZAMELING (KM 30) TO LEIDEN (KM 60) (Mpumalanga Area between Ermelo and Piet Retief).
