

BASIC ASSESSMENT PROCESS

NOTIFICATION TO INTERESTED AND AFFECTED PARTIES REGARDING APPLICATIONS FOR ENVIRONMENTAL AUTHORISATION

Notice is given in terms of Chapter 6 of Government Notice No. R. (GN R.) 982 under the EIA Regulations (2014) promulgated under Section 24(5) and 44 of the National Environmental Management Act, 1998 (Act 107 of 1998) (NEMA) (as amended), of applications for Environmental Authorisation (EA) for the following:

- ✎ The upgrading of the Giyani Waste Water Treatment Works (WWTW) for an additional capacity of 8ML/day (from current 6ML/day to 14ML/day);
- ✎ The installation of three new bulk water reservoirs with a combined capacity of 35 ML; and
- ✎ Mining Permits for the quarrying of six new borrow pits associated with the ongoing construction and upgrading of bulk water supply infrastructure in, and around, Giyani.

Nature of project:

Three separate applications will be submitted for the project components described above. A consolidated Public Participation/Involvement Process will, where possible, be carried out in support of all the applications. Several NEMA Listing Notice activities are anticipated to apply and these will be determined and assessed during the Basic Assessment (BA) process to be followed for these applications. Furthermore, depending on the BA findings, there may be a requirement for the following additional licences/authorisations:

- ✎ Waste Management Licence(s) as required by the National Environmental Management: Waste Act (Act 59 of 2008 – NEMWA); and/or
- ✎ Water Use Licence(s) as required by the National Water Act (Act 36 of 1998 – NWA).

Location:

The existing WWTW, the proposed reservoirs, as well as the sites of the proposed new borrow pits are located on Portion 0 of the farm Greater Giyani No. 891 near the town of Giyani, which is part of the Greater Giyani Local Municipality within the Mopani District Municipality, in Limpopo Province. Xitiviso xa nyikiwa hi ku landza Kavanyisa ka 6 ka Xitiviso xa Mfumo xa No. R. (GN R.) 982 ehansi ka Swinawana swa EIA (2014) leswi tivisiweke ehansi ka Xiyenge xa 24(5) na 44 xa Nawu wa Malawulelo ya Mbangu wa Rixaka, 1988 (Nawu wa 107 wa 1988) (NEMA) (tanihilaha wu hundzuluxiweke hakona), xa swikombelo swa Mpfumelelo wa Mbangu (EA) eka leswi landzelaka:

- ✎ Ku antswisiwa ka Giyani Waste Water Treatment Works (WWTW) eka vundzeni byo engetela bya 8MI/siku (kusuka eka 6MI/siku kufika eka 14MI/siku);
- ✎ Ku akiwa ka madyithangi manharhu lamantshwa ya mati hi vutalo lama nga na vundzeni lebyi katsanisiweke bya 35 ML; na
- ✎ Mipfumelelo ya swa Migodi ya ku humesiwa ka maribye eka magoji ya tsevu lamantshwa lama misava ya wona yi pfalaka kun'wana lama fambelaniswaka na ku akiwa loku yaka emahlweni na ku antswisiwa ka switirhisiwankulu swa mphakelo wa mati hi vutalo eka Giyani, na le tindhawu ta le kusuhi.

Muxaka wa phurojeke:

Swikombelo swinharhu swo hambana swi ta yisiwa eka swiphemu swa tiphurojeke leti hlamuseriweke laha henhla. Endlelo ra ku Nghenelela/Khumbeka ka Vaaki leri katsanisiweke, laha swi koteka, ri ta endliwa hi ku seketela swikombelo leswi hinkwaswo. Migingiriko yo tala ya Xitiviso xa Nxaxameto wa NEMA yi languteriwa ku endla xikombelo naswona leswi swi ta bohiwa na ku hlahluviwa hi nkarhi wa endlelo ra Nhlahluvo wa Masungulo (BA) leri landzeleriwa eka swikombelo leswi. Ku yisa emahlweni, swi karhi swi lawuriwa hi leswi kumiweke swa BA, ku nga ha va na xilaveko xa tilayisense/mipfumelelo yo engetela leyi landzelaka:

- ✎ (Ti)Layisense ya Malawulelo ya Mati tanihilaha swi lavekaka hakona hi Malawulelo ya Mbangu ya Rixaka: Nawu wa Mathyaka (Nawu wa 59 wa 2008 – NEMWA); na/kumbe
- ✎ (Ti)Layisense yo Tirhisa Mati tanihilaha swi lavekaka hakona hi Nawu wa Mati wa Rixaka (Nawu wa 36 wa 1998 – NWA).
