DECISION ON ENVIRONMENTAL AUTHORISATION

The Department is satisfied, on the basis of the information made available to it, and subject to compliance with the conditions of this Environmental Authorisation and the requirements of the Environmental Impact Report, that the applicant should be authorized to undertake the proposed activities as specified below.

ACTIVITIES AUTHORISED

By virtue of the powers conferred on it by the National Environmental Management Act, 1998 (Act No. 107 of 1998) ("NEMA") and the Environmental Impact Assessment Regulations, 2014 ("EIA Regulations") the Department hereby grants environmental authorisation to **Motuoane Energy (Pty) Ltd** to undertake activities specified in Section 3 below and as described in the Environmental Impact Report and Environmental Management Programme (EIR&EMPR).

The granting of this authorisation is subject to compliance with conditions specified under section 5 below.

Listed Activity: The clearance of an area of 300 square metres or more of indigenous vegetation except where such clearance of indigenous vegetation is required for maintenance purposes undertaken in accordance with a maintenance management plan.

The holder of this authorisation is authorized to conduct the following activities within the area described under section 4:

3.1 Non-invasive exploration activities:

3.1.1 Background data collection and data management which entails:

Identification of existing boreholes, and where emitting boreholes are identified, gas pressure and flow rate will be measured, samples collected and analysed; analysis of existing geological data, magnetic data and cores; and consultation with directly affected landowners in preparation for invasive exploration activities.

3.1.2 Geological and geophysical logging which entails:

Analysis of core samples for the presence of hydrocarbons as well as the determination of the physical properties of the rocks; and integration of geological logging and surface structures data into maps.

3.2 Invasive exploration activities

3.2.1 Geotechnical and soil sampling:

Soil sampling which entails the removal of small sections of the soil profile using a soil auger which is 75 mm in diameter, at depths of between 15 and 30 centimetres on average. The duration of the sampling will be short term, i.e. it may take days to weeks to complete.

3.2.2 Diamond core drilling:

Drilling of up to 3 wells; the first of the 3 wells will be drilled in the vicinity of the existing blower in the area of interest in order to obtain more data on the geology and potential hydrocarbons. The drilling of the two wells, including their locations will depend on the results of the first well. The surface footprint of each well pad is approximately 30m x 30m in extent and the total footprint area for all 3 sites will be 0.27 ha.

4. LOCATION AND DESCRIPTION OF THE APPLICATION AREA

The proposed exploration area covers various farms and farm portions near Hennenman town in the Free State Province, extending north, from approximately Theunissen, north east towards Kroonstad and east of Virginia and Hennenman. The said farms and farm portions are within the District Municipalities of Lejweleputswa and Fezile Dabi (see appendix 2 concerning the affected farm properties). The application area is approximately 149 377 hectares in extent.

5. CONDITIONS OF THE ENVIRONMENTAL AUTHORISATION

5.1 SCOPE OF AUTHORISATION

5.1.1 The holder is authorised to undertake the following exploration activities as outlined in the EIR:

- 5.1.1.1 Non-invasive operations: Background data collection and data management and geological and geophysical logging,**
- 5.1.1.2 Geochemical and soil sampling, and**
- 5.1.1.3 Drilling of up to 3 diamond core wells.**

5.1.2 The authorised activities must only be carried within the application area specified under section 4 above and appendices 2 and 3.

- 5.1.3 The holder of this environmental authorisation (hereafter referred to as the Holder) is responsible for ensuring compliance with the conditions of this environmental authorisation, and recommendations made in the Environmental Impact Assessment and Environmental Management Programme Report (EIR/EMPR) dated 30th of January 2017.
- 5.1.4 Any person(s) acting on behalf of the holder, inclusive of contractor(s), subcontractor(s), consultant, and employee are also subject to the conditions of this authorisation. This condition however does not exonerate the holder from its accountability and responsibility to ensure compliance with the conditions of this environmental authorisation.
- 5.1.5 Any changes to, or deviations from, and amendments to the proposed activities, conditions of this authorisation, and recommendations in the EIR/EMPR must be approved, in writing, by the Department before such changes, deviations or amendments are effected. The Department reserves the right to request the submission of information deemed necessary to assess and evaluate the significance and impacts of such changes, deviations and amendments before such changes, deviations and amendments are authorised or not. Any changes, deviations and amendments may be subject to the provisions of Chapter 5 of the EIA Regulations, 2014 pertaining to the amendments of the environmental authorisation and EMPR.
- 5.1.6 This environmental authorisation does not absolve the holder from complying with any other statutory obligations that may be applicable to the proposed activities.
- 5.1.7 The holder of this authorisation must apply for an amendment of this authorisation in the case of a change of ownership or transfer rights and obligation.

5.2 NOTIFICATION AND APPEAL OF AUTHORISATION

- 5.2.1 The holder must, in writing, within fourteen (14) days of the date of this authorisation, notify all registered interested and affected parties (I&APs) of the outcome of the application.
- 5.2.2 The notification contemplated above must, amongst other issues:
 - 5.2.2.1 Stipulate the date of the decision, and the date of issue of the environmental authorisation.
 - 5.2.2.2 Provide reasons for the decision, included in Appendix 1 of this environmental authorisation.

- 5.2.2.3 Inform registered I&APs of the appeals procedure provided for in terms of the National Environmental Management Act, 1998: National Appeals Regulations (GNR 993 of 08 December 2014).
- 5.2.2.4 Draw the attention of the I&APs to the manner in which they may access the decision, including obtaining the copy of the authorisation.

5.3 COMMENCEMENT OF THE ACTIVITY(S)

- 5.3.1 This authorisation will only be effective in the event that an application for exploration right is granted in terms of the Mineral and Petroleum Resources Development Act, 2002 (Act 28 of 2002). None of the activities listed in this EA and authorised activities may therefore commence without an exploration right.
- 5.3.2 The authorised activities shall not commence within 20 days of the date of this authorisation, pending potential lodgement of appeal(s).
- 5.3.3 Where an appeal is lodged against the decision by any party, the environmental authorisation or any provision or condition of the environmental authorisation will be suspended in accordance with section 43(7) of the National Environmental Management Act, 1998; and as such you may not commence with any activity, unless authorised in writing by the competent authority and/or the decision on the appeal has been taken.
- 5.3.4 A thirty (30) day written notice must be given to the Petroleum Agency SA prior to the commencement of any of the authorised exploration activities.
- 5.3.5 The authorised activities must commence within a period of 3 years from the date of issue of this authorisation. If commencement of the authorised activities does not occur within the said period, the authorisation lapses. Where the holder still intends undertaking the authorised activity(s), a new application for authorisation in terms of the EIA Regulations, 2014 must be obtained.
- 5.3.6 Any requests for extension of the commencement date of this authorisation should be lodged with the competent authority before the expiry of the environmental authorisation in accordance with amendments to Regulation 28 (1) of EIA Regulations, 2014.

5.4 MANAGEMENT, MONITORING AND AUDITING OF OPERATIONS INCLUDING REPORTING REQUIREMENTS

MANAGEMENT OF THE ACTIVITY

- 5.4.1 The Environmental Management Programme (EMPR) submitted with the Environmental Impact Assessment Report (EIR) is hereby approved. It is hence mandatory for the holder to implement all recommendations and management measures stipulated in the EMPR throughout all the phases of the proposed exploration activities.
- 5.4.2 Any non-compliance with the EMPR constitutes non-compliance with this environmental authorisation, and any non-compliance with this authorisation may result in its suspension and may render the holder guilty of an offence in terms of section 49A of NEMA and may, if convicted, be liable for penalties contemplated in section 49B (1) of NEMA.
- 5.4.3 Should there be changes in the operation and management of the authorised activities, the EMPR must be amended to accommodate those changes and submitted to the competent authority for approval before implementation takes place.
- 5.4.4 The holder of the authorisation must implement necessary measures to ensure that operators, contractors and subcontractors have full awareness of the recommendations on the EMPR before commencing with any authorised activity.
- 5.4.5 The EMPR must be included in all contractual documentation entered thereto between the holder and contractor(s).
- 5.4.6 A copy of the EMPR must be kept on site at all times.
- 5.4.7 The holder must, before the commencement of the authorised activities, appoint an independent and experienced Environmental Control Officer (ECO) who will ensure that the conditions of this authorisation and provisions of the EMPR are implemented and adhered to.
- 5.4.8 The holder of this authorisation must submit weekly and monthly environmental monitoring reports during drilling operations and any other planned invasive activities on site. Furthermore, the holder is required to submit an environmental audit report annually which must be carried out by an independent and qualified environmental assessment practitioner and such must evaluate compliance with the conditions of this EA and provisions of the EMPR, in line with Appendix 7 of the EIA Regulations, 2014.
- 5.4.9 The holder of this authorisation must keep all records relating to monitoring and auditing and make them available for inspection to any relevant and competent authority in respect of this development.

- 5.4.10 All documentation e.g. audit/monitoring/compliance and notifications, must be submitted to the designated Agency in terms of this authorisation.

5.5 SPECIFIC CONDITIONS

- 5.5.1 The holder of the EA or the appointed ECO must, within 30 days prior to the commencement of the authorised exploration activities, distribute notifications to all affected land owners informing them of the operational plans. The said notification must include amongst other issues the following:
- 5.5.1.1 Site establishment, commencement date, including duration of the proposed activities;
 - 5.5.1.2 Sketch plan showing the operational area(s);
 - 5.5.1.3 Details of the ECO; and
 - 5.5.1.4 Procedure to lodge complaints and any environmental issues arising from the operations.
- 5.5.2 The holder of the EA must ensure that any potential impact on the environment is avoided, minimized and prevented. In this regard, all mitigation measures specified in the EIR and EMPR aimed at protecting environmentally sensitive areas, surface and groundwater resources and surrounding communities during the undertaking of the proposed exploration activities must be implemented. Failure thereof may constitute non-compliance and an offence, and may result in the implementation of necessary enforcement measures provided for under the NEMA.
- 5.5.3 The holder of this authorisation must obtain land use and access agreements prior to the commencement of the proposed activities. Furthermore, in order to avoid conflict of interests with the current land-use activities, the applicant must consult on an ongoing basis with the affected surface landowners and keep them informed of the project development.
- 5.5.4 Contamination of soil, surface and groundwater shall be prevented at all times; in this regard, proper containment measures must be implemented onsite at all times. Furthermore, hazardous and general wastes materials must be disposed of at licensed landfill sites.
- 5.5.5 Surface and groundwater monitoring programmes submitted with the EIR must be implemented during and post exploration drilling operations.

- 5.5.6 Emergency incidents must be addressed and reported to the Petroleum Agency SA in accordance with section 30 of NEMA. In addition, the holder is required to notify the Petroleum Agency SA within 24 hours of the occurrence of an emergency incident.
- 5.5.7 Surface and groundwater, ecology, air quality and noise, wetlands and aquatic ecology and waste management programme must be implemented during and post exploration drilling operations.
- 5.5.8 The holder of the authorisation must annually assess the environmental liabilities of the operations and submit a financial provision review report in terms of the requirements of section 24P of NEMA and Regulations Pertaining to the Financial Provisions for Prospecting, Exploration, Mining or Production Operations (GN R 1147 of 20 November 2015).
- 5.5.9 The holder of this authorisation must undertake a formal wetland delineation within the proposed drilling locations in order to properly determine the boundaries of wetlands, channels and riparian areas prior to the commencement of drilling operations.
- 5.5.10 Drilling fluids and muds to be used must strictly be biodegradable and water-based. The holder is required to submit Material Safety Data Sheets for drilling fluids at least 60 days before drilling commences.
- 5.5.11 Wastewater produced during drilling operations must be stored in above ground storage containers or tanks, and must be disposed appropriately at completion of the drilling operations.
- 5.5.12 Sites with poor vegetation cover and disturbed by agricultural and mining activities shall be selected as target sites for drilling activities in order to minimize vegetation and habitat loss.
- 5.5.13 The finalization of drilling positions must be selected in conjunction and with the recommendations of a qualified Heritage Assessment Practitioner, Geohydrologist and Ecologist.
- 5.5.14 Buffer zones recommended in the EMPr for the protection of heritage sites, archeological sites and environmentally sensitive areas must be adhered to during drilling operations.
- 5.5.15 The holder is required to undertake progressive rehabilitation during operations. In this regard, plugging of boreholes must be done in accordance with the Regulations for Petroleum Exploration and Production, 2015.
- 5.5.16 All recommended mitigation measures included in the EIR/EMPr dated 30 January 2017 are deemed to be the conditions of the EA and must therefore be adhered to.

5.6 GENERAL

- 5.6.1 A copy of the EA and the EMPR must be kept onsite to ensure appropriate implementation of the mitigation measures.
- 5.6.2 The Department shall not be responsible for any damages or losses suffered by the holder in an instance where the operation is temporarily stopped for reasons of non-compliance with the conditions as set out herein.
- 5.6.3 In view of the above, and having taken into consideration environmental management principles as set out in section 2 of NEMA, and information presented in the EIR and EMPR, and subject to compliance with conditions of the EA and recommendations of the EMPR, the Department is satisfied that the proposed activities will not be in conflict with the objectives of the Integrated Environmental Management set out in Chapter 5 of NEMA and will not result in any detrimental risks to the environment and public. The EA is accordingly granted.

APPENDIX 1

REASONS FOR DECISION

1. Information considered in making the decision

All the information presented to the Petroleum Agency SA was taken into account in reaching the decision.

The information considered include amongst others -

- 1.1 The provisions of Chapter 5 of the NEMA which relates to the Integrated Environmental Management and section 2 NEMA principles, the EIA Regulations, 2014 and other relevant NEMA regulations and guidelines.
- 1.2 The Scoping report dated 15 August 2016.
- 1.3 The information contained in the EIR dated 30 January 2017.
- 1.4 The Environmental Management Programme (EMPR) submitted with the EIR.
- 1.5 The results of the Public Participation Process submitted with EIR dated 30 January 2017 which highlighted issues, objections and concerns raised by various I&APs and responses by the EAP.
- 1.6 Comments received from various State Departments i.e. Department of Rural Development and Land Reform, and Department of Water and Sanitation, and State Organs i.e. Transnet, Eskom, South African Heritage Resource Agency, and South African National Roads Agency Limited included in the EIR/EMPR dated 30 January 2017.
- 1.7 Specialist reports namely:
 - Ecology and Wetlands by David Hoare Consulting cc dated 01 November 2016;
 - Geohydrology by Exigo dated 31 October 2016; and
 - Heritage by Professional Grave Solution (Pty) Ltd dated 13 November 2016.

2. Submission and Consideration of the Scoping Report

In line with Regulation 21(1) of the EIA Regulations, 2014, the applicant submitted a scoping report within 44 days from the date of receipt of the application for environmental authorisation i.e. on the 15 August 2016. The scoping report was considered and evaluated in accordance with the requirements of Regulations 21 and 22, and appendix 2 of the EIA Regulations, 2014, and was duly accepted (with conditions) on the 22 September 2016 based on the following:

- 2.1 The scoping report was subjected to a public consultation process for a 30 days period and incorporated comments received from interested and affected parties, the competent authority

(Petroleum Agency SA in this regard), state departments administering laws relating matters affecting the environment and organs of states.

- 2.2 In addition, the public consultation process carried out adhered to the requirements of Regulations 41 and 44 of the EIA Regulations. In this regard, interested and affected parties were notified of the application through various means such as onsite notices, newspaper advertisements, and correspondences (letters/emails).
- 2.3 The scoping report contained information set out in Appendix 2 of the EIA Regulations and in this regard, relevant policies and legislation were identified; the need and desirability of the proposed project motivated and asserted, alternatives identified, environmental attributes associated with the proposed activity(s) identified and assessed, impacts and risks identified and assessed and suitable mitigation measures proposed; and key issues to be addressed in EIA phase identified.

3. Submission of the Environmental Impact Assessment Report (EIR) and Environmental Management Programme (EMPR)

3.1 Regulation 23(1) (a) and (b) requires the applicant to submit:

- (a) an environmental impact report (EIR) inclusive of any specialist reports, and an EMPR within 106 days, which must have been subjected to a public consultation process of at least 30 days and reflects incorporation of comments received;
- (b) a notification in writing that the EIR and an EMPR will be submitted within 156 of the acceptance of the scoping report by the competent authority.

3.2 The EIR, inclusive of specialist reports, and an EMPR were received by the Petroleum Agency SA within the prescribed submission date i.e. the 30 January 2017. The said reports were subjected to a public consultation process of 30 days and included comments received from interested and affected parties.

4. Consideration of the EIR and EMPr

Regulation 18 requires the competent authority to take into consideration section 24(O) and 24(4) of the Act when considering the application for EA, the need for desirability of undertaking the proposed activity, any guideline published in terms of section 24J of the Act. Regulation 23(3) further provides that the EIR must contain all information set out in Appendix 3 and must address the requirements as determined in the regulations pertaining to the financial provisions for rehabilitation, closure and post closure of

operations; and Regulation 23(4) requires the EMPR to contain all information set out in Appendix 4 of the EIA Regulations.

The EIR and EMPR were assessed taking into consideration the aforementioned requirements, and the key significant issues that resulted in the Department's decision are set out as follows:

- 4.1 In terms of the need and desirability of the project, where proposed exploration activities become successful, long term benefits would include promotion of access to other sources of energy, contribution to South Africa's energy needs and thus energy security.
- 4.2 The public consultation process undertaken by the EAP which includes notifying and registering interested and affected parties, advertising the proposed project, subjecting Scoping and EIR reports to a 30 day commenting period, consulting with various states departments and organs of states, and addressing comments received from all interested and affected parties was in line with the requirements of EIA Regulations, 2014 and related guidelines.
- 4.3 The Environmental Impact Assessment process as prescribed by the EIA Regulations, 2014 was adhered to by the EAP and this includes identification and assessment of the applicability of relevant legislation, guidelines and policies. The undertaken process is deemed satisfactory.
- 4.4 The environmental attributes associated with the proposed activities were clearly identified; and the potential impacts on biophysical, cultural/heritage and socio-economic environment were identified and assessed.
- 4.5 The mitigation measures to address all identified environmental impacts during all phases of the proposed exploration activities were recommended and aligned with identified impacts.
- 4.7 The profile and details of the EAP with respect to the qualifications and experience in environmental impact assessments and related projects has given confidence in the EAP's ability and competence to carry out the EIA process.
- 4.8 Three (3) alternatives were identified as follows:
 - a. Alternative 1: "No Go Alternative", which implies that no exploration activities will take place and that the environment remains unchanged and unaltered;
 - b. Alternative 2: "Maximum Exploration Extent", which places emphasis on exploration activities with less restrictive mitigation measures to be implemented to protect the environment, thus allowing for unrestricted exploration; and
 - c. Alternative 3: "Sensitivity Planning Approach", which put emphasis on protection of natural resources and use of stringent mitigation measures to minimise identified adverse impacts. The alternative in question will use sensitivity planning approach and thereby utilizes the consolidated

sensitivity map as a planning tool in order to avoid impacting on sensitive environmental features. This is a preferred and acceptable alternative for the proposed exploration activities.

- 4.9 The EIR dated 30 January 2017 identified all legislation and guidelines that have been considered in the preparation of the EIR.

5. Key Findings

Careful consideration of information and factors listed in sections 1 and 2 above have thus resulted in the following conclusions:

- 5.1 All fundamental and procedural requirements prescribed in the applicable legislation have been satisfied.
- 5.2 The identification and assessment of potential impacts of the activity, including cumulative impacts, was adequately undertaken, and the proposed mitigation and management measures are aligned with potential impacts. Furthermore, the majority of the potentials impacts associated with the planned exploration activities would be of low significance post mitigation. The impacts will be short term and localized.
- 5.3 The total footprint area of disturbance will be localized and on a small scale as only 0.27 ha of the total area of 149 377 ha will be disturbed.
- 5.4 The public consultation process undertaken by the EAP adhered to the minimum requirements as prescribed under Chapter 6 'Public Participation' of the EIA Regulations, 2014 and related guidelines. The following were the key findings:
 - 5.4.1 All objections and concerns related to the proposed activities were satisfactorily addressed by the EAP and in addition, mitigation measures to address all potential impacts have been included in the EMPR. It is thus our view that the EAP has complied with the requirements as outlined in Chapter 6 of the EIA Regulations, 2014.
 - 5.4.2 Objections and concerns related to future activities, i.e. the potential impact on water resources with respect to quality and quantity due to the use of hydraulic fracturing method and associated activities. The EAP tried to provide clarity that the application in question does not include unconventional exploration techniques but it is for conventional exploration to obtain core samples.
- 5.5 No deviations requested from certain requirements of Regulation 41 of Government Notice No. R. 982 were received by the Department.

5.6 The findings of the site visit:

- The site visit was undertaken on 21 April 2017 and it focused on the farms where potential drilling of exploration wells will be undertaken, including farm Nooitgedatch RE/245 where the first borehole will be drilled.
- The area targeted for drilling the first well is already disturbed by agricultural activities i.e. crop farming and lives stock grazing.

6. Conclusion

In view of the above, and having taken into consideration environmental management principles as set out in section 2 of NEMA, and information presented in the EIR and EMPR, and subject to compliance with conditions of the EA and recommendations of the EMPR, the Department is satisfied that the proposed activities will not be in conflict with the objectives of the Integrated Environmental Management set out in Chapter 5 of NEMA and will not result in any detrimental risks to the environment and public. The environmental authorisation is accordingly granted.
