# COMMENTS ON THE FINAL SCOPING REPORT (FSR) FOR THE PROPOSED 3000 MW GAS TO POWER PROJECT AT THE COEGA SPECIAL ECONOMIC ZONE (SEZ), EASTERN CAPE PROVINCE

The Directorate: Biodiversity Conservation has reviewed and evaluated the aforementioned report.

The proposed site lies at the South East part of Zone 13 of the Coega SEZ, which has been designated for industrial developments as well as power plants. The Dedisa peaking power plant and substation are situated close to the proposed site.

The Draft EIA Report must include the following as guidelines considered and ensure that the proposed project is in compliance with their requirements:

- All relevant provincial biodiversity plans; and specialist studies;
- NEMBA National List of Threatened Ecosystem that are threatened and in need of protection;
- Draft Species Environmental Assessment guideline;
- National Climate Change Adaptation Strategy Version UE10, 13 November 2019; and
- The site locality maps illustrating the ecological sensitivity, Open Space Management Plan (OSMP) and different alternatives.

In order to minimize the loss of biodiversity, the Draft EIA Report including the specialist studies must clearly describe how different stages of the mitigation hierarchy was applied.
