1. Welcome and apologies

- Cllr Mdlalose opened the meeting and welcomed all in attendance.
- A community member opened the meeting with prayer.

2. Purpose of Meeting

To obtain comments of meeting attendees and plan for community notification about the project

3. Discussions

3.1. Cllr Mdlalose presented the proposed project highlighting how there were plans in 2009 concerning the construction of a reservoir but this did not go ahead. He added that the reservoir area was inspected and found to be suitable and the project will now go ahead and will include pipes. He highlighted the









importance of community members not fighting with project team members to ensure the success of the project.

- 3.2. Zanele Mthembu introduced herself and the project team members from KDCM, Terratest and GroundAfrica
- 3.3. Bongi Manatha also repeated the roles of the project Team Members. She highlighted the importance of the community members providing correct information for household members to ensure that water is sufficient for everyone. She asked the community members to assist the project team with the identification of sensitive areas such as graves
- 3.4. Cllr Mdlalose stated that the project will take about 3 years to complete. Added the following;
 - 3.4.1. importance of community members pointing out graves to project team members;
 - 3.4.2.even if pipe will run through field, the width of the trench will not exceed that of a car and the presence of a pipe does not mean that a field will be unusable.
 - 3.4.3. Community members whose fields will have a pipe running through them are urged to not ask for compensation as the project will be for the benefit of the overall community
 - 3.4.4.questions about appointments of labourers must be held off until further notice
 - 3.4.5.all attendees to complete the circulating attendance registers to ensure that they are notified of project developments
- 3.5. Mr Buja thanked the Cllr and Project Team members for their attendance. Asked for the community to avoid complaints about the project as it will benefit even future generations. Highlighted the importance of community members not disturbing the work of the project team as the team's aim is to help the community
