Wetteloosheid en vandalisme is kommerwekkend

GEMSBOK-UPINGTON: Die regering het sy kommer uitgespreek oor die vandalisering en afbrand van Clicks-winkels regoor die land en gesê dat dit teenstrydig is met die gees van vrede en respek vir menseregte.



Die regering het Maandag in 'n verklaring gesê dat die openbare verontwaardiging erken word na die Clicks-advertensie, waar 'swart hare' as "droog en beskuldig" uitgebeeld word.

Die regering het gesê hoewel dit ewe verontreg word deur die kru rassistiese uitbeelding deur die betrokke advertensie, is hierdie daede van wetteloosheid, insluitend vandalisme en die afbrand van Clicks-winkels, Maandag kommerwekkend.

Daar word gesê dat dit teenstrydig is met "die

gees van vrede en respek vir menseregte wat hierdie land sedert die aanbreek van demokrasie gevorm het".

Die regering het hom ook uitgespreek teen wettelose gedrag en gesê dat hierdie soort gedrag nie die verantwoordelike manier is om konflik op te los nie.



Niemand plak binne die Valke gebou

Daar is vrye toegang tot die perseel wat deur die SAPD se Valke beset word, daarom gebruik lede van die publiek die perseel as ablusie gerief of oornagfasiliteite vir haweloses.

GEMSBOK-UPINGTON: Na aanleiding van die berig oor die "plakkers" wat hulle op die perseel wat tans deur die SAPD se Valke beset word, het die Gembok verder met verskeie ingeligtes gepraat.

Dit het aan die lig gekom dat die plakkers nooit binne die gebou kan of mag slaap nie, maar wel van die res van die perseel gebruik maak.

Ook het dit aan die lig gekom dat verskeie lede van die publiek die perseel gebruik as ablusie gerief, aangesien die naaste publieke ablusieblok heeltemal te ver van plekke soos die poskantoor en arbeidskantore is, waar daar daaglik lang toue mense staan.

Dit blyk dat die gebrek aan genoeglike veiligheidsmaatsreels soos veiligheidsheiningens ens van hierdie perseel, wat tans in die besit van departement openbare werke is, 'n oop uitnodiging is vir enige persoon wat die perseel wil betree, hetsy om as ablusie gerief of selfs as oornagfasiliteite te gebruik.

"Ek is die een wat Sondae vir hierdie mense kerk hou en sorg dat hulle iets ordentlik te ete kry. Ek sal nie daarmee ophou nie, dit is tuss-

sen my, my God en die haweloses. Enige persoon is welkom om met my hieroor te kom praat. Ek doen dit nie as polisieman nie, maar as christen. Ons is maar net 'n handjievol wat dit doen, terwyl die res van die dorp oor hul neuse kyk na die wat hulp nodig het," het kol De Witt Botha die afgelope week aan die Gembok gesê. Intussen is die Gembok besig met 'n ondersoek na die toename in haweloses, straatkinders en die verskeie rolspeleers wat hierdie kwesbare groepe in die steek laat.



Ook op Upington moes die SAPD ingryp toe woedende politiese betogers die kettingwinkel bestorm het as deel van die landswye onluste.

Motorinbrekers binne ure vasgetrek

GEMSBOK-UPINGTON: Lede van die ZF Mgcawu District Covid-19-operasiespan het twee mans in hegtenis geneem weens diefstal uit motorvoertuie.

Volgens 'n polisie woordvoerder het dit gevolg nadat 'n klagte ontvang is van 'n vermeende diefstal van meer as R11 000 uit 'n voertuig deur twee mans in 'n rooi Ford Fiesta by die winkelsentrum.

Die polisie het onmiddellik 'n grootskaalse soektog begin en die voertuig is later in Kathu opgemerk, waar die twee verdagtes van 30 en 46 jaar in hegtenis geneem is.

Hulle het daarin geslaag om die kontant en selfone wat vasgelê is, vir verdere ondersoek te verhaal.

"AO Van Dyk van die Upington SAPD was my eerste kontak toe ek by stasie kom. Die lede het onmiddellik opgetree, alvorens ek my volle verklaring kon afgee en die saak nommer nog beskikbaar was.

Mnr Links van die radiobeheer het kontak met AO Reed gemaak en die het binne enkele minute die kamera bewys gaan deur kyk by die mall. AO Reed het op uitstaande kenmerke op voertuig en verdagtes opgemerk en onmiddellik het hulle opgetree en die ander SAPD takke by Olifantshoek en Kathu in kennis gestel om op die uitkyk te wees vir die spesifieke voertuig. Sersant Mqaisa was op bystand en het opgevolg en toe die voertuig



gekry met die verdagtes. Ek wil net dankie sê aan ons SAPD lede wie so spoedig opgetree het en my innige dankbaarheid betoon. Nooit kon ek my ore glo toe ek hoor die verdagtes is in skaars drie ure na die misdaad gepleeg is, in 'n ander dorp vasgekeer nie.
