**Project Proposal: EAGLE MINES PTY LTD** has lodged a Prospecting Right and Environmental Authorisation application to the Department of Mineral Resources and Energy (DMRE) to prospect with bulk sampling for Gold Ore and Uranium Ore, on Farm Rietvallei 130 IQ; situated in the magisterial district of Ventersdorp. in terms of Section 16 and 20 of the Mineral and Petroleum Resource Development Act, 28 of 2002 (MPRDA). WTP Environmental Consultants (Pty) Ltd was appointed as the Environmental Assessment Practitioners (EAP) to conduct the Environmental Impact Assessment (EIA) process.

**Location:** The applicant intends to prospect on the Farm Rietvallei 130 IQ, situated in the magisterial district of Ventersdorp, North West Province.

**Application for Environmental Authorization: Eagle Mines (Pty) Ltd** is required to obtain Environmental Authorization (EA) in support of its prospecting right and has accordingly submitted an application an Environmental Authorization to the DMRE accepted on the 14<sup>th</sup> November 2022. The proposed activities will require environmental authorization in terms of the Environmental Impact Assessment (EIA) Regulations (GN No. R324, R325, R326, R327 as amended on 07 April 2017) of the National Environmental Management Act (NEMA) (No. 107 of 1998) as amended. The proposed prospecting activities triggers Activity 19 of Listing Notice 2 (GN R 325) and based on the triggered activities, the application will be subject to a Scoping Report and EIR (Full EIA).

**Opportunity to participate:** Chapter 6 of NEMA requires that a full and transparent Public Participation Process (PPP) must be conducted for any listed activities. An initial Background Information Document provides a summary of the proposed project and EIA process and is available on request from the appointed EAP (Contact Details below)- please contact us in order to receive the document.

Interested and Affected Parties (IAPs) are invited to register and/or provide written comments. All comments should be submitted together with their name, contact details (preferred method of communication e.g email) and an indication of any direct business, financial, personal or other interest that they may have in the application to the contact person indicated below. Once registered IAPs will be informed of further opportunities to comment on the Scoping Report.
