AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 02 FEBRUARY 2015 FOR THE PROPOSED CONSTRUCTION OF THE MOOKODI-GANYESA 132kV POWER LINE, NEW PROPOSED GANYESA SUBSTATION AND HAVELOCK LILO, NORTH WEST PROVINCE

The Environmental Authorisation (EA) issued for the above application by this Department on 02 February 2015 and your application for amendment to the EA received by this Department on 16 May 2017 refer.

The applicant applied for the amendment of the coordinates of the proposed substation, which due to the consultation and negotiations with the relevant landowner, resulted in the need for the substation to be located closer to the road. In addition, the applicant applied to change the holder of the EA as the initial holder of the EA is no longer the Eskom representative associated with the project.

This letter must be read in conjunction with the EA dated 02 February 2015.

In terms of Regulation 4(2) of the Environmental Impact Assessment Regulations, 2014 (the Regulations), you are instructed to notify all registered interested and affected parties, in writing and within 14 (fourteen) days of the date of the EA, of the Department's decision in respect of your application as well as the fact that an appeal may be lodged against the decision in terms of the National Appeals Regulations, and the provisions regarding the submission of appeals as contained in the Regulations.

Should any person wish to lodge an appeal against this decision, he/she must submit the appeal to the appeal administrator, and a copy of the appeal to the applicant, any registered interested and affected party, and any organ of state with interest in the matter within 20 days from the date that the notification of the decision was sent to the registered interested and affected parties by the applicant; or the date that the notification of the decision was sent to the applicant by the Department, whichever is applicable.
