AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 08 MAY 2015 FOR THE PROPOSED CONSTRUCTION OF THE CASTLE WIND ENERGY FACILITY NEAR DE AAR IN THE EMTHANJENI LOCAL MUNICIPALITY, NORTHERN CAPE PROVINCE.

The Environmental Authorisation (EA) dated 08 May 2015 for the abovementioned project and your application for amendment to the EA received by this Department on 09 February 2018 refer.

Based on a review of the reason for requesting an amendment to the above EA, this Department in terms of Chapter 5 of the Environmental Impact Assessment Regulations, 2014, has decided to grant an extension of the validity period of your authorisation for an additional five (5) years.


The activity must commence within a period of five (5) years from the date of expiry of the EA issued on 08 May 2015, as amended, (i.e commence by 08 May 2023). If commencement of the activity does not occur within that period, the authorisation lapses and a new application for environmental authorisation must be made in order for the activity to be undertaken.
