AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 05 OCTOBER 2015 FOR THE CONSTRUCTION OF THE 132KV OVERHEAD POWER LINE FROM THE PROPOSED CASTLE WIND ENERGY FACILITY TO THE HYDRA SUBSTATION NEAR DE AAR IN THE NORTHERN CAPE PROVINCE

The Environmental Authorisation (EA) issued for the abovementioned application by this Department on 05 October 2015, your application for amendment of the EA received by the Department on 24 July 2020 and the acknowledgement letter dated 31 July 2020, refer.

Based on a review of the reason for requesting an amendment to the above EA, this Department in terms of Chapter 5 of the Environmental Impact Assessment Regulations, 2014 as amended, has decided to amend the EA dated 05 October 2015, as follows:

Amendment 1: Amendment to Conditions 6 and 7 of the EA related to the validity of the EA:

The activity must commence within a period of five (05) years from the date of expiry of the EA issued on 05 October 2015 (i.e. the EA lapses on 05 October 2025). If commencement of the activity does not occur within this period, the authorisation lapses and a new application for environmental authorisation must be made in order for the activity to be undertaken.

The applicant applied to extend the validity period of the EA as the development was not awarded preferred bidder status in the Department of Mineral Resources and Energy's Renewable Energy Independent Power Producer Procurement (REIPPP) Programme. The applicant intends to bid this project in the DoE REIPPP future rounds.

The Department is aware that the environment changes constantly, as a result it might be significantly different from the one that existed at the time of the issuing of this EA, hence the validity of the EA cannot exceed a maximum period of 10 years. Failure to commence with construction activities within the maximum 10 year period, your EA will be deemed to have lapsed and a new application for Environmental Authorisation will have to be lodged.

This proposed amendment letter must be read in conjunction with the EA dated 05 October 2015, as amended. In terms of the Promotion of Administrative Justice Act, 2000 (Act No 3 of 2000), you are entitled to the right to fair, lawful and reasonable administrative action; and to written reasons for administrative action that affects you negatively. Further your attention is drawn to the provisions of the Protection of Personal Information Act, 2013 (Act no. 4 of 2013) which stipulates that the Department should conduct itself in a responsible manner when collecting, processing, storing and sharing an individual or another entity's personal information by holding the Department accountable should the Department abuses or compromises your personal information in any way.

In terms of Regulation 4(2) of the Environmental Impact Assessment Regulations, 2014, as amended (the EIA Regulations), you are instructed to notify all registered interested and affected parties, in writing and within 14 (fourteen) days of the date of the EA, of the Department's as well as the provisions regarding the submission of appeals that are contained in the Regulations.

Your attention is drawn to Chapter 2 of National Environmental Management Act, 1998 (Act No. 107 of 1998) National Appeal Regulations published under Government Notice R993 in Government Gazette No. 38303 dated 08 December 2014 (National Appeal Regulations, 2014), which prescribe the appeal procedure to be followed. Kindly include a copy of this document (National Appeal Regulations, 2014) with the letter of notification to interested and affected parties in this matter.
