Proposal: Robben Island Museum proposes the restoration and maintenance of the Robben Island Blue Stone Quarry (BSQ) wall and limestone pathway that runs along the top of the wall. Robben Island Museum aim to maintain the historical integrity of the BSQ wall and thus, will be reconstructing the breached section and other damaged areas by recycling debris from the collapsed wall. New material will be added to strengthen the wall. No concrete or heavy machinery will be used as part of the reconstruction. The reinstatement of the wall will be restoring the quarry environment to its original state and will ensure the future protection of the quarry and its associated heritage value.

Location: The proposed site is situated on Farm Robben Island 432 and 1436, Robben Island, Western Cape Province.

Because this development involves the maintenance of the Blue Stone Quarry Wall, it requires a Maintenance Management Plan to be approved in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA). - iii. the sea; —

but excluding where such infilling, depositing, dredging, excavation, removal or moving—

- (a) is for maintenance purposes undertaken in accordance with a maintenance management plan
