### APPROVAL OF THE AMENDED ENVIRONMENTAL MANAGEMENT PROGRAMME TO COMPLY WITH CONDITION 15 OF THE ENVIRONMENTAL AUTHORISATION DATED 02 JULY 2019 FOR THE DEVELOPMENT OF THE 100MW LICHTENBURG 2 PHOTOVOLTAIC SOLAR ENERGY FACILITY AND ASSOCIATED INFRASTRUCTURE NEAR LICHTENBURG, WITHIN THE DITSBOTLA LOCAL MUNICIPALITY, NORTH WEST PROVINCE
