AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 13 SEPTEMBER 2021 FOR THE ANGLO AFRICAN METALS ZERO WASTE RECOVERY SOLUTION AND ASSOCIATED INFRASTRUCTURE NEAR KWA-GUQA IN THE EMALAHLENI MUNICIPALITY WITHIN NKANGALA DISTRICT MUNICIPALITY, MPUMALANGA PROVINCE

The Environmental Authorisation (EA) issued for the abovementioned application by this Department on 13 September 2021, your application for amendment of the EA received by the Department on 25 May 2022 and the acknowledgement letter dated 25 May 2022, refer.

Based on a review of the reason for requesting an amendment to the above EA, this Department, in terms of Chapter 5 of the Environmental Impact Assessment Regulations, 2014 as amended, has decided to amend the EA dated 13 September 2021 as follows:

Amendment 1: Correction of the throughput capacity of the plant (Page 3 of the EA)

From:

"The plant will be developed to process 2000 tonnes of tailings/slag per month, approximately 3 tons per day"

To:

"The plant will be developed to process 2000 tonnes of tailings/slag per month, approximately 3 tons per hour"

Reason for the amendment:

As indicated on Page 5 of the Integrated Environmental Authorisation (EA) and Waste Management Licence (WML), the processing capacity of the plant is 2000 tons of tailings/slag per month, 3 tons per hour, 72 tons per day x 28 days x 12 months. The description in the listed activities on page 3 therefore needs to be corrected to reflect the correct throughput capacity as 3 tons per hour.

This amendment letter must be read in conjunction with the EA dated 13 September 2021.

In terms of the Promotion of Administrative Justice Act, 2000 (Act No 3 of 2000), you are entitled to the right to fair, lawful and reasonable administrative action; and to written reasons for administrative action that affects you negatively. Further your attention is drawn to the provisions of the Protection of Personal Information Act, 2013 (Act no. 4 of 2013) which stipulate that the Department should conduct itself in a responsible manner when collecting, processing, storing and sharing an individual or another entity's personal information by holding the Department accountable should the Department abuse or compromise your personal information in any way.

In terms of Regulation 4(2) of the Environmental Impact Assessment Regulations, 2014, as amended (the EIA Regulations), you are instructed to notify all registered interested and affected parties, in writing and within 14 (fourteen) days of the date of the EA, of the Department's as well as the provisions regarding the submission of appeals that are contained in the Regulations.

Your attention is drawn to Chapter 2 of National Environmental Management Act, 1998 (Act No. 107 of 1998) National Appeal Regulations published under Government Notice R993 in Government Gazette No. 38303 dated 08 December 2014 (National Appeal Regulations, 2014), which prescribes the appeal procedure to be followed. Kindly include a copy of this document (National Appeal Regulations, 2014) with the letter of notification to interested and affected parties in this matter.

Should any person wish to lodge an appeal against this decision, he/she must submit the appeal to the appeal administrator, and a copy of the appeal to the applicant, any registered interested and affected party, and any organ of state with interest in the matter within 20 days from the date that the notification of the decision was sent to the registered interested and affected parties by the applicant; or the date that the notification of the decision was sent to the applicant by the Department, whichever is applicable.


