# SOCIAL STATEMENT PART II AMENDMENT APPLICATION BRANDVALLEY ENERGY FACILITY NOVEMBER 2021

### 1. INTRODUCTION AND BACKGROUND TO REPORT

Brandvalley Wind Farm (Pty) Ltd (the applicant), a subsidiary of G7 Renewable Energies (Pty) Ltd (G7), has been authorised to develop a 140 megawatt (MW) wind energy facility (WEF) (DEA reference number 14/12/16/3/3/2/900) near Laingsburg, on the border of the Northern Cape Province and the Western Cape Province in South Africa. The authorised WEF is located in the Karoo Hoogland, the Witzenberg (Ceres) and the Laingsburg Local Municipalities, which fall within the Namakwa, the Cape Winelands and the Central Karoo District Municipalities, respectively.

EOH Coastal and Environmental Services were appointed by Brandvalley Wind Farm (Pty) Ltd to undertake and manage the Environmental Impact Assessment (EIA) process for the authorised WEF. Tony Barbour was appointed by EOH Coastal and Environmental Services to undertake the specialist Social Impact Assessment (SIA) to inform the EIA process which was concluded in July 2016. The findings of the SIA for the Brandvalley WEF are contained in the SIA Report submitted to EOH Coastal and Environmental Services in July 2016.

Brandvalley Wind Farm (Pty) Ltd received Environmental Authorisation on 23 November 2016 (Reference No. 14/12/16/3/3/2/900) for the construction of up to 58 wind turbines, with a hub height of 120 m and rotor diameter of 140 m.

Subsequently, Terramanzi Group (Pty) Ltd was appointed by G7 Renewable Energies in 2018 to undertake a Part 2 Substantive Amendment Application for the 140MW Brandvalley Wind Energy Facility. The Part 2 Amendment Application sought to authorise the following:

- Increase hub height to 125m.
- Increase rotor diameter to 160m.
- Increase capacity of each turbine to up to 5.5MW.

A Social Assessment Statement was prepared by Tony Barbour as part of the Part II Amendment (July 2018).

Subsequent to the above, WSP have been appointed by to manage a Part II Amendment application process to address changes in the wind turbine specifications and a reduction in the number of wind turbines proposed.

### 2. PROJECT DESCRIPTION

Brandvalley Wind Farm (Pty) Ltd intend to follow a Part II Amendment Application process due to the change of scope of the existing authorisation for the Brandvalley WEF (Reference No. (Reference No. 14/12/16/3/3/2/900), which was for a total of up to 58 turbines with a maximum generation capacity of 140 MW. Each turbine was authorised for rotor diameter (RD) of up to 140 m, hub height (HH) of up to 120 m.

The proposed amendments are aimed at improving the efficiency of the Brandvalley WEF and involve the following changes:

- A reduction in the number of wind turbines from 58 to 34.
- Increase in turbine hub height from 120m to 125 m.
- Increase in rotor diameter from 140 m to 180 m.
- Increase capacity of each turbine to up to 7MW.

The only material changes to the authorised Rietkloof WEF (Reference No. 14/12/16/3/3/2/900) therefore involve a reduction in the number of wind turbines from 58 to 25, changes in hub height and rotor diameter. The location of the turbines remains

the same as the components assessed by the SIA undertaken in 2016 as part of the EIA process managed by EOH Coastal and Environmental Services.

### 3. APPROACH TO PREPARING SOCIAL STATEMENT

As of February 2021, there are no sensitivity layers on the DEFF Screening Tool for Socio-economic- features, therefore this report is not compliant with the Assessment Protocols published on 20 March 2020, in Government Gazette 43110, GN 320. This specifically includes Part A, which provides the Site Sensitivity Verification Requirements where a Specialist Assessment is required but no Specific Assessment Protocol has been prescribed. Part A has therefore not been compiled for this assessment.

The Social Statement comments on the implications of the proposed changes to the authorised Brandvalley WEF. The approach to preparing the Social Statement is based on the Western Cape Department of Environmental Affairs and Development Planning Guidelines for Social Impact Assessment (DEADP, 2007). These guidelines are based on international best practice. The approach to preparing the Social Statement included:

- A review of the findings of the SIA undertaken in 2016 (Barbour and van der Merwe, 2016).
- Review of Social Impact Assessment Addendum prepared in 2018 (Barbour and van der Merwe 2018).

The Addendum prepared in 2018 included a review of relevant policy and land use planning documents to ensure that the most recent documents were referred to in the amendment application. The following documents were reviewed.

- Laingsburg Municipality Integrated Development Plan (IDP) (2017/18 Review).
- Laingsburg Municipality Spatial Development Framework (SDF) (2017).
- Central Karoo District Municipality Spatial Development Framework (2013).
- District Growth and Development Strategy (2007 2022).
- Karoo Hoogland Local Municipality Integrated Development Plan (2017-2022).
- Witzenberg Municipality Integrated Development Plan (2017-2022).

### 4. ASSUMPTIONS AND LIMITATIONS

### 4.1 Assumptions

## Findings of SIA (2016)

Assumed that the key findings of the SIA undertaken in 2016 remain valid.

### Social Impact Assessment Addendum (2018)

Assumed that the findings of SIA Addendum prepared in 2018 remain valid.

### Socio-economic baseline data

The Social Impact Assessment Addendum prepared in 2018 included a review of the baseline socio-economic data and key policy and planning documents (see above). This information remains relevant to the 2021 Part II Amendment.

### 4.2 Limitations

### Limitations

Based on the experience of the consultant, there are no limitations that have a material bearing on the preparation of the Social Statement.

### 5. SPECIALIST DETAILS

Tony Barbour is an independent specialist with 28 years' experience in the field of environmental management. In terms of SIA experience Tony Barbour has undertaken in the region of 260 SIAs and is the author of the Guidelines for Social Impact Assessments for EIA's adopted by the Department of Environmental Affairs and Development Planning (DEA&DP) in the Western Cape in 2007. Annexure A contains a copy of Mr Barbour's CV.

### 6. DECLARATION OF INDEPENDENCE

This confirms that Tony Barbour, the specialist consultant responsible for undertaking the study and preparing the Social Statement, is independent and does not have any vested or financial interests in the proposed WEF being either approved or rejected. A signed declaration is contained in Annexure B.

### 7. SOCIAL STATEMENT

The proposed amendments to the Brandvalley WEF are aimed at improving the efficiency and involve:

- A reduction in the number of wind turbines from 58 to 34.
- Increase in turbine hub height from 120m to 125 m.
- Increase in rotor diameter from 140 m to 180 m.
- Increase capacity of each turbine to up to 7MW.

Based on a review of changes associated with the Part II Amendment there are no changes to the significance ratings reflected in the Brandvalley WEF SIA (2016). In this regard the:

- The reduction on the number of wind turbines from 58 to 34 and the increase in hub height and rotor diameter of the wind turbines associated with the Part II Amendment will not change the nature or significance of any of the social impacts previously assessed as part of the SIA (2016) for the Brandvalley WEF.
- The mitigation measures for the construction of the Brandvalley WEF listed in the SIA (2016) are appropriate for Part II Amendment. No additional management outcomes or mitigation measures in terms of social impacts are therefore required.

The Part II Amendment of the Brandvalley WEF, is therefore supported.
