1. Welcome and Purpose of Meeting

Mpungose Tribal Authority meeting Chairperson opened the floor to the project team

2. Purpose of Meeting and Discussions

- 2.1. Cllr M Dludla discussed the project as involving a pipeline and a new reservoir at Mpehlela and asked for the permission of the Mpungose Tribal Authority for the project to proceed
- 2.2. Zanele Mthembu introduced herself as an ISD consultant and requested for permission for the project to be undertaken. She further stated the following:
 - 2.2.1.under their scope of work, there will be door-to-door visits within the community to obtain the number or people within the community and to the project will cater for them
 - 2.2.2.under the environmental scope, there will be an investigation of environmental aspects such as plants
 - 2.2.3.under the Geotechnical scope there will be an investigation of the soil conditions

Note- All proceeding were undertaking in isiZulu and translations were undertaken by EAP

- 2.3. Mpungose Tribal Authority meeting Chairperson asked when the studies will begin. Zanele responded by stating that the work will be taking place even on the day of the meeting and it would be appreciated if public meetings could be arranged by relevant community leaders
- 2.4. Mpungose Tribal Authority meeting Chairperson asked how the populations counts will be undertaken as it will be a time-consuming exercise as the KDCM may have records. He added that himself and the Cllr have made efforts to count the population. He enquired if maps cannot be used as it seems that the work will be undertaken randomly and there may be problems encountered
- 2.5. Zanele Mthembu clarified that the counting will be undertaken on a sampling basis and that aerial images will also be used to aid with the exercise
- 2.6. The attendees agreed that the proposed project would need to be presented in public meetings on Sunday 19th of June and these can be undertaken for Ward 9 and 10 with the first meeting at 09:00 and the next at about 11:00.
- 2.7. In response to a question by one of the about the Mpungose Tribal Authority members concerning the areas where sampling will take place, Cllr M Dludla stated that the pipes will supply the KwaHlokohloko area and that all people living in areas where the pipe will run will benefit from the project
- 2.8. One of the about the Mpungose Tribal Authority members stated that there have previously been disagreements between specialists and community members concerning the pipeline route and this issue will need to be resolved.
