We would like to take this opportunity to inform you that the Final Environmental Impact Assessment Reports (FEIArs) for the above-mentioned proposed projects were received by the Department of Environment, Forestry and Fisheries (DEFF) for consideration and decision making on the **13**th of February **2020**.

After reviewing the documentation, the DEFF has issued Environmental Authorisations (EAs), in terms of the National Environmental Management Act, 1998 (Act 107 of 1998) (NEMA) and Environmental Impact Assessment (EIA) Regulations 2014 (as amended), for the three (3) above-mentioned proposed projects respectively.

The EAs were dated **08 June 2020**, however, they were only issued by the DEFF on **15 June 2020**. The reasons for the decisions are detailed in Annexure 1 'Annexure 1: Reasons for Decision' of the respective EAs, which are attached to this letter.

Your attention is drawn to Chapter 2 of the NEMA National Appeal Regulations published under Government Notice R993 in Government Gazette No. 38303 dated 8 December 2014 (National Appeal Regulations, 2014), which prescribes the appeal procedure to be followed. Should any person wish to lodge an appeal against these decisions, he/she must submit the appeal to the appeal administrator, and a copy of the appeal to the holder of the EA, any registered interested and affected party, and any organ of state with interest in the matter within twenty (20) days from the date that the notification of the decisions was sent to the registered interested and affected parties by the applicant (i.e. within 20 days from 18 June 2020).
