Amendment of the page number on the cover page

- 1. The page number is hereby amended

 - "3.3.8 [No Cement batching on site] Cement batching to be conducted well above the 1:100 year flood line or outside the horizontal distance of 100 meters from any watercourse"

 - a. by the substitution for Appendix III for the following: Appendix IV

Amendment of the condition 5 of Appendix IV

- 7. Condition 5 of the licence is hereby amended
 - a. by the substitution in condition 5.2 of the following condition:
 - "5.2 Stormwater shall be diverted from the [mine complex] operation site and roads and shall be managed in such a manner as to disperse runoff and concentrating the storm-water flow"

Amendment of the condition 10 of Appendix IV

- 8. Condition 10 of the licence is hereby amended
 - a. by the substitution in condition 10.1.2 of the following condition:
 - "10.1.2 Contains the [mine] operations water management and water loss strategies and programs"

Amendment of the condition 10 of Appendix IV

- 9. Condition 10 of the licence is hereby amended
 - a. by the substitution in condition 10.1.3 of the following condition:
 - "10.1.3 Sets annual targets for improved water use efficiency for the [mining activity] power generation activities, beneficiation and waste disposal practices and stipulates which measures will be implemented to achieve the targets on the [mines] operation site"

Amendment of the condition 11 of Appendix IV

10. Condition 11 of the licence is hereby amended-

"11.1 Water samples must be taken from all the monitoring boreholes by using approved sampling techniques and adhering to recognised sampling procedures. Samples should be analysed for both organic as well as inorganic pollutants, as [mining activity] power generation activities often lead to hydrocarbon spills in the form of diesel and oil. At least the water quality parameters on Table 4 should be analysed"
