For the project: Identity, Ritual and Potency Exploring personhood and identity marking in the San rock paintings of the Drakensberg, South Africa

The objective of the permit is to sample pigment at rock art site number: 2929CC 038, only ,2mm will be taken per sample, this is so small, the amount is hardly discernable by the human eye. This will be done to uncover whether the recipes/ingredient for the paint is similar in the same region or not; as well as to endeavor to reconstruct pigment or material trade routes linked to the production of pigments.

The site are also going to be dated by C14-method.

This research is of rare value since it combines both quantitative and qualitative research.

The application was considered by the Provincial Heritage Authority, the KwaZulu-Natal Amafa and Research Institute on 4 October 2021. The documents submitted in support of the application were reviewed.

The committee resolved not to object to the research and pigment sampling and dating
