AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 19 NOVEMBER 2018 FOR THE 75MW GEMSBOK PV5 SOLAR ENERGY FACILITY AND ITS ASSOCIATED INFRASTRUCTURE ON THE REMAINING EXTENT OF PORTION 8 (ROOIDAM) (A PORTION OF PORTION 3) OF THE FARM GEMSBOK BULT FARM NO. 120 AND THE REMAINING EXTENT OF PORTION 3 (ROOIDAM) OF THE FARM GEMSBOK BULT NO. 120 NEAR KENHARDT WITHIN THE KHEIS LOCAL MUNICIPALITY IN THE NORTHERN CAPE PROVINCE

## Reason for amendment:


The applicant applied for amendment of the farm property reference name with the change of the SG Code to align with the Title Deed, and for the EA to reflect the property details as per the Title Deed.

This amendment letter must be read in conjunction with the EA dated 19 November 2018, as amended.

In terms of the Promotion of Administrative Justice Act, 2000 (Act No 3 of 2000), you are entitled to the right to fair, lawful and reasonable administrative action; and to written reasons for administrative action that affects you negatively. Further your attention is drawn to the provisions of the Protection of Personal Information Act, 2013 (Act no. 4 of 2013) which stipulate that the Department should conduct itself in a responsible manner when collecting, processing, storing and sharing an individual or another entity's personal information by holding the Department accountable should the Department abuse or compromise your personal information in any way.

In terms of Regulation 4(2) of the Environmental Impact Assessment Regulations, 2014, as amended (the EIA Regulations), you are instructed to notify all registered interested and affected parties, in writing and within 14 (fourteen) days of the date of the EA, of the Department's as well as the provisions regarding the submission of appeals that are contained in the Regulations.

Your attention is drawn to Chapter 2 of National Environmental Management Act, 1998 (Act No. 107 of 1998) National Appeal Regulations published under Government Notice R993 in Government Gazette No. 38303 dated 08 December 2014 (National Appeal Regulations, 2014), which prescribes the appeal procedure to be followed. Kindly include a copy of this document (National Appeal Regulations, 2014) with the letter of notification to interested and affected parties in this matter.

Should any person wish to lodge an appeal against this decision, he/she must submit the appeal to the appeal administrator, and a copy of the appeal to the applicant, any registered interested and affected party, and any organ of state with interest in the matter within 20 days from the date that the notification of the decision was sent to the registered interested and affected parties by the applicant; or the date that the notification of the decision was sent to the applicant by the Department, whichever is applicable.
