COMMENT ON THE DRAFT SCOPING REPORT AND ENVIRONMENTAL AND SOCIAL IMPACT ASSESSMENT FOR THE PROPOSED BOTSWANA-SOUTH AFRICA (BOSA) TRANSMISSION INTERCONNECTION PROJECT

Our letters dated 02 February 2016 on the Notice of EIA for the proposed development have reference.

1. The mandate of the Department of Agriculture, Forestry and Fisheries (DAFF) as an Environmental Impact Assessment (EIA) commenting authority, is mainly to ensure control over development affecting natural forests, protected woodlands and listed protected tree under the National Forests Act, 1998 (Act No. 84 of 1998).
2. The vegetation description on page 11 in the Aquatic and Terrestrial Ecological Assessment and page 15 in the Birds Impact Assessment Report refer to the Vegetation map publication of Mucina and Rutherford (2006) and vegetation occurring are Dwaalboom Thornveld, Madikwe Dolomite Bushveld, Zeerust

Thornveld, Dwarsberg –Swartruggens Mountain Bushveld, Klerkdorp Thornveld, and Mafikeng Bushveld. These veld types are least threatened except for Mafikeng which is vulnerable.

3. Tree species protected under the National Forests Act of 1998 will be affected by the proposed activities such as *Vachelia erioloba*, *Combretum imberbe*, *Sclerocarya birrea* and *Boscia albitrunca*. Application has to be made to Department of Agriculture, Forestry and Fisheries (DAFF) for the removal of such species under Section 15 of the National Forests Act. Information required with the licence application is a number of matured protected trees species and the veld type to be affected by the proposed activities.
4. Once information on the tree species, their number and habitats affected has been received with the licence application, further investigation will be done to decide whether a biodiversity off-set should be considered, which focuses on the following:
 - the protected area targets;
 - to what extent the targets have been met;
 - the relative biodiversity value,
 - rarity of the veld type; and
 - threat status
5. Although the report focuses on species, the assessments relates this to habitats, since biodiversity conservation and off-sets strongly relates to the protection of ecosystems and habitats, rather than merely a species-focus.
