NOTICE OF MINING PERMIT APPLICATION PROCESS

Notice is hereby given as required in terms of Section 27(5) of the Mineral and Petroleum Resources Development Act (Act No. 28 of 2002) of the submission and acceptance of a mining permit application by the Regional Manager of the Department of Mineral Resources (DMR) with reference number: GP30/5/1/3/2/10003MP.

The application was submitted by Aquarella Investments 389 (Pty) Ltd to obtain authorization from the DMR to undertake mining activities for Clay (General) and Shale/Brick Clay in the Magisterial District of Westonaria, Gauteng Province. Mining will take place by quarrying and the area of extent will be a maximum of 1.5 hectares.

AGES (Pty) Ltd is appointed as the independent Environmental Assessment Practitioners (EAP) to evaluate the possible environmental impacts associated with the proposed mining activities. Such impacts will be recorded in an Environmental Management Plan (EMP) in accordance with Regulation 52 of the Mineral and Petroleum Resources Development Regulations, which is to be submitted to the DMR.

One of the first responsibilities of the EAP is to conduct a stakeholder consultation process that offers landowners or lawful occupiers and interested and/or affected parties (I&AP's) the opportunity to voice their opinions and concerns in this regard and to establish communication channels between land owners, lawful occupiers, other I&AP's and the applicant (Aquarella Investments 389 (Pty) Ltd).

The mining permit application was submitted to the Regional Manager of the Braamfontein branch of the Gauteng Provincial DMR.

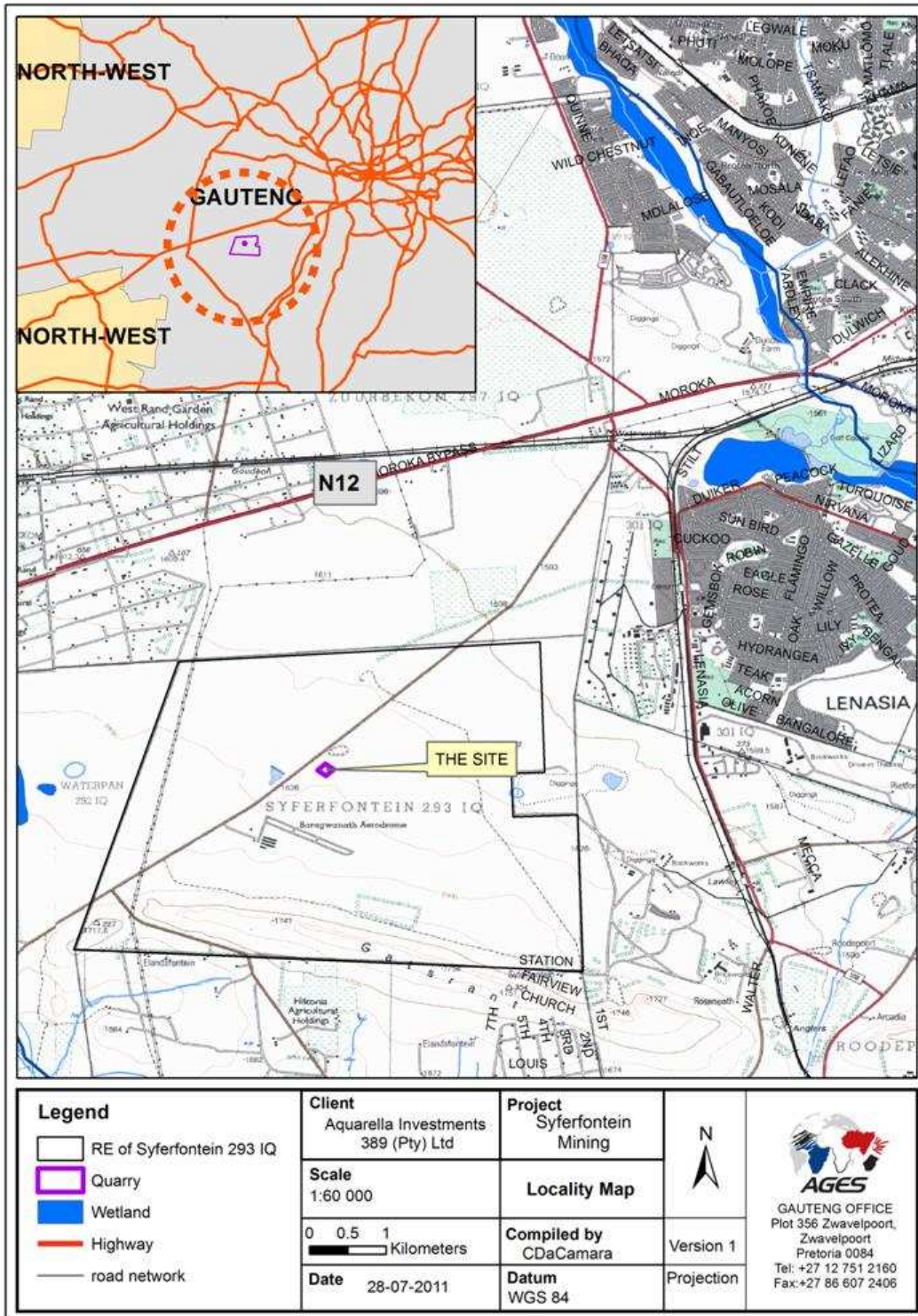
