ACCEPTANCE OF AN APPLICATION FOR PROSPECTING RIGHT IN TERMS OF SECTION 16(2) OF THE MINERAL AND PETROLEUM RESOURCES DEVELOPMENT ACT, 2002 (ACT 28 OF 2002) (AS AMENDED) (HEREIN AFTER REFERRED TO AS MPRDA): LODGED BY SIMON COLLIN THABO MAKWEYA TO PROSPECT FOR DIAMONDS (ALLUVIAL AND GENERAL), IN RESPECT OF PORTION 1 OF THE FARM WAGENMAKER'S DRIFT 24, SITUATED IN THE MAGISTERIAL DISTRICT OF JACOBSDAL.

1. We refer to the abovementioned matter and wish to inform you that your application for prospecting right in terms of Section 16 of the MPRDA in respect of **portion 1 of the farm Wagenmaker's Drift 24 for commodity diamonds (general and alluvial) has been accepted.**

2. Please be further informed that the **remaining extent and portion 2 of the farm Wagenmaker's Drift 24** have been excluded from your application for reason that there is an existing prospecting right on the aforesaid properties for the same mineral applied for as contemplated in section 16(2)(b) of the MPRDA.
3. Please take note that in terms of section 16(4) of the MPRDA, you are required to:
 - (a) Notify in writing and consult with the landowner or lawful occupier and any other affected party; and
 - (b) Submit *electronically* and *manually* the results of such consultations on or before the 28 January 2016. Your consultation must be extended to the Department of Land Affairs if the land is state owned or in the event that the land is subject to land restitution, to consult the office of the Commission on Restitution of Land Rights and submit the results of such consultations on the date mentioned above.

Further note that should this office discover at a later stage the existence of a right or permit issued in respect of the property forming the subject of this application, further processing of this application shall discontinue.

The acceptance in the case in hand does not imply that you may prospect on the land in question. This letter only implies that your application for prospecting right is now in process.
