On 9 October 2015, the Department of Mineral Resources gave permission to Rakhoma Mining Resources Pty Ltd, to continue with its Environmental Impact Assessment (EIA) Process for the proposed development of Geluk Mine and prepare an Environmental Impact Report (EIR) and Environmental Management Programme (EMPr).

Notice is hereby given in accordance to Government Notice R982, Regulation 40 of the NEMA EIA Regulations of 2014, that a **Draft EIR and EMPr** for the proposed project has been prepared and is now available for public review.

The EIR presents the findings of the EIA Process undertaken for the project and takes into consideration potential negative and positive impacts and recommends mitigation measures for its management. The impacts identified will be proactively managed through the implementation of an EMPr. The EMPr provides a basis for managing, mitigating and monitoring the environmental impacts associated with all the phases of the mine development.

An integrated EIA process is being followed for several licenses/authorisations required for the project as per the following pieces of legislation:

- National Environmental Management Act 107 of 1998 – Environmental Authorisation
- Mineral and Petroleum Resources Development Act, 28 of 2002 – Mining Right
- National Environmental Management: Waste Act (59 of 2008) – Waste Management License
- National Water Act, 36 of 1998 – Water Use License
