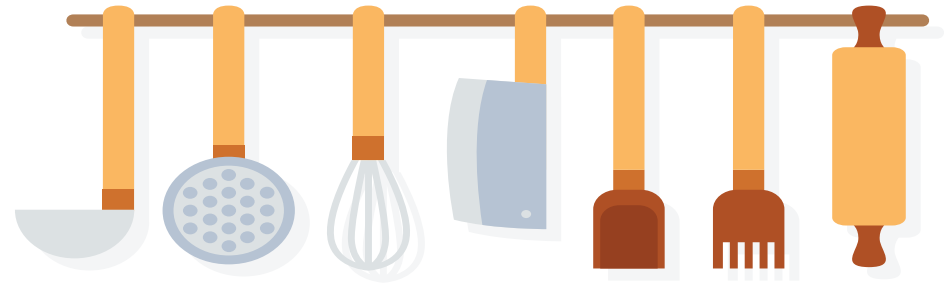

# SEEKING ANSWERS

 THE Mpumalanga Department of Health has released a preliminary report following the death of two babies at Shongwe Hospital last Tuesday.

The premature babies allegedly died after oxygen ran out in the neonatal ward.

Last week, MEC Sasekani Manzini visited the hospital and promised to have the preliminary report by Friday.

According to Manzini, various stakeholders contribute to the delivery of healthcare.

The stakeholders include the Mpumalanga Department of Public Works, Roads and Transport that provides artisan support to the facility, private companies who are contracted to provide other services, and other social partners.

"Preliminary reports indicate that these role players could have a part to play in the circumstances leading to the unfortunate death of the two babies.

"We will give them the opportunity to study the report and provide guidance on their areas of responsibility. We hope this process will provide a conclusive picture of what led to the death of the babies and will assist the

department to ensure that there is no stone unturned in this process," she said.

Manzini called for calm on the matter and said all the relevant stakeholders be given an opportunity to deal with the matter with diligence. She assured the people of the province that all is well, especially in the neonatal ward.

"As government we are doing everything we can to ensure that we provide answers

to this incident.

"I have assembled a team to visit the bereaved families and update them on the process we are following to find answers to what happened.

"We commit to keeping them abreast of every development on this matter going forward.

"We want to assure everyone that at the end of the process we will provide a full disclosure to the families," she said.

## Deadly escape for notorious thug!

**NOTORIOUS** thugs, Clearance Dlamini, was killed in a horrific accident while escaping away from the police in a stolen car.

The 29-year-old from Merry Pebbles Stream Village in Bushbuckridge, Mpumalanga, was wanted for various robberies and attempted murder cases when he met his death.

The incident happened between Atherstone and Xanthia villages on Wednesday.

*Daily Sun* reported about his criminal activities last year.

He was wanted for attempted murder after he allegedly shot a 53-year-old man and took his firearm at Merry Pebble Stream.

According to Mhala police spokesman Captain S'fiso Nyakane, police had been looking for Dlamini for a long time.

He said they received a call on Wednesday about a car crash. When cops arrived at the scene they found a dead man, who was identified as Clearance Dlamini.

"We discovered that the car was reported stolen after an Ethiopian man alleged that a group of men came to his house and took his car."

Dlamini was found with a 9mm gun and two ammunition, as well as balaclava and gloves.

Nyakane said cops were investigating cases of culpable homicide and theft of motor vehicle.

## 'Now my little girl limps and can't walk properly'

**THE fed-up principal called the cops on the naughty pupils last Friday.**

When cops arrived at Makerana Primary School, they allegedly forced the pupils to do exercises.

But 10-year-old Karabo Malibe fell on the ground.

She couldn't get up and a cop allegedly kicked her leg. Now she's in severe pain and her foot is swollen.

Her great-grandmother, Martha Malibe (73) from Vezubuhle near KwaMhlanga, told *Daily Sun* the young girl didn't tell her what had happened at school.

"She had been screaming the whole night since Friday. I asked

her what was wrong, but she wouldn't say. All she said was that her foot was painful. Her mum tried to comfort her.

"On Sunday afternoon her friends came by to play with her.

"That's when we got to know that she had been kicked by a cop at school.

"They told me the principal called the cops on them because they were naughty."

"I know that when kids misbehave they need to be scolded, but not like this.

"Now my little girl is limping and can't walk properly. She doesn't go to school and will fall behind with her school work."

The family took the girl to a clinic on Monday and were given pills.

"I'm so disappointed with the school. They didn't come to check on how my great-grandchild was," she said.

When the SunTeam arrived at her home, the girl's mum was in a meeting with cops and the principal at the school.

Mpumalanga education spokesman Gerald Sambo said: "The parents can open a case against the cop who allegedly assaulted the learner at their nearest police station."

Brigadier Leonard Hlathi said parents of the child should see a cop shop commander.

## Suicide survivor fights depression

**NKULULEKO** Khanyi will host a campaign on Saturday in Lynnville, Emalahleni, aimed at fighting depression.

Nkululeko said he was planning to host the campaign in all nine provinces.

He said he'd attempted suicide twice because of depression.

He told *Daily Sun* the illness affected many men, yet they were scared to come out.

He said the death of hip hop artist HHP, Nechume and varsity professor Bongani Mayosi was proof that depression shouldn't be taken lightly.

"Business people and police offi-

cers are most affected. We decided to come to Emalahleni because it's where most youth commit suicide," he said.

"People need a support structure when they lose their jobs. Everyone can come and will be given a chance to speak about their experiences.

"Men are expected to come out in their numbers to help fight depression."

Nkululeko said the municipality had pledged to support his campaign.

He said people would get advice on how to get help, and artists and celebrities would be present at the campaign.

"Attempts to find him at his friends

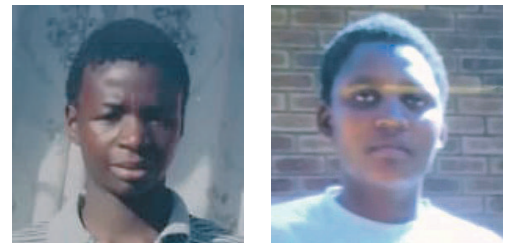
and relatives' places were not successful.

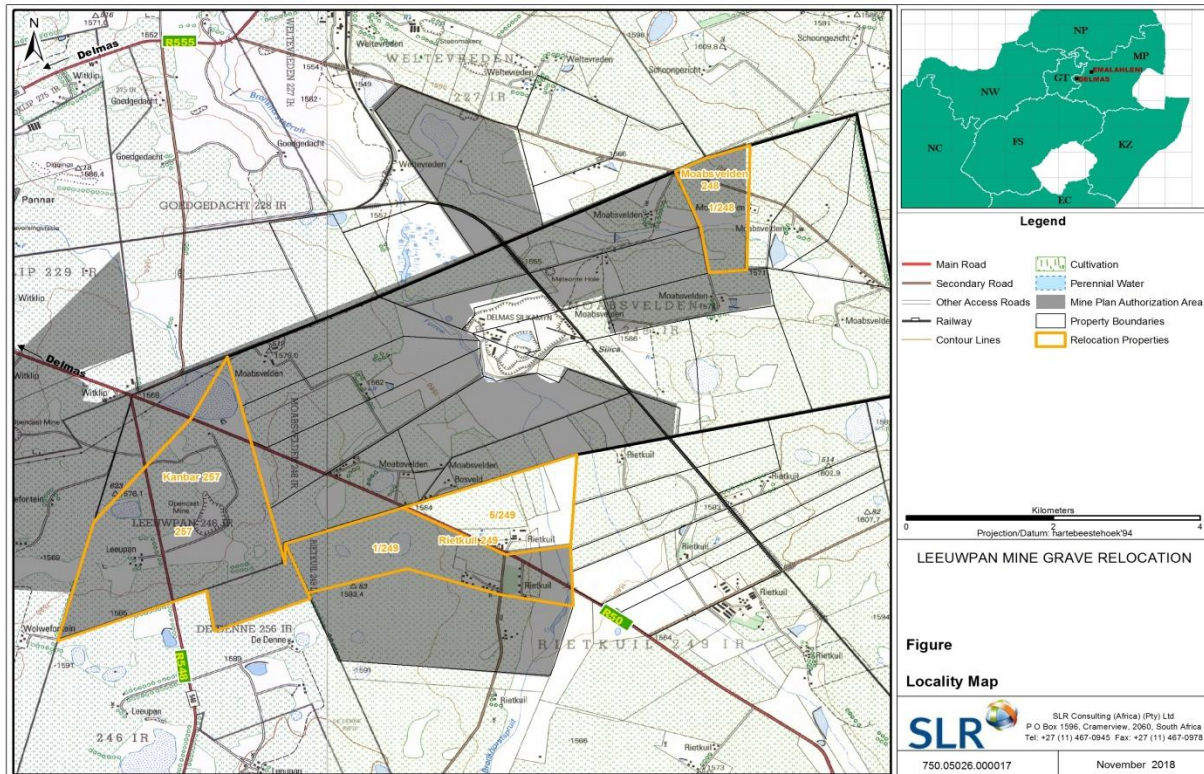

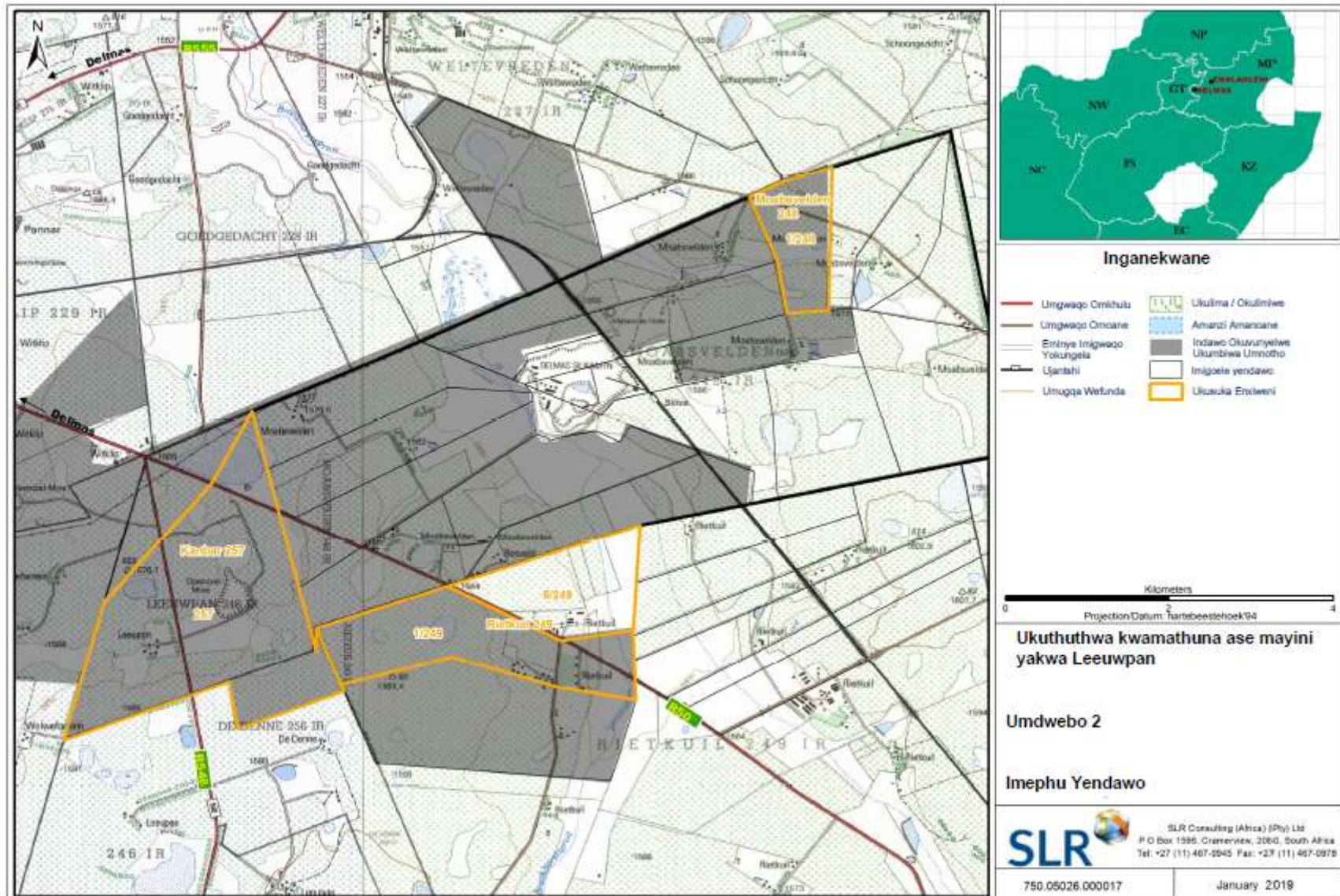

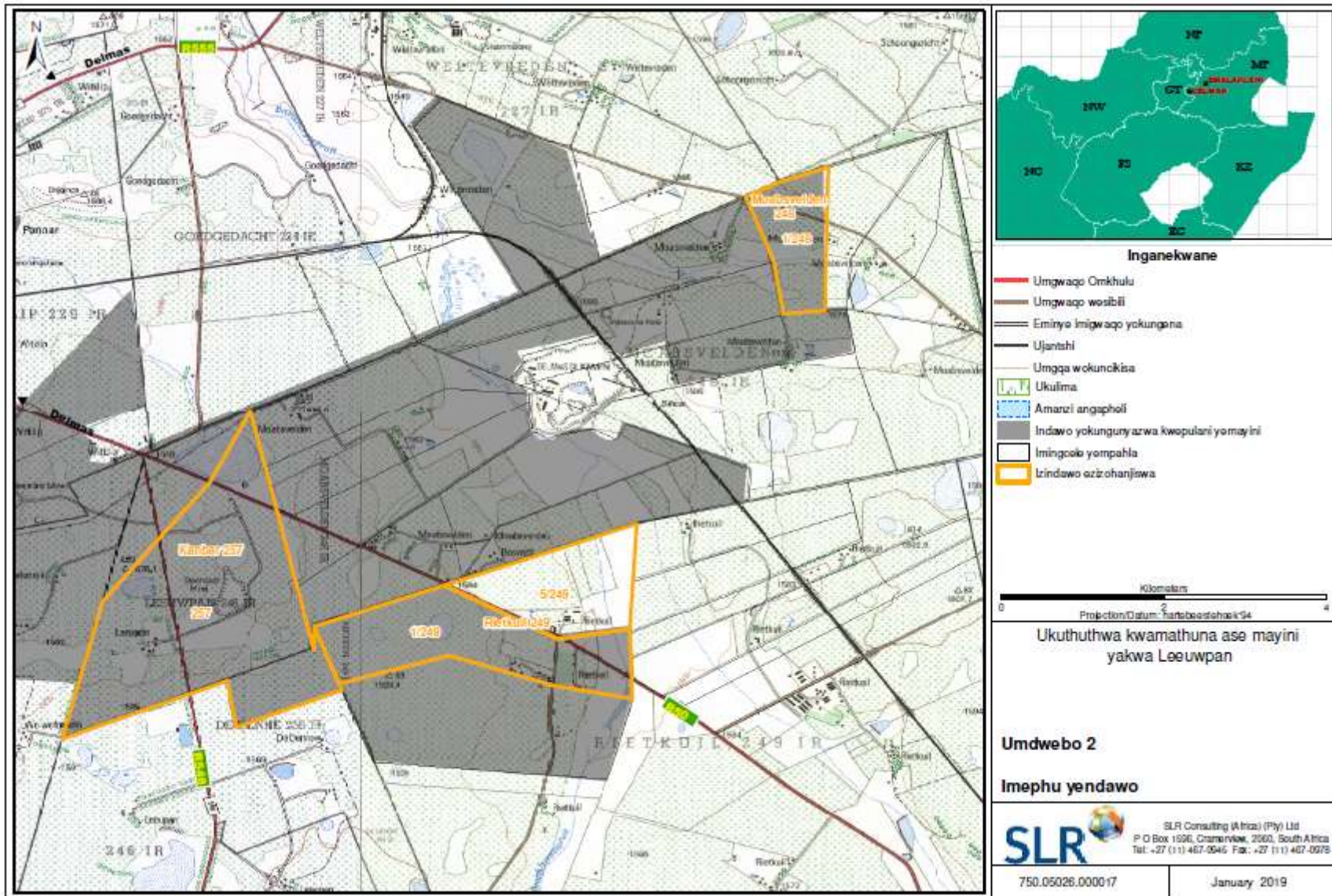
