GEJ Resources (Pty) Ltd ("GEJ") has applied for a Prospecting Right in terms of Section 16, simultaneously with Section 20, of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002), as amended ("MPRDA").
