NOTIFICATION OF AN ENVIRONMENTAL AUTHORISATION PROCESS IN TERMS OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT (ACT NO. 107 OF 1998) AND THE NATIONAL WATER ACT (ACT NO. 36 OF 1998) FOR THE PROPOSED TOWNSHIP DEVELOPMENT OF PORTION 883 AND PORTION 1713 OF THE FARM RANDJESFONTEIN 405 J.R., TO BE KNOWN AS MIDRIDGE PARK EXT. 25

Introduction

The application in this matter, Vukile Property Fund Ltd, has appointed Prism EMS to attend to an application for environmental authorisation from GDARD, as well as a Water Use License from DWA, to facilitate development of Portions 883 and 1713 of the farm Randjesfontein 405 J.R.

The proposed development will consist of two erven zoned 'Special', to facilitate offices, a clinic, and other uses as the Council will permit with special consent. It is the applicant's intention to develop the site with market viable development to uplift and compliment the surrounding area. The site is affected by a wetland system to the north of the site, crossing over into the adjacent property to the west.

Legislation

National Environmental Management Act, 1998

Section 24 of the NEMA requires that activities (e.g. construction), which may impact on the environment must obtain an environmental authorisation from a relevant authority before commencing with the activities. Such activities are listed under Regulations Listing Notice 1 Government Notice (GN) 544 (dated 2 August 2010) of NEMA.

The activity triggers: <u>Government Notice 544, Activity 11</u>: "The construction of a (vi) bulk storm water outlet structures; or (xi) infrastructure or structures covering 50 square metres or more where such construction occurs within 32 metres of a watercourse.

Government Notice 544, Activity 23: The transformation of undeveloped, vacant or derelict land to residential, retail, commercial, recreational, industrial or institutional use, inside the urban area, and where the total area to be transformed is 5 hectares or more, but less than 20 hectares in size.

National Water Act, 1998

The activity triggers will trigger water uses in terms of Section 21 (c) and (i) of the NWA: "Impeding or diverting the flow of water in a watercourse and altering the bed, banks, course or characteristics of a watercourse".


As a result, the developer will also be applying for a Water Use License to permit the proposed development from the Department of Water Affairs.

Location and Size

The subject site is situated north of New Road, east of 3rd Road and west of the N1 (Ben Schoeman Highway) in the Midrand Area. It falls within Ward 97 of the City of Joburg Region B on Portion 883 and Portion 1713 of the Farm Randjesfontein 405 J.R.The total size of the property is 5, 0120 ha.
