The prescribed form for the Notice of Intention to Appeal can be obtained from WSP as per the contact details below.

2. In terms of sub-regulation 60(2) and 60(3) in the EIA Regulations, 2010, the appellant must provide the applicant with a copy of the notice of intention to appeal to the applicant and all registered interested and affected parties c/o WSP, including details on where and for what period the appeal submission will be available for inspection.
3. An appeal must be:
 - a) Submitted in writing (Appeal forms to be obtained from the Department through above contact information);
 - b) Accompanied by:
 - A statement setting out the grounds of appeal;
 - Supporting documentation which is referred to in the appeal and is not available to the competent authority;
 - A statement that the appellant has complied with regulation 62(2) or (3) together with copies of the notices referred to above;
 - The prescribed appeal fee, if any.

An appeal as contemplated above must be submitted within 30 days after the lapsing of the 10 days stipulated above.
