#### NOTICE OF APPLICATION FOR A PART 2 AMENDMENT OF THE ENVIRONMENTAL **AUTHORISATION FOR THE** PORT SHEPSTONE CREMATORIUM **UPGRADE**

Notice is given in terms of Section 41 of Regulation No. 326 of 7 April 2017 under Sections 24(5) and 44 of the National Environmental Management Act, 1998 (Act No. 107 of 1998), of the Independent Crematoriums South Africa's (ICSA) intention to amend the Environmental Authorisation granted for the upgrade to the Port Shepstone Crematorium on Alesund Road in Port Shepstone.

Kantey & Templer Pty (Ltd) has been appointed by ICSA to undertake the Part 2 amendment application process for the exclusion of conditions in the Environmental Authorisation specifying that an abatement system be installed prior to the operation of the crematorium. The design of the cremator unit to be installed comprises an in-built abatement system that has been tested and proven on similar installations to effectively abate the formation and release of pollutants into the atmosphere.

The application is therefore to request that the Environmental Authorisation be amended to state that an additional abatement system will be investigated and installed should quarterly stack emission monitoring (in the first year of commissioning the crematorium) indicate that particulate matter emissions from the crematorium exceed the minimum emission

An Application for an Amendment of an Environmental Authorisation has been lodged with the KZN Department of Economic Development, Tourism and Environmental Affairs in terms of Regulation 31 of the Environmental Impact Assessment Regulations (GNR 326, 2017).
