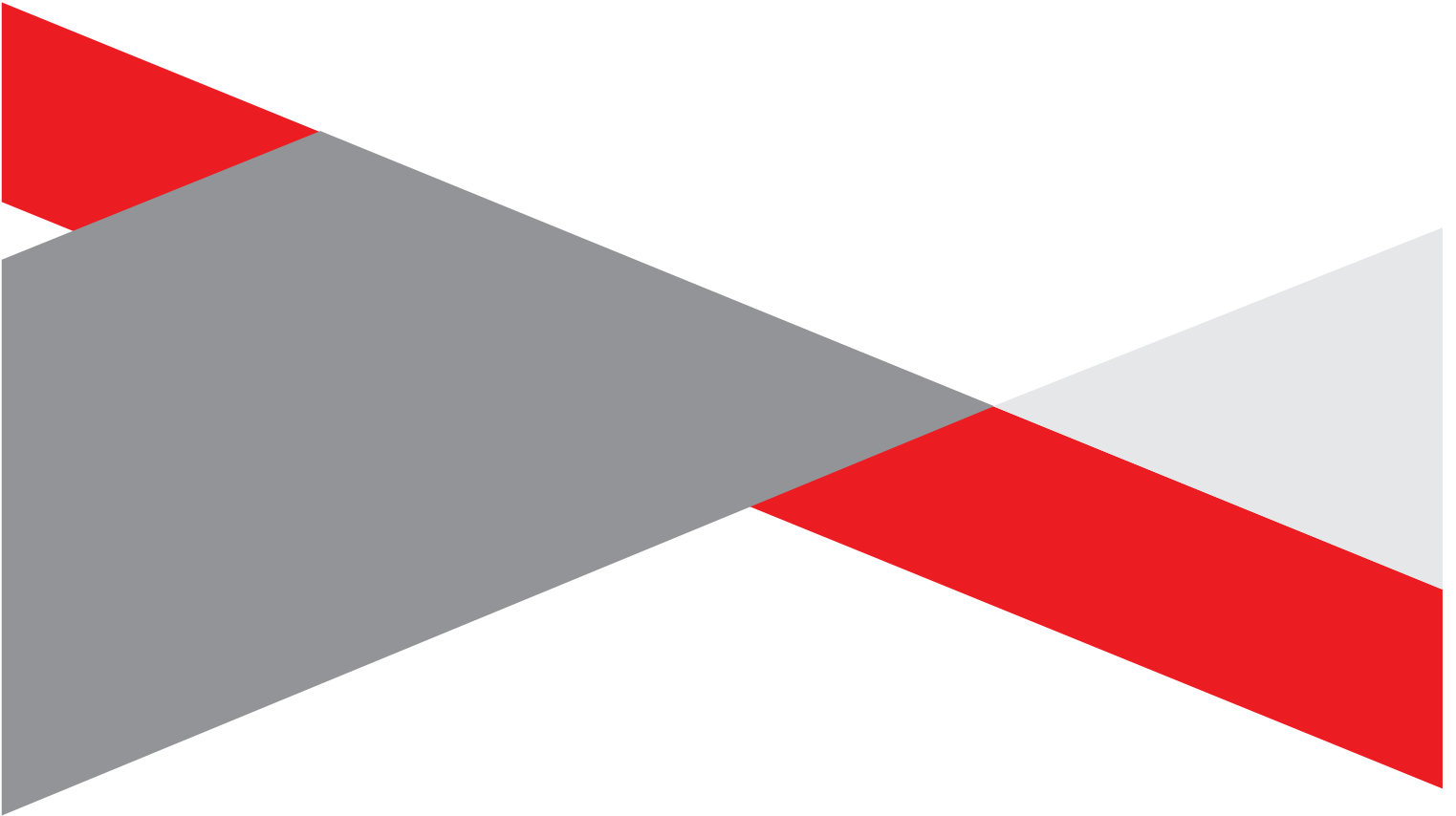

SLAAN 3 KEER IN 10 DAE TOE

Diewe teiken Bfn-substasie

'n Dik elektriese kabel is drie keer in tien dae by die Vierperdewami-substasie in Pellissier, Bloemfontein, gesteel. Dit het veroorsaak dat 'n groot aantal huise elke keer vir bykans 24 uur sonder krag was.



So lyk die elektrisiteitskabel van 64 m lank wat al drie keer in Pellissier gesteel is. Foto: VERSKAF

Die DA-raadslid Rossouw Botes het elke keer saam met Centlec, elektrisiteitsverskaffer van die Mangaung-metro-munisipaliteit, gewerk om die probleem op te los. Botes moes ook bontstaan om vrae van die inwoners te beantwoord. "Omdat die inwoners reeds onder beurtkrag ly, is die bykomende ongerief bykans ondraaglik," sê hy. Dit is 'n simptoom van 'n groter kwessie. "Met hoër werkloosheid in Mangaung, stygende kospryse, en munisipale wanbestuur, word die inwoners die slagoffers van diegene wat gedwing word om alternatiewe werk te soek," sê Botes. Goeie regering, laer kospryse en oorhoofse ekonomiese groei is die enigste antwoord om onnodige skade in gemeenskappe te voorkom, sê hy. Die kabel wat vervang moes word, is 64 m lank en die koste was telkens sowat R110 000. Dit word maar net weer van die belastingbetalers verhaal. Botes sê die kablediefstal wys dat mense die werk dophou. Net nadat dit die eerste keer vervang en herstel is, is

dit weer 'n keer gesteel. Die algehele koste van die drie diefstalle is sowat R330 000. "Die omliggende bome is nou skoon gesny sodat Centlec 'n spreiende moniteer op een van die straatligte wat direk op die mini-substasie skyn. Van die sekerheidsfirmas patroleer ook die gebied meer gereeld." Botes was beïndruk deur die wyse waarop Centlec die hele saak hanteer en 'n span uitgestuur het om telkens die kabel te vervang. Baie personeellede het ook saam beraadslaag oor hoe die probleem opgelos kon word. "Van die sekerheidsfirmas in die omgewing het ook aangebied om meer gereeld daar 'n draai te maak." Botes sê die diefstalle het tussen 31 Oktober en 9 No-

vember voorgekom. Dit moes diewe gewees het wat weet wat hulle doen. Die substasies word gesluit, maar deure word oopgebreek. Botes sê nadat die kragkabel by die substasie ontkoppel is, word 'n gat 'n ent verder in die grond gegrawe om die kabel daar af te kap en uit die grond te haal. "Die vermoede is dat bakkes gebruik word om die kabel uit die grond uit te trek omdat dit baie swaar is en nie sommer deur mense self gedoen kan word nie. Die kables word stuk vir stuk weggerig." Lele Mamutu, woordvoerder van Centlec, het by navraag gesê dat kablediefstal 'n enorme probleem vir Centlec is en dat die entiteit se skade jaarliks om en by R50 miljoen in dié verband beloop.

Polisie stel veldtog teen misdaad in Koffiefontein bekend 5 jaar ná moord op lede

Die veldtog vir 'n veiliger Kerstyd is spesiaal in Koffiefontein bekend gestel om mense daaraan te herinner dat die polisie steeds op soek is na die moordenaars van twee polisielede van die dorp. Dit was Vrydag die boodskap van lt.genl. Baile Motswenyane, Vrystaatse polisiekommissaris, toe die polisie dié provinsie se jaarlikse veldtog vir 'n veiliger Kerstyd op die Dithakeng-sportterrein van stapel gestuur het.

Die tema van vanjaar se veldtog is "meer voete op die grond om sigbare polisiëring uit te lig en te verbeter". T.J. Sebeela, voorsitter van Koffiefontein se gemeenskapspolisiëringsforum (GPF), het in sy spreekbeurt aan die polisie gesê die gemeenskap sal die polisie in sy stryd teen misdaad bystaan. Sebeela het egter by Motswenyane gepleit om korrupsie in die polisie uit te roei omdat dit die beeld van die polisie skaad. Sebeela het die gemeenskap ge-

vra om met die GPF saam te werk om 'n einde aan gendergeweld te bring. Op 29 Junie 2017 is konstabels Obert Mekoa en Mzonani Majo by die polisiekantoor doodgeskiet en die vuurwapens van een van hulle is geroof. Niemand is nog weens dié moorde aangekeer nie.

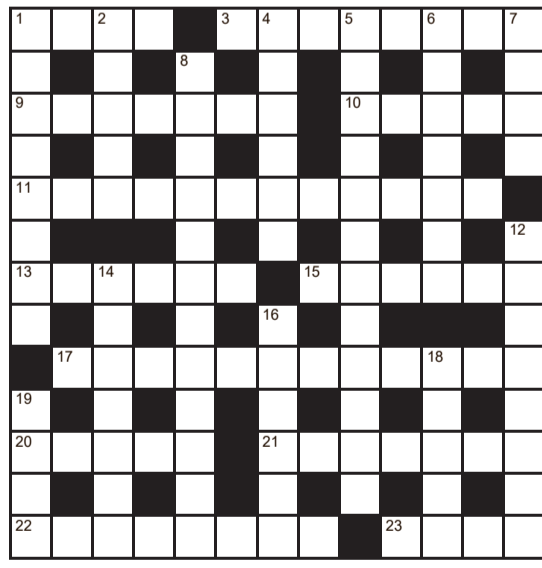
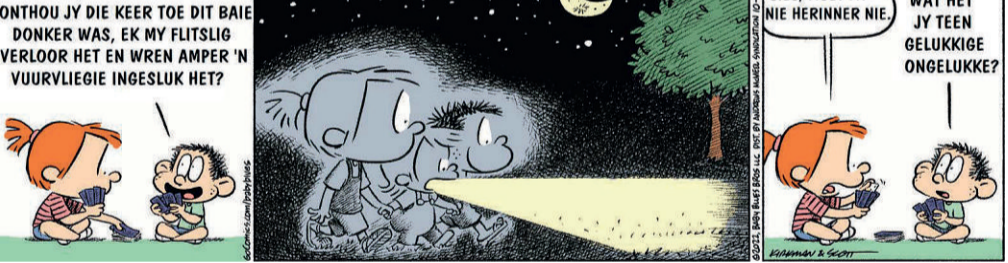

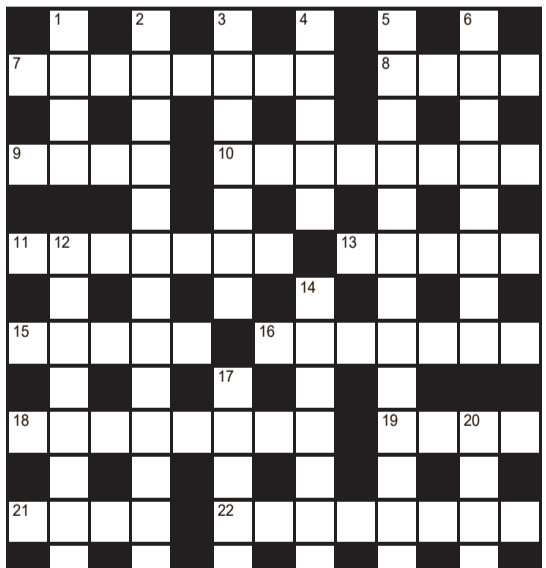

Dís waar vakbonde vandag marsjeer

Vakverbonde en hul lede beplan om die land vandag met hul afwesigheid tot stilstand te bring, maar sommiges gaan ook die strate invaar.

Die vakverbond Saftu gaan saam met sy mededinger Cosatu in ses provinsies marsjeer en optogte reël. Zwelinzima Vavi, hoofsekretaris van Saftu, het egter Maandag op 'n mediakonferensie in Johannesburg bekltoon hul lede sal nie in massas byeenkom nie omdat die werklke doel van die dag is om die ekonomie te strem en die mag van die werkersklas te illustreer.

Die optogte is dus meer 'n bykomende seremoniële optrede tot die wegby-aksie. Ontwrigting kan egter steeds plaasvind nadat albei vakverbonde hul lede opge-ru het oor die "kapitaliste"

se "aanslag" op die werkersklas wat hulle "woedend behoort te maak". Vavi se mees onheilspelelende uitlating was egter dat die twee vakverbonde mik om die uitvoerende gesag van die regering deur hul massa-aksieplan te "onttroon". Pres. Cyril Ramaphosa en sy kabinet is dus die teiken. Dr. Theuns Eloff, onafhanklike kommentator, reken dié dreigement dra nie meer dieselfde gewig as wat dit in vorige jare sou gedra het nie. Volgens hom is die drie-party-alliansie nie meer so belangrik as wat dit voorheen was nie. "Cosatu self het nie meer die miljoene lede wat hy voorheen gehad het nie. Sy mag is 'n fraksie van wat dit was," het Eloff verduidelik. In daardie opsig is dit vir

hom duidelik wat eintlik aangaan. "Cosatu en Saftu het gedoen wat mode is: Vir Cyril (Ramaphosa) te kap in 'n desperate poging om lede te werf en hul magsgreep te herstel." Eloff reken dit is meer 'n noodkreet van die vakverbonde as 'n behoorlike poging om sy gelede onder die wapen te roep. Tog sit wetstoepassingsagentskappe oorgehaal om ontwrigting hok te slaan. Maar oor die poging om die uitvoerende gesag te ontroon is Eloff nie te bekomerd nie. "Dit gaan heel waarskynlik misluk."

Waar gaan Saftu marsjeer?
In Bloemfontein gaan Saftu vanaf die Batho Lokasie-saal in Mangaung tot by die kantoer van die premier in die O.R. Tambo-gebou stap.

Daar sal ook in vyf ander provinsies, naamlik Gauteng, die Wes-Kaap, Limpopo, Mpumalanga en die Oos-Kaap, optogte wees. Saftu het beklemtoon dat net tot 1 000 lede per stad sal deelneem. Maar met die vakverbonde se beroep op selfs werkloose om deel te neem, kan dit dalk meer word. Sanparke het reeds aangedui dat voortydige en opportunistiese optogte rondom die Krugerwildtuin begin kop uitsteek het en reisigers moontlik in gevaar kan stel. "Daarom kan die situasie dalk eskaleer," het Sanparke op Facebook gesê. Dit is veral die Numbi-hek, die Paul Kruger-hek en die Phabeni-hek wat geraak word. Sanparke raai reisigers aan om baie versigtig te wees en ten minste verdragings te ver wag.
