'n Kanker van die sagte weefsel is twee jaar gelede by hom diagnoseer, waarna hy bestraling en chemobehandeling ontvang het.

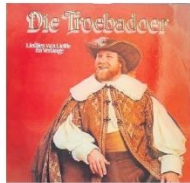
Sy vrou, Dalene, sê hy het die laaste tyd erge pijn gehad. Hy was 71 jaar oud.

Pretorius het in 'n rekordgetal van 12 Rhodes-toernooie gespeel en in die laat 1950s en in 1963 twee keer vir die destydse Kleurling Springbokspan teen 'n Swart Suid-Afrikaanse vyftiental uitgedraf.

Hy was vermomde agter die skrum met sy kranke lang en sekur aangevoerk. Sy taktiese skoppe en brekslae rondom die skrum het sy teenstanders ontenu.

Pretorius was ook 'n kranke tennis- en ghoëlspeeler en moes soms albei sportsoorte sonder enige professionele afrigting beoefen.

Sy vrou en vyf voormalige spanmaat Deen "Tonna" Mouton, wat self die gesogte Groen en Goud oor sy skouers getrek het, het hulde aan die reus van rugby gebring.

"Ek het die voorreg gehad om vier Rhodes-toernooie van 1963 tot 1969 saam met Pietie te speel.

"Hy was inderdaad 'n briljante rugbyspeeler wat die spel haarfyn kon ontleed deurdat hy sy opsies so vinnig en doeltreffend kon uitvoer.

"Hy het 'n reuse-aandeel gehad in die prestasies van die sevierende Noordwes-Kaapspan (NWK) wat in 1963 in Kimberley alle teenstand uit sy pad gegee het om uiteindelik die gesogte Rhodes-trofee met die gedulde WP-span te deel.

"Die Kapteenaars het daai dag gedink dis net vir opdraf en die beker Kaap toe te neem.

"Maar Piet en sy gedugte agter het die WP 'n opdraende stryd gegee. Piet se 'Gary Owens' het WP ontkant betrap!

"Dit was 'n naelbyt-eindstryd wat

toe geen punte opgelewer het nie. NWK het die span van Griekwaland-Wes in die halfeindstryd met 6-3 geklop om sodoende vir WP aan te durf.

Pretorius was 'n onderwyser van beroep en het 40 jaar lank sy plek in die opvoekende veld gestaan, waarna hy in 1991 die tuig neergelê het.

Hy was geliefd onder sy leerlinge en was altyd by skole sport betrokke. Sy oudste seun, Neil, het soos sy pa vir die plaaslike Collegians-klub en NWK op losskakel uitgedraf.

Toe Neil op kollege was, het hy provinsiale rugby as 19-jarige vir die destydse Transvaal gespeel.

"My pa het altyd vir my gesê: 'Speel die oomblik en dink en fokus wat jy die volgende oomblik gaan doen'. Hy het nooit probeer om my coach te wees nie," sê Neil.

Pretorius word ook vir grappies onthou waarvoor oud-rugbyspelers nog steeds kan lag.

"Pa se liefde vir sy kinders en kleinkinders en sorgsaamheid teenoor ons almal as gesinslede was vir ons baie spesiaal. Ons het baie dae van geluk en hlydskap in ons gesinslede geniet," sê sy vrou, die 92-jarige Merca.

Hy word oortuig deur sy vrou, twee seuns, Neil en Deon, en twee dogters, Merle en Lollie.

Pretorius se begrafnis het Saterdagoggend (27/05) in Uppington plaasgevind.
