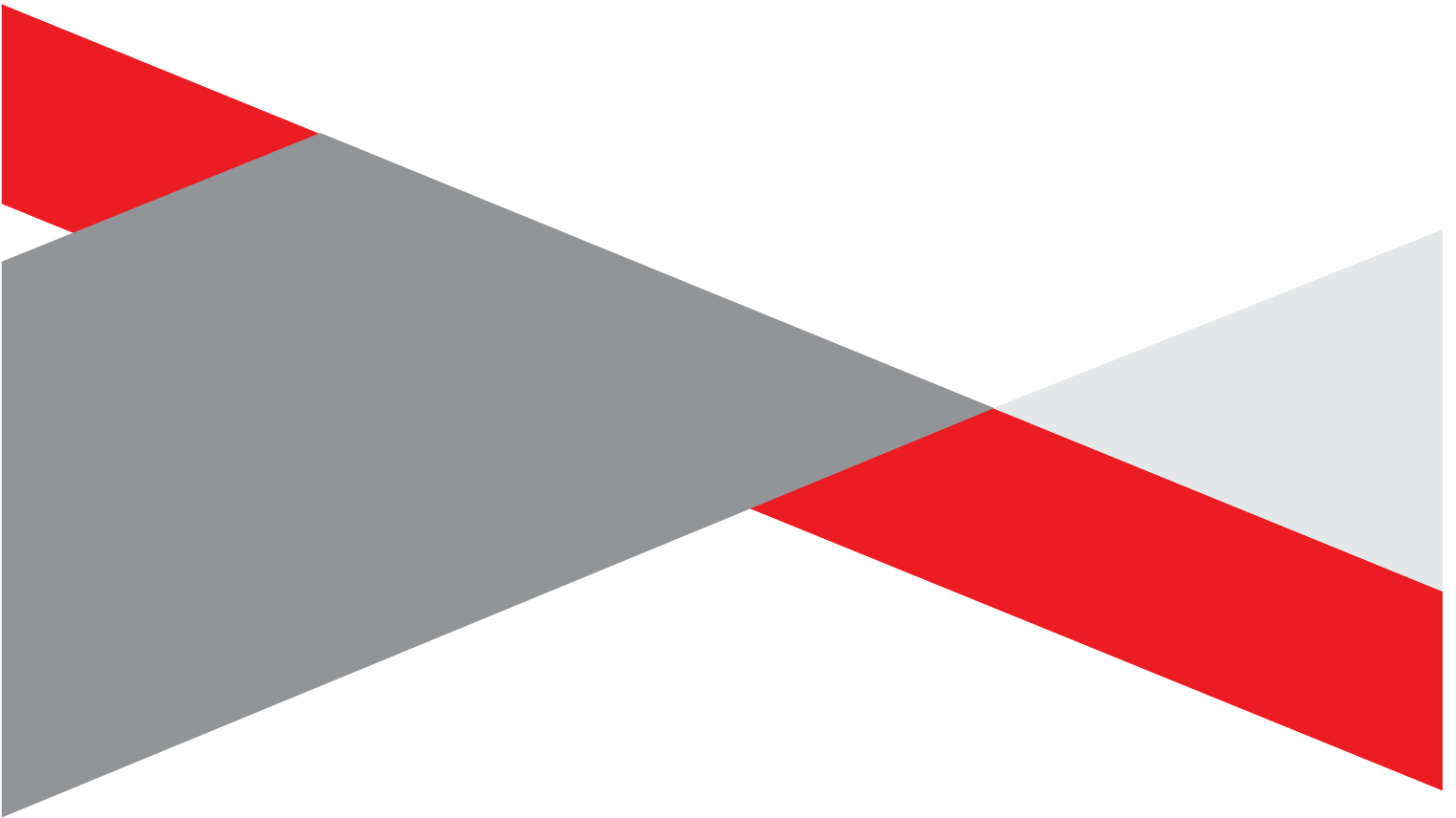

**NOTICE ON AVAILABILITY OF AMENDMENT MOTIVATION REPORT FOR ENVIRONMENTAL  
AUTHORISATION**

Mulilo Springbok Wind Power (Pty) Ltd received an Environmental Authorisation (EA) for the Springbok Wind Power Generation Facility on 27 July 2011, with amendments issued in October 2011, June 2014, July 2015, 18 May 2016, June 2018, August 2018, July 2019 and June 2021. The applicant intends to further amend the EA to extend the validity by an additional 5 years such that the EA would be valid for a period of sixteen (16) years and six (6) months from the date of issue of the authorisation.

In terms of Condition 1.6 of the EA dated 27 July 2011 and Regulation 29 of the EIA Regulations 2014, as amended, it is possible for an applicant to apply, in writing, to the competent authority for an amendment of the environmental authorisation if the amendment will not change the scope of a valid environmental authorisation nor increase the level or nature of the impact. The amendment to extend the EA validity will not increase the level, nature or significance of impacts which were initially assessed, and the amendment will take place within the authorised development footprint. An application in this regard has been submitted to the DFFE who have confirmed that the application falls within the ambit of a Part 1 amendment process. A public participation process is required to be undertaken in support of this application in accordance with the requirements of the DFFE.
