### **FREE STATE/LESOTHO BORDER ROAD: ENVIRONMENTAL PLANNING AND AUTHORISATION FOR THE PROPOSED REALIGNMENT, DESIGN AND CONSTRUCTION OF THE FREE STATE/LESOTHO BORDER ROAD AND RELATED INFRASTRUCTURE, FREE STATE PROVINCE**

1. Delta BEC consulting engineers was appointed by the Department of Public Works' to perform planning related work for the realignment, design and construction of the Free State/Lesotho Border Road. The purpose of this is as follows:
  - To enable the effective patrol of the border between South Africa and Lesotho by the South African National Defence Force;
  - For the Department of Agriculture, Forestry and Fisheries to manage and control the possible Trans –border spreading of animal disease, through managing and maintaining the border fence, amongst other.
  - Other purposes that are essential for the State.

The main objective of this project is to determine and establish the route and alignment for the Border Road (patrol road and fence) and to obtain "site clearance" (including relevant approvals over affected properties in favour of the state) for the road, in order to enable the detailed design and implementation of the re-construction of the road and to meet the functional specifications of the Defence Force.

The road has been in existence for many years but has fallen into disrepair due to poor maintenance, erosion and other factors. Land rights tenure in favour of the state has never been registered over the affected properties. The road (including its access routes) affects or traverses approximately 262 farm properties all along the international border between the Free State Province and Lesotho.

2. We require written consent or response from the identified affected land owner(s) for the purposes of:
  - 2.1 Environmental Authorisation, including agreement on borrow pits in some instances.
  - 2.2 Application for and issuing of Water Use Licenses by the Department of Water Affairs and Sanitation in terms of the National Water Act, 1998 (for the altering and/or impeding of a watercourse, disturbance to the river bed and/or bank, and taking of groundwater or surface water during construction).

*PTO*

- 2.3 Acquiring of rights to the affected properties for the state on portion of the said property, for the said road to enable the state to expend funds for the construction, the use and maintenance of the said road and access thereto.



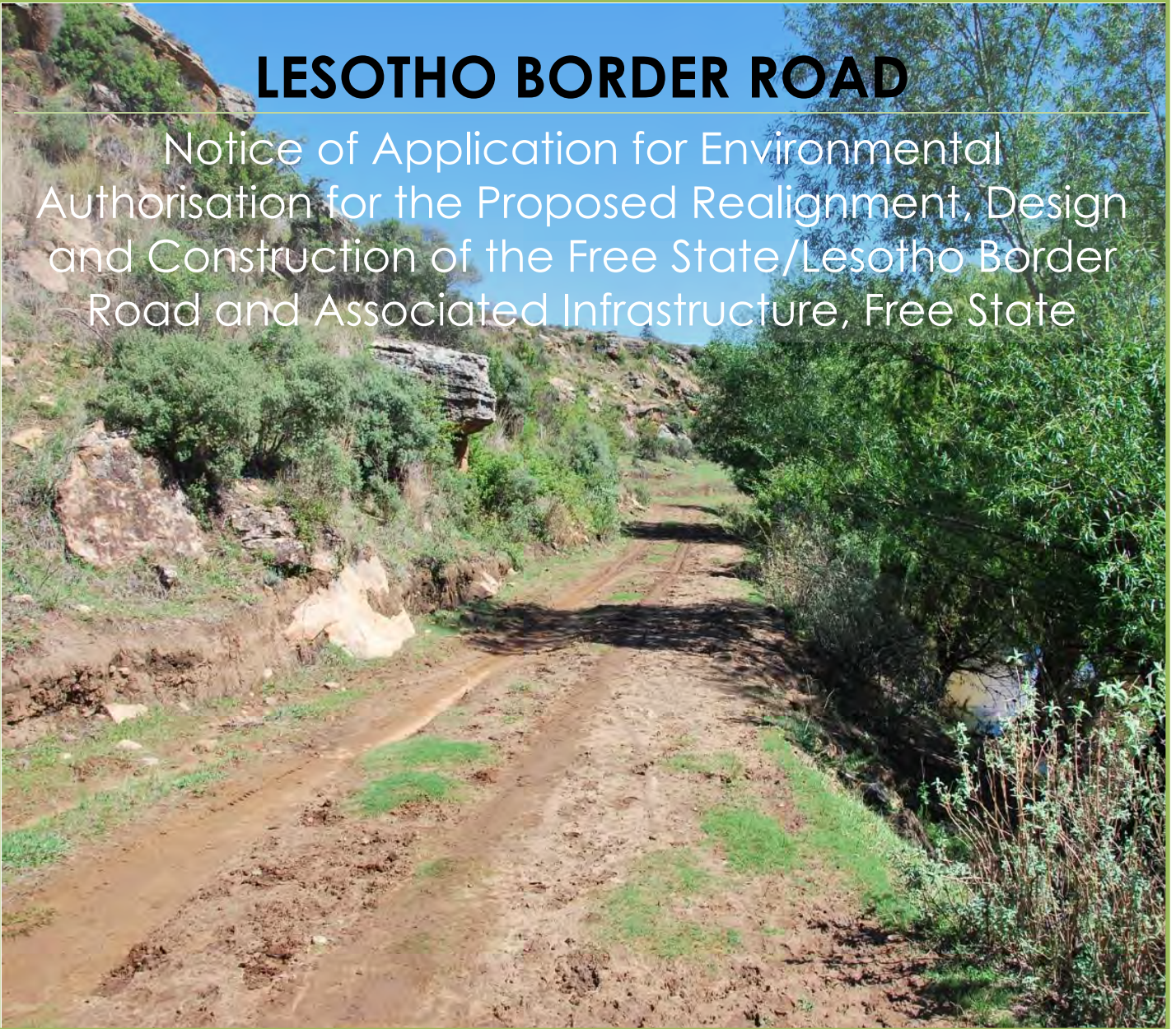

## 1. Purpose of this Document

The **National Department of Public Works** (DPW) as the “**Applicant**”, being the responsible body for the border road, hereby gives notice of the application for Environmental Authorisation for the proposed realignment, design and construction of the Lesotho Border Patrol Road.

The purpose of this document is to provide:

- ✚ Background information about the proposed project,
- ✚ A description of the required environmental authorisation processes, and
- ✚ A description of the required public participation processes.

## 2. Proposed Development and Phases

A Scoping and Environmental Impact Assessment process is required for the development of a road (proposed route of the border road is 520 km in length) with a reserve wider than 30 metres (proposed reserve is between 22 and 33 metres wide) along the border between the Free State Province and Lesotho. The route traverses approximately 262 farm portions. The road will be accessed through 19 access roads affecting approximately 30 farm portions. The project consists of two phases.

Phase one of the project include:

- ✚ Conducting technical engineering, environmental, planning and land use, cadastral and land tenure assessments of the road and its access roads to determine the needs and requirements for the alignment, repair and reconstruction of the road and for acquiring rights to the land needed for the road.
- ✚ Conducting road planning and preliminary design work to determine the optimal route and road development alternatives to the level required to obtain environmental authorisation and site clearance, including acquiring rights to the land needed for the road.

Phase two of the project will include the detailed road design and construction of the border road.

## 3. Project Location

The road is situated in the Free State Province.

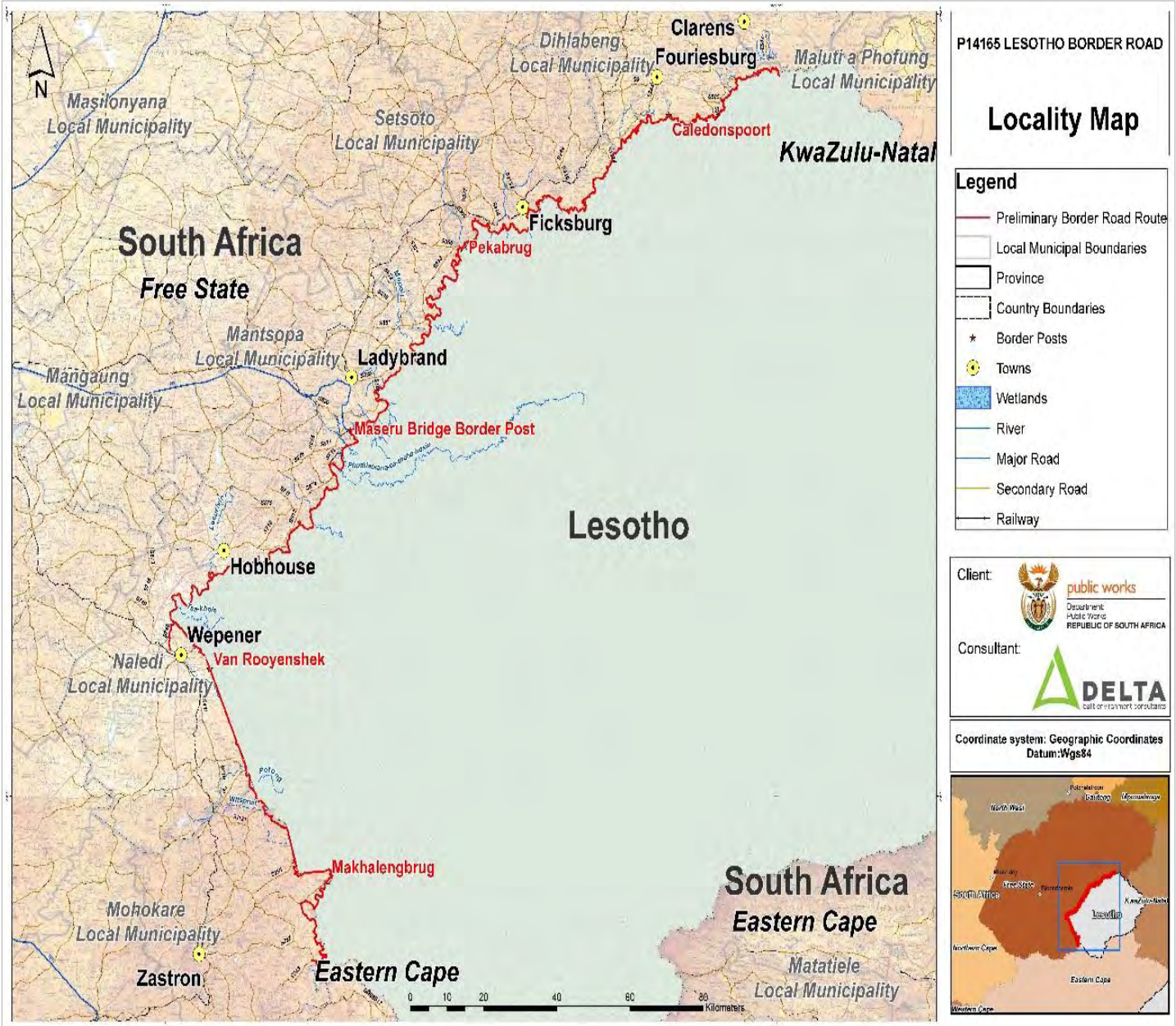

## 4. Regulatory Requirements

The National Environmental Management Act, 1998 (Act No. 107 of 1998): Environmental Impact Assessment Regulations, 2014, as amended, lists activities which require environmental authorisation before commencement.

The proposed realignment, design and construction of the Free State/Lesotho Border Road trigger several listed activities (see **Box 1** to the right) in Government Notice R.983 (GN R. 983), GN R.984 and GN R.985, which require a Scoping and Environmental Impact Assessment process, including:

- ✚ A Water Use Licence Application for the water uses in terms of Section 21 (a), (b), (c) and (i) of the National Water Act, 1998 (Act No. 36 of 1998).
- ✚ A Mining Permit Application for the possible establishment of borrow pits in terms of Section 27 of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002).
- ✚ A Heritage Resources Permit Application in terms of Sections 34, 35 and 36 of the National Heritage Resources Act, 1999 (Act No. 25 of 1999).

As part of the environmental impact assessment process, Interested and Affected Parties (I&AP) will be offered the opportunity to register their interest to the project (see **Diagram 1** below) in order to partake in the public participation process in terms of Section 41 of the Environmental Impact Assessment Regulations 2014 (GN R.982).

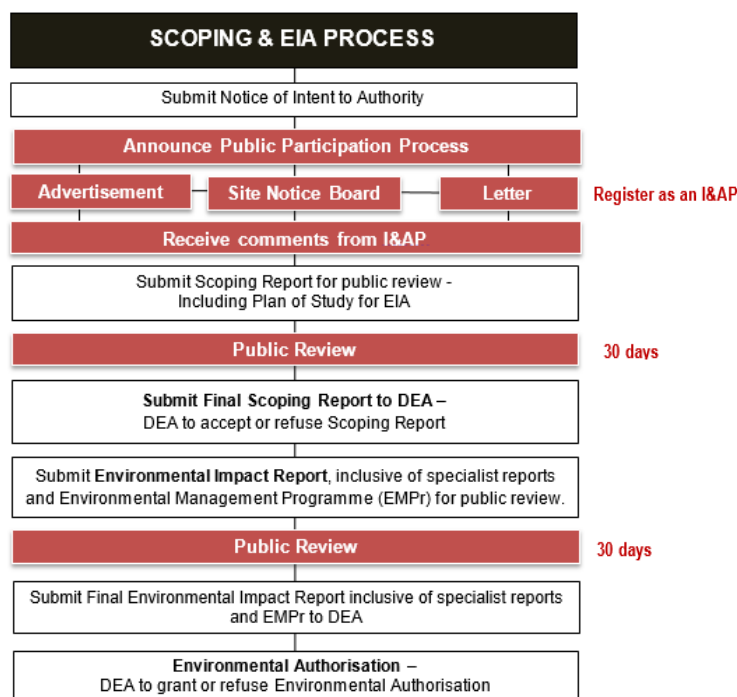


Diagram 1: EIA process and I&AP commenting opportunities

Box 1: Listed activities associated with the proposed project

### LISTING NOTICE 1 (GN R.983):

#### **Activity 19:**

The infilling or depositing of any material of more than 5 cubic metres into, or the excavation, removal or moving of soil, sand rock of more than 5 cubic metres from a watercourse.

#### **Activity 21:**

Any activity including the operation of that activity which requires a mining permit in terms of section 27 of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002).

#### **Activity 22:**

The decommissioning of any activity requiring a closure certificate in terms of section 43 of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002); or a mining permit where the throughput of the activity has reduced by 90% or more over a period of 5 years excluding where the competent authority has in writing agreed that such reduction in throughput does not constitute closure.

### LISTING NOTICE 2 (GN R.984):

#### **Activity 27:**

The development of a road with a reserve wider than 30 metres.

### LISTING NOTICE 3 (GN R. 985):

#### **Activity 10:**

The development of facilities or infrastructure for the storage and handling of a dangerous good, where such storage occurs in containers with a combined capacity of 30 but not exceeding 80 cubic metres.

#### **Activity 12:**

The clearance of an area of 300 square metres or more of indigenous vegetation.

#### **Activity 14:**

The development of infrastructure or structures with a physical footprint of 10 square metres or more where such development occurs within 32 metres of a watercourse measured from the edge of a watercourse.

#### **Activity 18:**

The widening of a road by more than 4 metres, or the lengthening of a road by more than 1 kilometre.



## 5. Specialist Studies

A number of potential environmental impacts and issues have been identified. These include:

### Watercourses



- Two thirds of the project follows the banks of the Caledon River.

### Fauna and Flora



- Impact on fauna and flora species. An example is the protected scorpion species found in the area.

### Agricultural, Soil and Land Capability



- Project might involve conversion of productive agricultural land.
- Possible impact on the economical land use value.
- Soil erosion due to the construction activities.

### Heritage & Paleontological Resources



- Several potentially sensitive heritage features may be affected.

### Borrow Pits



- The construction of the road will require suitable construction material to be sourced from new and/or existing borrow pits.

### Farm Infrastructure



- Potential impacts on farm infrastructure along the road such as, *inter alia*, gates, fence, farmsteads and outbuildings.

### Pollution

- Dust pollution
- Noise pollution

### Traffic and Community Safety



- Potential road alignment within urban / settlement areas.
- Positive and negative socio-economic impacts.
- Access roads during construction may have direct and indirect impacts on the existing road network.

### Positive Impacts



- Impacts from illegal overgrazing will be reduced.
- The risk to the RSA of foot and mouth disease will be reduced.

Independent environmental specialists will be appointed to assess the identified potential and cumulative impacts on the environment. The following specialist studies have already been identified to be undertaken:

- ✚ Archaeological Assessment
- ✚ Paleontological Assessment
- ✚ Invasive Alien Species Control and Eradication
- ✚ Climate, Soils, Agriculture and Land Use Assessment
- ✚ Geotechnical Surveying
- ✚ Biodiversity Assessment


