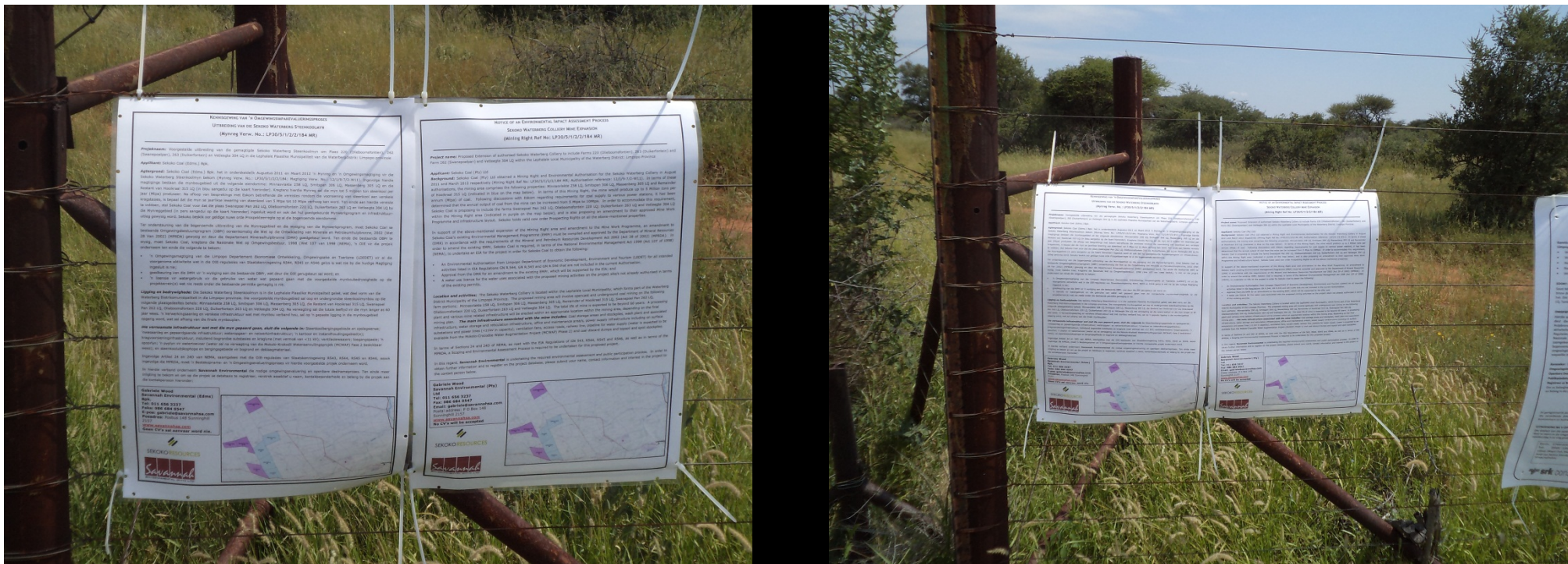


Figure 2 (a) & (b): Site Notice Placed on the On the fence of Farm Swanepoel Pan (23°36'17.03"S; 27°22'17.67"E) in January 2013

# Staatsrede laat landbouvræ steeds onbeantwoord

Hoewel President Zuma in sy staatsrede volgens Agri SA se korporatiewe skakeling dit duidelik gemaak het dat landbou en landelike ontwikkeling steeds hoog op die regering se agenda is, is sy verwysing na die behoefte aan dialoog met rolspelers in die bedryf, veral na aanleiding van die onlangse arbeidsonrus, aanduidend van 'n gebrek aan 'n gedeelde visie oor die toekoms van die landbou.

Sy aankondiging oor die heropening van die grondeiseproses verleng ook die onsekerheid van die afgelope 20 jaar oor grondbesit wat investering in die bedryf en sinvolle transformasie verder sal kniehalter. Dit is ook noodsaaklik dat enige onduidelikheid oor die interpretasie en toepassing van die Grondwet se bepaling oor "billike en regverdige" vergoeding vir grond wat onteien word, uit die weg geruim word.

Agri SA verwelkom President Zuma se sterk standpunt teen geweld en misdadige optrede tydens protesaksies en vertrou dat dit ook van toepassing sal wees op diegene wat hulle tydens die arbeidsonrus in die Wes-Kaap daaraan

skuldig gemaak het.

President Zuma het die regering weer eens verbind tot beleidsopbrengte binne die raamwerk van die Nasionale Ontwikkelingsplan. In dié verband sien Agri SA uit na die beter belyning van beleid en praktyk met dit wat in die Nasionale Ontwikkelingsplan in die vooruitsig gestel is. Die nuwe minimum loon is 'n voorbeeld van 'n beleidskeuse wat die haalbaarheid van die Nasionale Ontwikkelingsplan se werkskeppingsdoelwitte ondermyn.

In sy dialoog met die regering sal Agri SA aandag gee aan maatreëls wat landbouontwikkeling sal rugsteun en investering in die bedryf aanmoedig. Aspekte soos infrastruktuurontwikkeling en die bekostigbaarheid van insette waarvan die pryse administratief vasgestel word, sal van deurslaggewende belang wees. Uiteraard is 'n veilige landelike omgewing ook 'n voorwaarde vir beleggersvertroue. In dié verband is die spoedige implementering van al die fasette van die Landelike Veiligheidsplan ook van belang.

## Solea Renewables takes a giant leap

The evident need for alternative energy sources is increasingly becoming more of a need than an option according to Solea Renewables.

Solea Renewables recently announced the completion of the first ever off-grid utility scale photovoltaic system in Southern Africa, an evolutionary phase for the energy sector within the continent; a commendable result made possible by the partnering of Solea Renewables and Cronimet Mining Energy SA. The 1 megawatt (MW) plant is set to produce 1.8 GWh of electricity annually.

Commissioned in November 2012 and having taken a total of eight weeks to construct, the plant is currently operational and performing according to expectations, says Vusi Mhlanzi, CEO of Solea Renewables.

Sized around 2 hectares of land on Cronimet Mining Energy SA's site in Thabazimbi Limpopo, this is the first project of its nature that has been successfully executed within Southern Africa.

Moritz Hill, Director of Cronimet Mining Energy SA, sees this achievement as a great milestone for the continent's renewable energy production potential.

"Solar PV forms a big part of renewable energy, especially in Europe. Africa has more radiation, which even doubles that of Europe in some regions. With the country's increased demand to decrease the reliance on our primary energy provider - Eskom

and the continent's favourable climate for the harnessing of solar energy, this is only the beginning for projects such as these," comments Mhlanzi.

He says, "We believe that this industry is currently in its infancy and has tremendous growth potential over the next few years, especially with the current power challenges that the continent is facing, we will begin to see the industry's full potential."

With a clear focus on the future, Solea Renewables is looking at spreading their expertise throughout the continent.

"Our target market now is the rest of the continent," says Mhlanzi. Our targeted clients are big power users such as mining and the industrial sectors. The main aim is to decrease the continent's reliance of fossil fuels so that we can decrease our carbon footprint.

"The ivory, which differs in size and thought to have been removed from two different elephants, are valued at R25 400. Police investigations are underway to establish the origin of the recovered ivory and possibly find the carcasses of the slain elephants," said Brigadier Hangwani Mulaudzi.
