

NOTICE OF THE PROPOSED RE-INSTATEMENT AND DEVELOPMENT OF VBC08 WETLAND PROJECT IN SECUNDA, MPUMALANGA PROVINCE

Notice is given in terms of Regulation 41(2) of GNR 326 (2014, as amended) published under section 24 and 24D of the National Environmental Management Act (No. 107 of 1998) (NEMA) for submission of an application for Environmental Authorisation (EA) in respect of activities identified in terms of GNR 327 and GNR 324 (2014, as amended) and in terms of Section 41(4) of the National Water Act (36 of 1998) (NWA), for the submission of a Water Use Licence (WUL) Application.

BACKGROUND AND LOCATION

Secunda Operations, a division of Sasol South Africa Limited (Sasol) are proposing the reinstatement of a Channelled Valley Bottom Wetland (VBC08) located below the Nitro Fertiliser plant. The reinstatement project entails the installation of up to eighteen wetland restoration structures (weirs) at various points of the VBC08 wetland system. The installation of the weirs will help improve the wetland health by reducing nutrient and salt load into the Bossiespruit. The Secunda Industrial Complex (SIC) is located in Secunda, which is approximately 50 km north of Standerton and 28 km west of Bethal in the Mpumalanga Province. The site is east of the R546 Regional Road and Embalenhle Township and falls within Govan Mbeki Local Municipality of the Gert Sibande District Municipality.

ENVIRONMENTAL APPLICATION

KENNISGEWING VAN DIE VOORGESTELDE HERINSTELLING EN ONTWIKKELING VAN VBC08 VLEILAND PROJEK IN SECUNDA, MPUMALANGA PROVINSIE

Kennisgewing geskied ingevolge Regulasie 41 (2) van GNR 326 (2014, soos gewysig) gepubliseer kragtens artikel 24 en 24D van die Wet op Nasionale Omgewingsbestuur (Nr. 107 van 1998) (NEMA) vir die indiening van 'n aansoek om Omgewingsmagtiging (EA) ten opsigte van aktiwiteite geïdentifiseer ingevolge GNR 327 en GNR 324 (2014, soos gewysig) en ingevolge artikel 41 (4) van die Nasionale Waterwet (36 van 1998) (NWA), vir die indiening van 'n Watergebruiklisensie (WUL) aansoek.

AGTERGROND EN LIGGING

Secunda Bedrywighe, 'n afdeling van Sasol South Africa Limited (Sasol), stel voor dat 'n Channeled Valley Bottom -vleiland (VBC08) onder die Nitro -kunsmissaanleg herstel word. Die herinstellingsprojek behels die installering van tot agtien vleilandherstelstrukture (stuwwe) op verskillende punte van die VBC08 vleilandstelsel. Die installering van die stutte sal help om die gesondheid van die vleiland te verbeter deur die hoeveelheid voedingstof en sout in die Bossiespruit te verminder. Die Secunda Industriële Kompleks (SIC) is geleë in Secunda, ongeveer 50 km noord van Standerton en 28 km wes van Bethal in die Mpumalanga Provinsie. Die perseel is oos van die R546 Streeks Pad en Embalenhle Township en val binne die Govan Mbeki Plaaslike Munisipaliteit van die Gert Sibande Distriksmunisipaliteit.
