INVITATION TO REGISTER AS AN INTERESTED AND AFFECTED PARTY (I&AP) AND COMMENT ON THE DRAFT SCOPING REPORT FOR THE PROPOSED MIXED USE DEVELOPMENT (JUPITER EXTENTION 8) ON PORTION 2 OF FARM ELANDSFONTEIN 90-IR, EKURHULENI METROPOLITAN MUNICIPALITY, GAUTENG PROVINCE

Abland (Pty) Ltd intends to establish a mixed use/ industrial 1 development to be called Jupiter Extension 8. The project entails the construction of buildings, internal roads and necessary infrastructure (stormwater and sewerage) to service the development. The site is approximately 20ha in extent and is located on the Remainder of Portion 2 of Farm Elandsfontein 90-IR, Germiston Ekurhuleni Metropolitan Municipality, Gauteng Province.

The proposed Jupiter Extension 9 will comprise of various compatible use zones. The use zones will include the following:

- Industrial No. 1
- Commercial (including shops and offices)
- Conference facilities and restaurant
- "Special" for access
- Public open space
- Roads

Abland (Pty) Ltd appointed Strategic Environmental Focus (Pty) Ltd (SEF) as an independent Environmental Assessment Practitioner (EAP) to facilitate the Scoping and Environmental Impact Reporting (S&EIR) to obtain an Environmental Authorisation from the Competent Authority, the Gauteng Department of Agriculture and Rural Development (GDARD).
