DRAFT BASIC ASSESSMENT REPORT FOR FOR THE PROPOSED CAPITAL PARK FILLING STATION

Fargofin (Pty) Ltd (herein referred to as Fargofin) proposes to establish a new filling station to be known as Capital Park Filling Station. The proposed filling station will occupy approximately 3 200 m2 in extent. The proposed filling station will consist of underground storage tanks (USTs) with a combined storage capacity of 92 m3; pump islands in forecourt; a convenience store with in-house Burger King facility; ablution facility; and car parking areas (24 parking bays). The site is located on ERF 1869 (corner of Paul Kruger road and Malherbe Street) in Capital Park, within the City of Tshwane Metropolitan Municipality, Gauteng Province.

Fargofin has appointed Strategic Environmental Focus (Pty) Ltd (SEF) as an independent environmental consultancy to facilitate the Basic Assessment (BA) process, including the public participation process. In terms of Government Notice No. 544 (Listing Notice No. 1) of the National Environmental Management Act, 1998 (Act No. 107 of 1998) [NEMA] the following listed activities are triggered and therefore require Environmental Authorisation by way of a Basic Assessment Process:
