DRAFT BASIC ASSESSMENT REPORT FOR FOR THE PROPOSED CAPITAL PARK FILLING STATION

Fargofin (Pty) Ltd (herein referred to as Fargofin) proposes to establish a new filling station to be known as Capital Park Filling Station. The proposed filling station will occupy approximately 3 200 m2 in extent.
