- That the mine must commit on clear timeframes and resources allocation to implement this outstanding matter of Burial Ground and Graves Sites, as these is a sensitive matter that need cooperation between the Mine and People with Heritage and Cultural Resources. - Taking into account that this process which was undertaken by the TRP Mine as a result of complaint laid by DCCS at DMRE and SAHRA against TRP lack of consultation and Compliance in relation to Heritage and Cultural Resources Management in 2021/08/13
