- Maxim Planning Solutions (Pty) Ltd was appointed by the Ditsobotla Local Municipality to attend to the establishment of the proposed township Blydeville Extension 4. As per normal procedures, we also referred the township establishment application to your organization for comments. In response to this submission, we received your organization's interim comment requesting that another copy of the palaeontological impact assessment be submitted as the copy that was uploaded on the SAHRIS portal was in black and white and of poor print quality. It was also indicated in the interim comments that the palaeontologist must provide clear recommendations as to whether a field investigation should be conducted or not.
- When we approached the EIA consultant to obtain a better print quality PIA and for further clarification on the requirement for a field investigation, we were informed that this project had already previously been submitted to your organization for comments during the EIA process and that all the matters indicated as outstanding have actually already been addressed during 2017 following which a Final Comment was issued by your organization in respect of this project. The matter was previously dealt with under Case ID 9696.
