
Maxim Planning Solutions (Pty) Ltd (2002/017393/07) submitted the above-mentioned application or township establishment to your organization for comments during 2009 (your reference 9/2/231/0013). Interim comments were furnished by your Me. Andrea Hickman on 15 September 2009. In terms of the fore-mentioned comments, we were directed to either contract an accredited specialist to provide a Phase 1 Impact Assessment Report or alternatively the specialist may provide a letter indicating that there is no necessity for any further assessment. It was also indicated that it may be more appropriate to conduct a full Heritage Impact Assessment. Maxim Planning Solutions (Pty) Ltd commissioned A Pelsers Archaeological Consulting to conduct a Phase 1 Heritage Impact Assessment in respect of the proposed development area. During scrutiny of our file it became apparent that the fore-mentioned HIA was erroneously not forwarded to your organization for finalization of this matter. Due to the fact that this matter was previously extensively investigated by your organization as well as the conclusion drawn in terms of the HIA report, it would be greatly appreciated if we could receive your final comments in this matter as soon as possible.

In view of your request to also upload the Environmental Impact Assessment report that was done in respect of the development, we wish to draw your attention to the fact that the project has since already been authorised by the Department of Environment, Conservation and Tourism by virtue of NWP/EIA/131/2007.
