Cumulative loss of vegetation types in Saldanha regoin, due to proposed developent is of very high concern. 4. The proposed site has been previously cultivated and very little natural vegetation remains and is thus of low concern from a botanical perspective, but should be confirmed. 5. Impacts on groundwater should be assessed as the site overlays teh Langebaan Road Aquifer System. 6. Linear activities can cumulatively contribute to loss of natural habitat in Saldanha region and routes should avoid sensitive areas. 7. First section of the power line runs through a Critical Biodiversity Area, known to contain species of Conservation Concern. Alternative routes must be identified and assessed by a specialist. 8. Impacts of power lines on Avifauna to be assessed by a qualified avifaunal specialist	AGES corresponded in an e-mail dated 16 June 2015 stating that the comments are valuable and will be of great assistance determining the scope of work for specialists. The power line alternatives are very limited as a result of the occurrence of the Langebaan Air Force Base, nearby and that is why the preferred option will be to put it alongside the existing lines.
