## NOTIFICATION OF GRANTING OF AUTHORISATION BY DEA FOR PROJECT REFERENCE 12/12/20/1569

ACED Renewables Cookhouse (Pty) Ltd submitted an application for authorisation to the National Department of Environmental Affairs for the proposed construction of a wind energy facility and associated infrastructure on a site near Cookhouse in the Eastern Cape Province (DEA Ref No. 12/12/20/1569).

As a registered interested and affected party on this project, you are duly notified that the Department has decided to grant ACED Renewables Cookhouse (Pty) Ltd authorisation for the project (in terms of 10(2) of the Environmental Impact Assessment Regulations). The environmental authorisation and conditions for authorisation, as well as reasons for the decision are attached to this letter of notification.

As an interested and affected party, your attention is drawn to Chapter 7 of the EIA Regulations which regulates appeal procedures. Should you wish to appeal any aspect of the decision by DEA, you must lodge a notice of intention with the Minister within ten (10) days of receiving notice of the decision (i.e. on or before 10 June 2010). An appeal, in terms of Regulation 63(2)(a) must be submitted on an official form published by or obtainable from the relevant department; and be accompanied by:

- i. a statement setting out the grounds of appeal;
- ii. supporting documentation which is referred to in the appeal and which is not in the possession of the Minister, MEC or delegated organ of state;
- iii. a statement by the appellant that Regulation 62(2) or (3) has been complied with together with copies of the notices referred to in that regulation; and
- iv. the prescribed appeal fee, if any.
