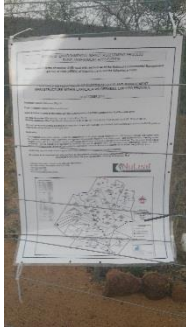

BACKGROUND INFORMATION DOCUMENT

OCTOBER 2016

In terms of the 2014 Environmental Impact Assessment (EIA) Regulations published in terms of Section 24(5) of the National Environmental Management Act 107 of 1998 (NEMA), the Project Applicant, **Lapalala Wilderness (Pty) Ltd**, hereby gives notice of its intention to apply for Environmental Authorisation from the **Limpopo Department of Economic Development, Environment and Tourism (LEDET)** as the Competent Authority, for the proposed establishment of the Custodian Sites and Management Infrastructure within Lapalala Wilderness in Limpopo Province.

The Basic Assessment process provided for in Regulation 19 read with Appendix 1 of GN R982 of 4 December 2014 of the 2010 EIA Regulations published under NEMA will be followed for the application for Environmental Authorisation.

By virtue of location, you have been identified as a potential **Interested and / or Affected Party (I&AP)** to this process, and are hereby invited to participate.

WHAT THIS DOCUMENT TELLS YOU

This Background Information Document (BID), provides you, as a potential I&AP, with **background information** on the proposed project, as well as, information regarding the Basic Assessment (BA) process to be undertaken to assess the potential impacts (i.e. positive and negative, as well as direct, indirect, and cumulative) of the proposed project.

It further indicates how you can participate in the assessment process, receive information and raise issues that may concern and / or interest you. The sharing of information forms an important component of the Public Participation Process as it not only provides I&APs with

the opportunity to become actively involved, but also provides information that may be of value for the proposed development.

PROPERTY & PROJECT DESCRIPTION

Lapalala Wilderness is located in the Lephalale local Municipality, in the Waterberg District Municipality, approximately 60 Km south east of Lephalale.

The proposed conservation initiative entails the establishment of 30 private lodges/ residences on 1500 Hectare Freehold Title Stands within the Lapalala Wilderness Area. Supporting management infrastructure inclusive of a training area, staff accommodation, breeding center, security section with accommodation, service staff houses and security control gates are also to be established. The placement of the lodges/ residences will be subject to a development envelope informed by specialist input. All associated civil infrastructure (water and waste treatment) will be included. Power will be supplied by solar power. The total development footprint will not exceed twenty (20) hectares.

Additionally, approximately 50 Km of game drive routes will be developed over the Lapalala Wilderness.

PROJECT MOTIVATION

The motivation and reasoning behind the proposed establishment of the Custodian Sites and Management Infrastructure is to secure the conservation status of the Lapalala Wilderness, ensure the sustainability and the protection of the biodiversity within Lapalala Wilderness, the ongoing community outreach projects, the support of the Lapalala Wilderness School and to secure existing jobs whilst creating new employment opportunities and the ongoing transfer of skills.

The vision of Lapalala Wilderness is protect this conservation legacy for future generations whilst creating the awareness of the interdependence between mankind and nature to deliver lasting benefits for communities, the environment and the country as a whole. In order to realize this vision, a strategic plan has been compiled whereby tourism, education, upliftment and economic opportunity all play a vital role. The establishment of the Custodian Sites forms part of this strategic plan.

Lapalala Wilderness is also currently in the beginning stages of being proclaimed as a Protected Area.

THE BASIC ASSESSMENT PROCESS

NuLeaf Planning and Environmental (Pty) Ltd has been appointed by the Lapalala Wilderness (Pty) Ltd to conduct the Basic Assessment process for the proposed development of the Custodian Sites and Management Infrastructure. - An independent **Environmental Assessment Practitioner (EAP)** must undertake the process on behalf of the applicant to ensure objectivity.
- The EAP will conduct a Public Participation Process and afford any and all persons interested and /or affected by the proposed development an opportunity to register and participate in the process. A **30 day registration period** is allowed for, as well as, an opportunity to ask questions, submit concerns etc.
- An **Application for Environmental Authorisation** will be submitted to the Competent Authority, which in this case is the Limpopo Department of Economic Development, Environment and Tourism (LEDET).
- The EAP must prepare a **Draft Basic Assessment Report (BAR)**, inclusive of specialist reports and a draft Environmental Management Programme (EMPr), which describes both the project and the environment and assesses the anticipated impact

of the project on the environment, and makes recommendations in terms of mitigation and management.

- Once complete, the Draft BAR will be circulated to all registered I&APs who are entitled to submit written comments in respect thereof. **A 30 day comment period** is allowed for.
- Once all comments from registered I&APs have been addressed, the EAP will submit the **Final BAR** to the Competent Authority (LEDET) for consideration.
- The Competent Authority is then required to make a decision on the application for Environmental Authorisation (i.e. either positive or negative).
- Once the Competent Authority has made a decision on the Final BAR, the EAP must communicate the outcome thereof to all I&APs who registered during the Public Participation Process.
- I&AP's have the right to **Appeal** against the decision of the Competent Authority should they feel the need to do so, in which case, the Competent Authority will review and reconsider the application. The appeal process is regulated in terms of the 2014 National Appeal Regulations published in terms of GN R993 on 8 December 2014 under NEMA.

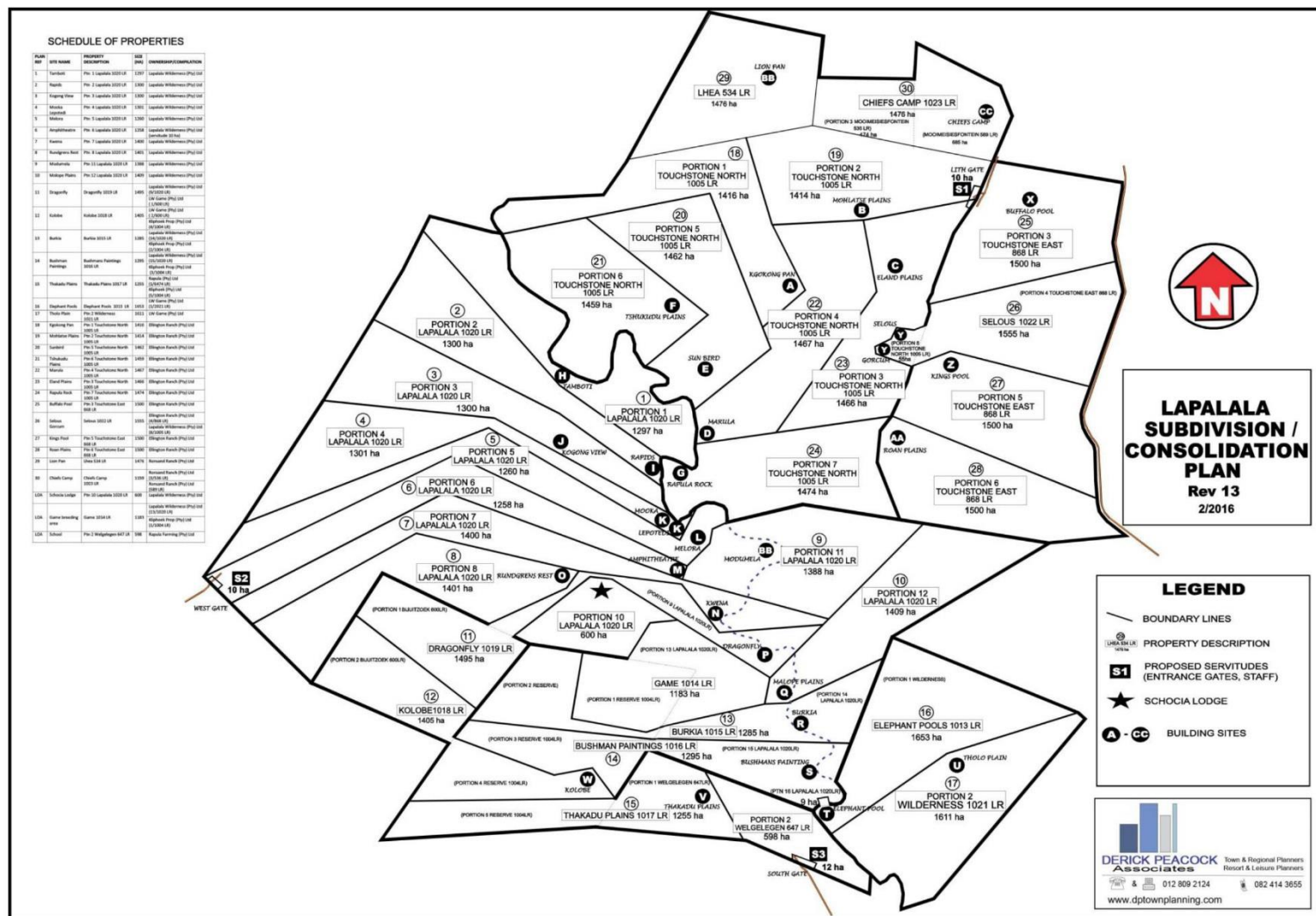


Figure 1: Proposed Custodian Sites
